Proceedings of the Mountrail County Commissioners

February 6, 2018

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Arlo Borud, Trudy Ruland, Wayne Olson, Garry Jacobson and Daniel Uran present. Also present was States Attorney Wade Enget.

Chairman Borud called the meeting to order.

Garret Volk, IT Director, stated he has been in contact with CPS if stayed with the same program software and hasn't heard back. New hardware on the new system checked with Tyler Technologies and in the middle of design and waiting on the hardware quotes. IBM is more expensive rather than the windows server.

Discussion on the backup types for the server. Currently the difference what we are doing vs. the new updated backups. The new backup would be offsite with no tape backup that is currently done in the Auditor's Office with tapes.

Comm. Borud stated all offices should be in agreement with this software program.

Comm. Ruland will be the executive sponsor for the steering committee.

Lori Hanson, Tax Director stated that the information for evaluating and selecting software from Tyler Technologies wasn't supplied. Tax Director Hanson questioned on how many years of data would be converted? With any conversion, consensus is to have CPUI be responsible for helping convert the County data and we would need to know what type of additional costs this would entail.

Tax Director Hanson has been in contact with the Burke County Tax Director. Burke County uses Software Innovations and is happy with the software.

Tax Director Hanson stated timeframe for land use layer for Ag Land Assessments will be completed for the 2019 Assessment year.

Lori Hanson, Tax Director met with the board to discuss abatements.

Tax Director Hanson stated the 2018 agricultural land value for Mountrail County is \$469.95. Currently the County is at \$421.93 which is not within the 10% tolerance level allowed by the State. Tax Director Hanson stated a minimum of a 2.5% to 3% increase on agricultural land values is needed which would bring the County within tolerance.

Moved by Comm. Ruland, seconded by Comm. Uran, to increase all agricultural land for the 2018 assessment year by 3% in order to stay in compliance with State guideline. Upon roll call, all present voted yes. Motion carried.

Laurie Johnson, Jail Administrator gave an update on the jail and brought contracts to the board for renewal. Discussion on the discharge plans with Social Services and how that is working going forward.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve signing the contract for the Food Service Contract with CBM Managed Services for February 1,2018 through January 31, 2019 year. Upon roll call, all present voted yes. Motion carried.

Jana Hennessy, Road and Bridge Engineer and Mary Trahan, Administrative Assistant met with the board to discuss road and bridge issues.

Engineer Hennessy discussed the frost law and the new permitting system. Administrative Trahan discussed the permits with the WDEA and brought the consideration of the \$1,000 frost law permit. How it works is \$1,000 per unit per county for travel within each county and would qualify for any gravel road for divisible and non-divisible loads with a weight limit of 7 ton/105,500 with no limits of how often being travelled this is only allowed during frost law. Administrative Trahan stated no check and balances so with the current contracts in place with the townships doesn't see how this would work.

Engineer Hennessy is requesting to not go forward with this since all townships contracts have already been signed. The distribution of the monies would be very difficult due to not having the information on where these trucks are traveling within the township roads.

Comm. Ruland stated it would be difficult to implement it currently since the current township contracts are in place.

Engineer Hennessy stated would discuss with all townships during meetings to see how the townships would like to go forward with the frost law permits.

Engineer Hennessy gave an update on the frost law map on weight limits.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the overweight map as presented to the Board. Upon roll call, all present voted yes. Motion carried.

Engineer Hennessy brought concerns to the board on the White Earth Bay Road on load restrictions due to the County taking over the easement of the roads. Specifically, the section of the White Earth Bay road from the fish station south and east to the White Earth Park easement. Discussion was to have the road at 6 ton max load restrictions.

Moved by Comm. Jacobson, seconded by Comm. Olson, to approve 6 ton maximum gross on the White Earth Bay Road, for the section of roadway from the fish station to the White Earth Bay Park easement. Upon roll call, all present voted yes. Motion carried.

Discussion on Knife River Township shared road has a sign of 105,500 on it which is located 90th Ave NW so Engineer Hennessy will contact to see if they will take down the sign.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the signing of the gravel release contract for the Lapica gravel pit for crushing gravel. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Olson, to approve the final pay applications for County Road 1 in the amount of \$48,139.45 and County Road 12 in the amount of \$15,892.93. Upon roll call, all present voted yes. Motion carried.

Full depth reclamation for signatures on Old Highway 2.

Moved by Comm. Ruland, seconded by Comm. Olson, to sign the construction and maintenance agreement with NDDOT for Old Highway 2. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Uran, to sign the contract and contract bond for the Minuteman Complex In slope Repair. Upon roll call, all present voted yes. Motion carried.

Discussion on three Volvo motor graders and the buyback option is being discussed due to the buying out of the Volvo dealership that was originally purchased from and who pays for the buyback of the Volvo motor graders.

Moved by Comm. Uran, seconded by Comm. Olson, to approve sending the letter to Swanston Equipment Corporation to discuss the buyback term. Upon roll call, all present voted yes. Motion carried.

Engineer Hennessy stated a letter from the Corp on Rural Water for implementation on the whole County Road 9 and not just White Earth Bay. Discussion on how to deal with this out of the park and road easements.

Engineer Hennessy requested a detailed plan on where this is implemented on WAWSA for rural water.

State's Attorney Enget stated an email was sent by Comm. Eric Jaeger from the Park Board to push this through to utilize the ROW within the Park of White Earth Bay.

Discussion on the other portions that are not the jurisdiction of the County Easements and should receive private Easements from individuals. A letter will be drafted by Engineer Hennessy for review in the next Commissioner meeting.

Discussion on Energy Impact Grant and what road to utilize it on. The deadline is April 20, 2018. County Road 9 would meet the specifications and overlays on the pavement roads. Engineer Hennessy will do two different grants with these two different options.

Update on the NDACE that was held in Fargo and Brett Pappa and Scott Duerre received scholarship no. 2 due to attending workshops held by NDLTAP.

Engineer Hennessy advised the Board of an upcoming National Study regarding gravel roads, and the possibility that Mountrail County may be able to participate in this study. Mountrail County would than benefit with additional gravel assistance on any roads selected to be included in the study. Engineer Hennessy will provide further updates as they become available.

Kent Onstad and Chris Meiers with MWEC spoke to Engineer Hennessy concerning the moving of the power poles on CR 9, 101st Ave NW but stated the County would have to pay for the relocation.

Tim Johnson, Board Member of Weather Modification gave an update on the District meeting. Also discussed on why Ward County pulled from the program, the opponents were there but not the proponents. Tim Johnson presented a letter of approval or support of Weather Modification.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve sending a letter for support for the Weather Modification to the Water Resource Board. Upon roll call, all present voted yes. Motion carried.

Traci Hysjulien, Clerk of Court presented the application for Court Facilities Improvement Grant Funds to implement eight individual display monitors in the jury box. Still waiting on the drug monies to pay the other portion that the grant isn't covering.

Moved by Comm. Olson, seconded by Comm. Jacobson, to approve going forward with funding to pay the total amount from the Clerk of Courts Budget and would be reimbursed when grants were approved. Upon roll call, all present voted yes.

Nichole Degenstein, Deputy Treasurer met to discuss implementing employer participation agreement in the NDPERS pretax service credit purchase program. Buying service credit hours for 15 years and some employees would like to utilize this program.

Moved by Comm. Ruland, seconded by Comm. Olson, to approve the employer participation agreement NDPERS pretax service credit purchase program. Upon roll call, all present voted yes. Motion carried.

Comm. Jacobson left at 12:40 p.m.

Stephanie A. Pappa, Auditor gave an update on the financial and expenditures for the 2017 budget year.

Discussion on the letter from EOG Resources of century code 38-08-05 located within 1,320 feet of occupancy of dwellings. In the future a letter will be sent due to time sensitivity for board meetings to disapprove the closeness of the dwellings to all notifications received in the future.

Comm. Uran gave an update on the Coordinated Regional Interoperability Board. Comm. Uran stated a meeting will be held on February 7, 2018 with the Derek Walker with CRIB, Sheriff's Department, E911 and Comm. Uran to discuss more and will be brought to the board at the next meeting.
