## Proceedings of the Mountrail County Commissioners

## February 20, 2018

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Arlo Borud, Trudy Ruland, Wayne Olson, Garry Jacobson and Daniel Uran present. Also present was States Attorney Wade Enget.

Chairman Borud called the meeting to order.

Moved by Comm. Jacobson, seconded by Comm. Olson, to review and approve the agenda as is. Upon roll call, all present voted yes. Motion carried.

Discussion on recording of the future minutes. It was discussed to leave the way it is.

Discussion on a correction in the Minutes of January 16, 2018 meeting brought forward by Lori Hanson, Tax Director. The Commission decided to leave minutes as approved.

Moved by Comm. Olson, seconded by Comm. Ruland, to approve the Minutes of February 6, 2018 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Olson, to approve the Special Minutes of February 16, 2018 as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Jacobson, to approve the bills totaling \$352,696.15. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a regular basis on the Mountrail County Website @ www.co.mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the January 2018 fees for the Clerk of Court Office. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the transfer for the 2018 budget fund as per the Board action totaling \$100,000 from the General Fund to the Emergency Fund. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to table to the call of the chair the Road Crossing Permit 606 from River Water, LLC on 96<sup>th</sup> Ave NW located in Sections 7 and 12 in Township 154 North, Range 93 West (Rat Lake Township) and Township 154 North, Range 94 West (Unorganized Township) to bore for water. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to table to the call of the chair the Road Crossing Permit 607 from River Water, LLC on 102<sup>nd</sup> Ave NW located in Sections 31 and 36 in Township 154 North, Range 95 West (Unorganized Township) and Township 155 North, Range 94 West (Unorganized Township) to bore for water. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to table to the call of the chair the Road Crossing Permit 608 from River Water, LLC on 102<sup>nd</sup> Ave NW located in Sections 31 and 36 in Township 154 North, Range 95 West (Unorganized Township) and Township 155 North, Range 94 West (Unorganized Township) to bore for water. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the signing of the Task Order 3 from HDR Engineering Inc. to plat the First Lutheran Parcel on CR 9 in Section 5, Township 155 North, Range 94 West (Unorganized Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the Sidwell GIS Maintenance Services Contract. Upon roll call, all present voted yes. Motion carried.

Discussion on conducting a 6 month evaluation for Nathan Sem with Planning and Zoning Administrator. Comm. Borud stated he would be willing to sit with Don Longmuir, the Emergency Board, and Planning and Zoning Board to do an evaluation.

Lori Hanson, Tax Director met with the board to discuss abatements along with Rory Porth, Tax Director Assistant.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve abatement on the 2018 mobile home taxes on parcel number 38-9000100 due to mobile home being destroyed. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Olson, to approve the abatement on the 2017 mobile home taxes on parcel number 18-9002500 due to mobile home being damaged and unlivable. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the abatement of parcel number 61-0089951 due to qualifying for 50% of Disabled Veterans Credit for the 2017 tax year. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the abatement on parcel number 61-0025200 due to qualifying for 40% of Homestead Credit for the 2017 tax year. Upon roll call, all present voted yes. Motion carried.

Rory Porth, Property Assessor gave an update on the soil type implementation. The Sidwell Drawings are ahead of schedule was supposed to delivered in August and should be delivered by end of February. Assessor Porth stated ArcMap Publisher is needed and beneficial in order for people to access in the County. Assessor Porth gave a comparison from the breakpoint method vs. actual land use.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the purchase of the ArcMap Publisher in the amount of \$2,000 to come out of the Tax Director's budget. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 10:00 A.M. public hearing to discuss the proposed zoning ordinance changes. Nobody from the public appeared.

Wade Enget, State's Attorney was present for the hearing pertaining to the proposed zoning ordinance change.

Discussion was to add the following changes to the Article V Definitions of Terms Used in this Ordinance Sec I Definitions: For the purpose of this ordinance, the following list of definitions is adopted.

34. <u>Utilities</u>: For the purposes of this ordinance, the definition of utilities shall be limited to electrical transmission lines, oil pipelines, <del>and</del> natural gas pipelines <u>and industrial water pipelines</u>. This definition shall exclude electrical distribution lines as a utility.

Moved by Comm. Olson, seconded by Comm. Uran, to approve the addition of the proposed zoning ordinance changes under Utilities. Upon roll call, all present voted yes. Motion carried.

Jenny Gaaskjolen, Branch Manager at BNC along with Shena Wold, Treasurer met with the Board to discuss requests for Financial Proposal regarding County Funds.

Manager Gaaskjolen discussed submitting a request for Financial Proposals regarding County Funds. Manager Gaaskjolen stated currently have great rates with BNC and would like to do business with the County in the future. Treasurer Wold stated banks usually inquire in the Treasurer's Office for CD's rates etc.

Treasurer Wold discussed the renewal of The Village Business Institute contract.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the renewal contract with The Village Business Institute Contract. Upon roll call, all present voted yes. Motion carried.

Comm. Olson discussed with Nathan Sem, Planning and Zoning Administrator concerning the bill listing if Berthold Ambulance and Stanley Ambulance should be paid out of the County Hazardous Chemical Account. Comm. Olson stated doesn't remember approving these two bills in the recent Emergency Board meeting.

Moved by Comm. Olson, seconded by Comm. Ruland, to hold back paying both Berthold Ambulance and Stanley Ambulance from the bill listing until further research is done by Administrator Nathan Sem. Upon roll call, all present voted yes. Motion carried.

Wade Enget, State's Attorney and Zach Gaaskjolen, Brosz Engineering was present concerning the flood at the South Complex. The counter-offer from Dan Brosz with Brosz Engineering is a settlement of \$60,000. The total cost of the flood was \$204,802.22.

Zach Gaaskjolen, Brosz Engineering stated would like to get passed this situation and was a subcontractor's responsibility that is no longer in the area.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the offer of \$60,000 from Brosz Engineering as the settlement. Upon roll call, all present voted yes. Motion carried.

Wade Enget, State's Attorney gave an update on the Ceres Environmental Services Arbitration.

Discussion on Human Resource position with Comm. Ruland stating more research will be conducted when she attends the Washington DC tour which is March 19th thru the 24th.

Jana Hennessy, Road and Bridge Engineer met with the board to discuss road and bridge issues. Also present was Mark Von Wald with AE2S representing WAWSA, Jason Slater with WAWSA, and Dan Vader Vorste with HDR Engineering.

Engineer Hennessy along with Mark Von Wald with AE2S discussed the WAWSA crossing permits on 101st Ave NW, CR9 and White Earth Bay. Engineer Hennessy stated that 101st Ave NW, CR9 is under design with HDR Engineering. Engineer Hennessy wanted plans on this project from WAWSA and coordinate with HDR Engineering.

Mark Von Wald stated the rural water will be outside of the ROW otherwise it will be placed on private property. The guideline WAWSA follows is to install at 75' away from all roads. The water pipelines are down far enough to not have to worry about.

Currently there are 10 crossing permits from WAWSA waiting for approval. A letter from Engineer Hennessy was approved by State's Attorney Enget.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the road crossing permits #522-523, #532, #535-536, #538, #542-544, and #547 from WAWSA. Upon roll call, all present voted yes. Motion carried.

Discussion was held concerning the roads within the White Earth Bay. Engineer Hennessy discussed a discrepancy from the Corp documentation and the documentation received from the Road and Bridge.

Mark Von Wald did speak with the Corp of Engineers also. Discussion was held on being in the ROW within the Park. Lot Holders will be right inside of the ROW. Within the park roads the Corp is responsible for those roads and the crossing will be permitted by the Corp. The Corp still maintains the land underneath the road even though the easement is with the County.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the crossing permits #551, #563-570, #572-574 and #582 from WAWSA within the White Earth Bay park roads subject to the Corp approval and paperwork being completed. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the signing of the NDDOT Safety Inspection of Concrete Box Culverts for every four year cycle. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve for the advertisement of bids on County Routes 1 & 2 from the Tagus to Ward County Line. Upon roll call, all present voted yes. Motion carried.

Discussion on CR 9 Wetland Mitigation Options. Option 1 is to purchase 1 acre of credit from Ducks Unlimited for a total cost of \$52,155; Option 2 is to purchase an easement for on-site compensatory mitigation that is \$47,303 but would need to monitor for 5 years. Engineer Hennessy would prefer Option 1 due to the high cost of monitoring for five years in Option 2.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve Option 1 to purchase 1 acre from Ducks Unlimited. Upon roll call, all present voted yes. Motion carried.

Discussion on a road worker and a performance plan was implemented to help improve performance of the road worker.

Comm. Uran along with Derrick Walker, Public Safety Programs Manager with ITD, Corey Bristol, Deputy Sheriff and Nathan Sem, Disaster Emergency gave an update on the study of the Coordinated Regional Interoperability Board of the ND Statewide Interoperable Radio Network. The goal is to improve current radio coverage throughout ND and create full interoperability both within the state and our bordering states and territories. The problem is aging equipment and over 800 transmitters in ND. The contribution to implement this program is 80% state vs 20% local funding. Governance Authority is SIEC, SIRN Subcommittee and then CRIBS.

Most of the funding is from HB 1178 with expected revenue of approximately 28 million.

Deputy Bristol stated the Sheriff's office is concerned about all the unknowns and would like to postpone the signing of the contract. The cost of the program is unknown. Willing to get a letter of intent to participate in the program.

Nathan Sem, Disaster Emergency also agrees with the Sheriff's office to many unknowns to move forward with signing the contract.

Derrick Walker stated two different options is a transfer agreement of turning over the frequency or a share agreement that the County would still own the frequency.

Memorandum of Understanding is the agreement to sign and at a later date the County would need to decide whether to do transfer or the share agreement.

Deputy Bristol is stating the cost is a big factor and the County is more than willing to participate.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the Memorandum of Understanding of CRIBS. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Jacobson, to approve Nathan Sem as an alternate on the CRIBS board. Upon roll call, all present voted yes. Motion carried.
