Proceedings of the Mountrail County Commissioners

April 21, 2015

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Arlo Borud, Garry Jacobson, Colleen Reese, and Trudy Ruland. Commissioner Greg Boschee was absent. Also present were Dave Leftwich with NDDOT and Jon R. Cameron with John Hoeven's U.S Senator's Office.

Chairman Borud called the meeting to order.

Corey Bristol, Sheriff's Deputy, spoke to the Board regarding using towing companies outside of Mountrail County. He stated in an emergency situation it is necessary to call other towing services. He also stated the local towing services will be called first.

Moved by Comm. Reese, seconded by Comm. Jacobson, to amend the motion made on February 17, 2015, to allow the Sheriff's Department to use discretion when calling a towing company. Upon roll call, all present voted yes. Motion carried.

Wade Enget, States Attorney, met with the Board to discuss the property known as the Government Lot 4 and the SE¼ of the SW¼ of Section 31, in Township 153 North, Range 89 West. Attorney Enget stated that all of the property owners have not been located to enter into negotiations to reach an agreement for right of way and to allow for construction of 74th Ave NW. Attorney Enget informed the Board to appoint a special board to start the condemnation process. The special board meeting was set for May 12, 2015 at 9:00 A.M.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the adoption of the resolution for 74th Ave NW. Upon roll call, all present voted yes motion carried.

Moved by Comm. Ruland, seconded by Comm. Reese, to approve payment pursuant to the special board recommendations consisting of Traci Hysjulien, Stephanie A. Pappa and Arlo Borud. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Reese, to approve the Minutes of April 7, 2015 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the payment of bills totaling \$727,099.41. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a regular basis on the Mountrail County Website @ www.co. mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the March 2015 fees for the Clerk of Court. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve Permit #229 authorizing Sacagawea Pipeline, LLC., to cross county/section line referred to as 92nd Ave NW of Section 10 and 11 in Township 151 North, Range 93 West (Big Bend Twp); 36th St NW of Section 2 and 35 in Township 151 & 152 North, Range 93 West (Big Bend Twp & Unorganized Twp); section line of Sections 35 & 36 in Township 152 North, Range 93 West (Unorganized Twp); 37th St NW of Section 25 & 36 in Township 152 North, Range 93 West (Unorganized Twp); 90th Ave NW of Sections 25 & 30 in Township 152 North, Range 92 West (Osborn Twp); 89th Ave of Section 29 & 30 in Township 152 North, Range 92 West (Osborn Twp); 88th Ave NW of Section 28 & 29 in Township 152 North, Range 92 West (Osborn Twp). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Reese, to approve Permit #230 authorizing the City of Stanley, to cross county/ section line referred to as Stanley Truck Bypass of Section 21 in Township 156 North, Range 91 West (Idaho Twp). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the salary increase deputy position for Ryder Uran in the Sheriff's Department totaling \$4,417.00 per month effective April 1, 2015. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the Regular Full-Time Dispatcher Agreement for Bailey Johnson in the Sheriff's Department in the amount of \$40,800.00 per year. Upon roll call, all present voted yes. Motion carried.

Don Longmuir, Planning and Zoning Administrator, and Lisa Lee, Assistant Planning and Zoning Administrator, was present for the hearing pertaining to the zoning amendments. Also present was Dan Lindberg.

Chairman Borud opened the 9:30 A.M. public hearing to receive comments on the zoning amendment request filed by Brian Iverson of Wild Pines LLC., with concurrence from landowner Daniel Lindberg, to rezone a 39.91 acre more or less tract of land in Idaho Township from rural recreational to residential for the purpose of residential development.

Administrator Longmuir presented information from the March 23, 2015 Planning & Zoning public hearing of the Planning & Zoning Commission. The Planning & Zoning Commission recommended approval of the zoning amendment filed by Wild Pines LLC.

Moved by Comm. Jacobson, seconded by Comm. Reese, to approve the request of Wild Pines, LLC., with concurrence from landowner Daniel Lindberg, for an amendment to the Mountrail County Zoning Ordinance to rezone a 39.91 acre more or less tract of land described as Outlot 1 of the NE¼ of Section 24, Township 156 North, Range 91 West (Idaho Township) from rural recreational to residential for the purpose of residential development in accordance with regulations set forth in Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their March 23, 2015 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 9:40 A.M. public hearing to receive comments on the zoning amendment request filled by Philip Newman, with concurrence from landowner Roy Jensen, to rezone a 9.29 acre more or less tract of land in Oakland Township from agricultural to industrial for the purpose of establishing a trucking business.

Administrator Longmuir presented information from the March 23, 2015 Planning & Zoning public hearing of the Planning & Zoning Commission. The Planning & Zoning Commission recommended approval of the zoning amendment filed by Philip Newman.

Craig Wienbar was present to object to the request. Craig Wienbar was concerned about the traffic and dust that would be created. Phillip Newman stated operating only 2 trucks and had no more than 4 trucks planned in the future. Phillip Newman also stated that there was a trailer house on the property that would be used as a rental property. Administrator Longmuir stated that it could only be used as employee housing or an office and must have a conditional use permit to be compliant.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the request of Phillip Newman, with concurrence from landowner Roy Jensen, with the stipulation that there would be a limit of 4 trucks and truck traffic would go south to 51st St, for an amendment to the Mountrail County Zoning Ordinance to rezone a 9.29 acre more or less tract of land described as the S½S½ of Government Lot 2, Section 7, Township 154 North, Range 89 West (Oakland Township) from agricultural to industrial for the purpose of establishing a trucking business in accordance with regulations set forth in Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their March 23, 2015 meeting. Upon roll call, all present voted yes. Motion carried.

Present for the public hearing was Jason Lalicker and Taryn Crews with WPX Energy Williston.

Chairman Borud opened the 10:00 A.M. public hearing to receive comments on the section line closing request filed by Jason Lalicker of WPX Energy Williston to close 1/5 of a mile of section line lying between Section 14 and Section 23, Township 150 North, Range 93 West (Unorganized Twp) described as NE¼NW¼, NW¼NE¼, of Section 23, and the SW¼SE¼, SE¼SW¼, of Section 14.

Robert Hamers wrote a letter objecting to the section line closing.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to deny the request to closing a section line. Upon roll call, all present voted yes. Motion carried.

Lori Hanson, Tax Director met with the Board to discuss Tax Abatements.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the Abatement application for property number #50-000300 to remove a non-existent building placed on property values. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the Abatement application for property number #06-9000300 to refund mobile home taxes to qualify as a farm home. Upon roll call, all present voted yes. Motion carried.

Shena Wold, Treasurer, met with the Board to discuss the accounts with Lakeside State Bank and Peoples Bank & Trust. The 2 banks have merged under the name Cornerstone Bank.

Moved by Comm. Ruland, seconded by Comm. Reese, to combine the 2 accounts under the name Cornerstone Bank. Upon roll call, all present voted yes. Motion carried.

Treasurer Wold, presented the Board with 2 options for receiving credit card payments. The options are MuniciPAY and Heartland.

Moved by Comm. Jacobson, seconded by Comm. Reese, to accept the proposal from Heartland for electronic payment processing for all County offices. Upon roll call, all present voted yes. Motion carried.

Jana Heberlie, Road Engineer, Scott Duerre, Engineering Tech, Mary Trahan, Monte Dyke and Eddie Patterson, Road Superintendents met with the Board to discuss Road & Bridge issues.

Engineer Heberlie opened the 11:00 A.M. bids for 2 new 2015 145 HP Front Wheel Assist tractors. Present for the bids were Scott Rudolph and Ryan Gjellstad with Border Plains, Jed Bohmbach with Gooseneck Implement, and Matt Miller with Butler Machinery.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the purchase of a Case IH Puma 150 FPS from Border Plains totaling \$104,977 and a John Deer 6150 M from Gooseneck Implement totaling \$97,300.. Upon roll call, all present voted yes. Motion carried.

Joan Hollekim was present to update the Board about the Road & Bridge Budget. Joan Hollekim explained that based on the budget 53rd and 74th are the only road projects being done in 2015.

Moved by Comm. Reese, seconded by Comm. Jacobson, to freeze all township assistance, except for the 25% of overweight permits fees. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to accept the lowest bid from Border States Paving, Inc. for CR 3, 74th Ave NW construction project. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie informed the Board that the Road & Bridge Department will be applying Magnesium Chloride on CR 1, Coulee Rd and CR 3, 74th Ave NW. Calcium Chloride will be applied to the rest of the County gravel roads as a comparison.

Engineer Heberlie informed the Board that it was suggested that CR 7, 93rd Ave NW speed be reduced to 35 mph. Currently it is 55 mph until the rail road crossing and it changes to 25 mph.

Moved by Comm. Reese, seconded by Comm. Jacobson, to reduce the speed limit on CR 7, 93rd Ave NW to 35 mph for the first mile. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie told the Board Tim Johnson from the Stanley Airport has asked for help with crack sealing and has asked if the Road & Bridge Department could help seal 10 cracks on the airport road.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the Road & Bridge Department help crack seal the Stanley Airport road. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the salary increase for Jessica Johnson totaling \$4,269.00 effective May 1, 2015. Upon roll call, all present voted yes. Motion carried.

Stephanie Pappa, Auditor updated the Board on the budget due to the decrease in oil revenue. Discussion was held on all the options available to fund the new law enforcement facility. The one option that is being considered is a Gross Production Tax loan with the Bank of North Dakota.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the pouring of the driveway slabs for the Duplex Units at the cost of \$1,800 per driveway. Upon roll call, all present voted yes. Motion carried.

Chairman Borud stated that Wade Enget has been assigned as the attorney for the Plains Marketing case.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the Ross Church to waive the fees for use of the community hall. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by comm. Jacobson, to approve the advertisement for 3 weight and measurement officers. Upon roll call, all present voted yes. Motion carried.
