#### Staff Concerns

- Nate Sem, Planning & Zoning Administrator reported that River Water LLC
  has decided to wait until the fall before re-applying for a conditional use permit
  to put in their industrial water line.
- Dakota Gold Transfer-Plaza LLC Conditional Use Permit Violation. Jana Hennessy, Mountrail County Road & Bridge Engineer reported that Dakota Gold Transfer- Plaza LLC has violated the terms of their conditional use permit by not paying for the road improvements as agreed on both their permit and by a letter they wrote December 3, 2014. Mountrail County Road & Bridge Engineer Hennessy stated she spoke with them via the phone during the May 3, 2016 County Commissioners meeting. At that time, Mr. Moe stated they could not pay the original amount and verbally committed to a lesser amount of \$150,000.00. August 1, 2016 Mountrail County Road & Bridge wrote to Mr. Moe asking for payment or explanation regarding their failure to pay what was agreed upon. To date, Mr. Moe has not responded.

**Motion**: Moved by Commissioner Borud, seconded by Vice Chairman Weisenberger to revoke Dakota Gold Transfer-Plaza LLC, with concurrence from Robert A & Susan K Erickson, landowners, conditional use permit to use land zoned industrial for oil storage on a 154.77 acre, more or less, tract of land, described as the SW¼ less Outlot 1, Section 2, Township 152 North, Range 88 West (**Plaza Township**) due to violating the listed conditions of the conditional use permit and to issue Dakota Gold Transfer-Plaza LLC a Cease & Desist. Upon roll call vote, all present voted yes. Motion carried.

- Brendle's Bay Update Nate Sem, Planning & Zoning Administrator reported that Jeff Meyers visited with him regarding the campers that are still in Brendle's Bay with no signs of those landowners starting to build. Mr. Meyers was concerned about those landowners getting their building permits extended. Wade Enget, Mountrail County States Attorney stated those building permits will not be extended and requested a list of those building permits given to the Planning & Zoning Board.
- Gary Satterthwaite has sent an email letting Planning & Zoning know that Knife River – North Central has removed their stockpiles of gravel and any gravel left there belongs to him. Knife River – North Central followed up with a request for a pit release and to release their letter of credit on that pit.

**Motion**: Moved by Commissioner Borud, seconded by Vice Chairman Weisenberger to approve the pit release and the letter of credit release for Knife River – North Central, with concurrence from Gary & Caroline Satterthwaite, landowners, on the conditional use permit to use land zoned agricultural for mining sand & gravel, on a 80 acre, more or less, tract of land described as the S½NE¼ of Section 7, Township 153 North, Range 92 West (**Knife River Township**). Pit has been reclaimed and Planning & Zoning has a release form signed by the landowners. Upon roll call vote, all present voted yes. Motion carried.

• Nate Sem, Planning & Zoning Administrator opened the discussion on the temporary use permit. Each Board Member had received a copy. A discussion was held on the pump placement and the hose placement. The checklist for hose placement was displayed. Jana Hennessy, Mountrail County Road & Bridge Engineer stated that Road & Bridge has a Temporary ROW Use Permit so would an applicant have to do both? Chairman Sorenson stated possibly. Chairman Sorenson reminded that Mountrail County's easements take precedence. It was decided the hose placement checklist would be handled administratively with no fee. Wade Enget, Mountrail County States Attorney stated he would create the ordinance for the TUP and the checklists.

Commissioner Hollekim requested to see the final TUP and checklists next meeting.

#### **Board Concerns**

Chairman Sorenson asked about the rig mats located by Palermo. Wade Enget, Mountrail County States Attorney stated his office is working on the affidavit.
