Discussion on the County Agent stipend pay was put on the agenda for the July 5th meeting due to requiring research that needs to be done.

Moved by Comm. Uran, seconded by Comm. Jacobson, to re-advertise for the Planning & Zoning/DES job opening with a preference for a Land Use Planner with a deadline of July 13, 2017. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve the appointment of Daniel Uran and Cindy Edwards to the Social Services Board for a 3 year term ending July 1, 2020. Upon roll call, all present voted yes. Motion carried.

The Board agreed to deny the request to close the County offices on July 3, 2017.

Traci Hysjulien, Clerk of Court, gave the Board a monthly statistics update. Clerk of Court Hysjulien stated the total number of cases is down by 22% from 2016. The civil cases are up 22%, criminal cases are down 26%, family cases are down 10%, and probate cases are up by 8%.

Clerk of Court Hysjulien stated a judge cancelled a civil jury trial for July 13 and 14 due to the Clerk of Courts Office being short staffed.

States Attorney Enget stated the County received confiscated drug money and plans to use the money to purchase 2 televisions to display the court calendar and a copy machine.

Lisa Lee, Planning & Zoning Administrator, was present for the hearings pertaining to the zoning amendments.

Chairman Borud opened the 9:50 A. M. public hearing to receive comments on the zoning amendment request filled by ONEOK Rockies Midstream with concurrence from Gladys Pennington, landowner, to rezone a

6.61 acre more or less tract of land in Unorganized Township from agricultural to industrial for the purpose of expanding and developing a compressor station site .

Present for the hearing was Alyssa Ruffie and Dick Vande Bossche from ONEOK.

Administrator Lee presented information from the June 20, 2017 Planning & Zoning public hearing of the Planning & Zoning Commission. The Planning & Zoning Commission recommended approval of the zoning amendment filed by ONEOK Rockies Midstream with concurrence from Gladys Pennington, landowner.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve the request by ONEOK Rockies Midstream with concurrence from Gladys Pennington, landowner, for an amendment to the Mountrail County Zoning Ordinance to rezone a 6.61 acre more or less tract of land described as Outlot 2 located in Gov't Lot 1 of Section 4, Township 150 North, Range 93 West (Unorganized Township) from agricultural to industrial for the purpose of expanding and developing a compressor station site in accordance with regulations set forth in Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their June 20, 2017 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 9:55 A. M. public hearing to receive comments on the zoning amendment request filed by Bridger Terminals, LLC with concurrence from Marshall and Jane Craft, landowner, to rezone a 10.02 acre more or less tract of land in Ross Township from agricultural to industrial for the purpose of constructing, owning, and operating a crude oil receipt, storage and pipeline injection terminal.

Administrator Lee presented information from the June 20, 2017 Planning & Zoning public hearing of the Planning & Zoning Commission. The Planning & Zoning Commission recommended approval of the zoning amendment filed by Bridger Terminals, LLC with concurrence from Marshall and Jane Craft, landowner contingent upon Bridger Terminals LLC paving 85th St NW to the end of Bridger Terminals LLC south property line, placing a sign at the south end of the property stating no Bridger Terminal LLC traffic can go beyond, building a west bound acceleration lane on HWY 2 as well as a road maintenance agreement for the life of the facility with a signed agreement with Ross Township.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to table until call of the chair the request by Bridger Terminals, LLC with concurrence from Marshall and Jane Craft, landowner, for an amendment to the Mountrail County Zoning Ordinance to rezone a 10.02 acre more or less tract of land described as Outlot 3 located in the E½E½NE¾ of Section 26, Township 156 North, Range 92 West (Ross Township) from agricultural to industrial for the purpose of constructing, owning, and operating a crude oil receipt, storage and pipeline injection terminal in accordance with regulations set forth in Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their June 20, 2017 meeting. Upon roll call, all present voted yes. Motion carried.

Grant Wentz and Jason Bentley with Bremer Bank met with the Board to discuss a loan proposal to refinance the BND jail facility loan.

The Board reviewed the loan proposal from First International Bank & Trust.

Allan Minnerath from Central Specialties and Rob Rebel with Knife River Corporation met with the Board to request to haul full loads of gravel on 46th St NW and 90th St NW for the NDDOT Highway 1804 road project. The Board denied the request as recommended by the Road & Bridge Department at the June 6, 2017 meeting. The road is currently restricted to 6 ton per axle/80,000 lbs. as stated by the North Dakota Century Code and gravel is a divisible load. Allan Minnerath offered to supply a bond and to do a pre and post inspection of the road. Engineer Heberlie presented an email from Jerry Uran, which stated Knife River Township raised the weight limit to 105,500 to decrease the number of trucks on the road.

Moved by Comm. Uran, seconded by Comm. Jacobson, to allow a \$400,000 letter of credit, complete a pre and post inspection of 46^{th} St NW and 90^{th} St NW, apply dust control, post 105,500 by legal weight limit signs and 35 mph max speed limit signs. Upon roll call, all present voted yes. Motion carried.

Jana Heberlie, Road & Bridge Engineer, met with the Board to discuss issues with the Road and Bridge Department along with Mary Trahan, Administrative Assistant and Scott Duerre, Engineering Tech.

Engineer Heberlie presented the bids from the June 6, 2017 bid opening for three 2017 six wheel drive motor grader. Engineer Heberlie stated the bid from Butler Machinery did not meet the bid specifications and did not include a guarantee buy back.

Moved by Comm. Uran, seconded by Comm. Jacobson, to awards the three 2017 six wheel drive motor grader to RDO Equipment at a total price of \$573,700 after the buy backs. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie informed the Board that the pavement to the Van Hook approach and CR 15 were damaged. Slawson Exploration Company entered into an agreement to improve the approach on CR 15. The Commissioners approved the Road Crossing Agreement on May 2, 2017. Engineer Heberlie stated Slawson has

violated several items from the agreement. The pre inspection was not completed, Slawson did not notify the County of the damages, hauling across CR 15, and the road was damaged. Present from Slawson Exploration Company was Eric Sundberg. Eric Sundberg stated unloaded trucks were utilizing the approach. Engineer Heberlie recommended terminating the road contract until the road is fixed. The Board agreed to reinstate the agreement once repairs to the road were made and the repairs to be completed by the end of July.

Engineer Heberlie stated the Riverview Homeowners Association submitted a Township Road Maintenance Agreement and Gerald Aftem of Aftem Development opposes the agreement. States Attorney Enget stated Riverview Homeowners Association is be sued by Aftem Development and suggested that the Board not act until the dispute is settled. States Attorney Enget further explained that previous Commissioner Minutes stated the County did not have jurisdiction over this road and would not be taking it over.

Engineer Heberlie informed the Board that the Bohmbach family and Brian & Paula Horob had requested that the County take over an access road located on 39th St NW in Section 24, Township 152 North, Range 93 West (Unorganized Township) and make it a township road. There is currently a road easement from the Corps until October 22, 2022 and the Bohmbach family is unable to sell the property because of this sunset clause. The Corps will grant the County an easement if the road becomes a public road.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve taking over the private access road with a maintenance agreement. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the agreement with HDR Engineering, Inc. for wetland monitoring on CR 3 and CR 12 and to not exceed \$16,192.00. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie stated Hess Corporation has requested permission to install a temporary monitoring well within county ROW to collect groundwater samples on 74th St NW.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve Hess Corporation to install a temporary monitoring well within county ROW to collect groundwater samples on 74th St NW and to authorize all future Temporary ROW Permits to be approved by the County Engineer. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve all Township Permitting Agreements. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve Jason Spaeth's request to take time off without pay during the week of July 10-14, 2017. Upon roll call, all present voted yes. Motion carried.

Discussion was held on purchasing a dust control truck. The Board suggested the Road & Bridge Department look into a used truck.

Discussion was held on a letter received from an employee about complaints concerning Sheriff, Kenneth Halvorson.

Laurie Johnson, Jail Administrator, met with the Board to give an update on the Jail Facility.

Lori Hanson, Tax Director, and Rory Porth met with the Board to discuss issues from the Property Assessment Office.

Tax Director Hanson state Assessor Porth had 1 hour of overtime in the month of May.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve 1 hour of overtime for Rory Porth for May 2017. Upon roll call, all present voted yes. Motion carried.

Assessor Porth gave an update on the implementation of soils process.

The County Board of Equalization reconvened at 2:00 P.M. Present was Susan Spaeth from the City of Stanley.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to open the Tax Equalization Meeting. Upon roll call, all present voted yes. Motion carried.

Tax Director Hanson stated the notice of increase that had not been sent to the Stanley Community Schools was sent and the State Tax Department had verified that the property was not exempt.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the true and full value on Parcel# 61-0093959 at \$353,900. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the 2% increase of ag land valuations to be in compliance. Upon roll call, all present voted yes. Motion carried.

Tax Director Hanson stated the motion to increase residential valuation needs to be amended.

Moved by Comm. Uran, seconded by Comm. Ruland, to reconsider the motion made on June 6, 2017 to approve the reduction in residential valuations by 9% for all areas except the City of Stanley. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the reduction in residential valuations by 9% on structures only less the City of Stanley. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the amended Abstract of Assessments, the Supplementary Abstract, the Abstract of Valuation of Certain Exempt Real Property, the State Game & Fish Abstract, and the Board of University of Schools Lands Abstract for the 2017 year. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to close the County Board of Equalization at 2:07 P.M. Upon roll call, all present voted yes. Motion carried.

Karen Babbitt, head Custodian, met with the Board to discuss sign issues at the Courthouse.

Gerry Nelson-Henin met with the Board to discuss Parcel #61-0063800. The land was taken for tax deed action in 1961. Gerry. Nelson-Henin requested the land be platted and transferred to the Nelson family. States Attorney Enget stated further research would be needed and will be discussed again at the July 5, 2017 meeting.
