Proceedings of the Mountrail County Commissioners

July 5, 2017

The Board met in regular session on Wednesday at 9:00 A.M. with Commissioners Arlo Borud, Trudy Ruland, Garry Jacobson, and Daniel Uran present. Also present was States Attorney Wade Enget, John C. Anderson, Jeff Meyer, Greg Johnson, Ty Mitchell, Carmen Haugen, Darla Miller, Heath Hetzel and Bonnie Nichols with American Bank Center.

Chairman Borud called the meeting to order.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to review and approve the agenda as is. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the Minutes of June 20, 2017 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve the bills totaling \$180,880.71 and June payroll, checks #10353-10367 and direct deposit #6326-6485 totaling \$851,803.88. Upon roll call, all present voted yes. Motion carried. Discussion was held on the resignation letter of Gary Johnson as the Commissioner for District 1. The letter was received and is effective upon the filing date of June 23, 2017. The Commissioners will make a decision at the July 18th meeting on the four interested candidates. Chairman Borud will request a letter of interest from each candidate.

The quote from Tyler Technologies was reviewed.

Discussion was held on the Raffle Application made by the Belden Trail Riders Association from July 8, 2017 to July 9, 2017. The event was postponed and States Attorney Enget stated a new application would need to be submitted.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve the appointment of Daniel Uran to the Audit Committee a standing committee of the North Dakota County Commissioners Association. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the overtime request for Heather Tomlinson for the week of Achievement Days from July 10-14, 2017. Upon roll call, all present voted yes. Motion carried.

Discussion was held on the stipend pay for the Extension Agent position. The Board agreed the current salary was comparable and with the current budget concerns the Board will not continue with the stipend pay.

Moved by Comm. Uran, seconded by Comm. Ruland, to deny the request made by NDSU to pay the Extension Agent the stipend salary. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to deny the request made by Gerry Nelson-Henin to plat and transfer Parcel #61-0063800 to the Nelson family. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the request made by Shena Wold, Treasurer, to purchase 2 computers and 3 shelving units. Upon roll call, all present voted yes. Motion carried.

Jeff Meyer, a resident of Brendle's Subdivison, met with the Board to discuss campers on residential lots. Jeff Meyer stated the building permits are being abused and feels people are not intending to build.

Lisa Lee, Planning & Zoning Administrator, stated the Planning & Zoning Board has discussed this issue and cease and desist orders have been issued.

Jeff Meyer questioned how many campers are allowed on a single family lot. States Attorney Enget stated one camper is allowed on the lot during the building process.

States Attorney Enget stated this matter will be handled through the Planning & Zoning Department and will be added to the July 24, 2017 agenda.

Carmen Haugen, a resident of Brendle's Subdivison, has 2 campers and a building permit. Carmen Haugen stated people are in the process of getting financing and one year is not enough time.

Administrator Lee discussed the proposed changes to the zoning ordinances to accommodate the newly passed medical marijuana bill. The proposed requirements will include a \$50,000 letter of credit, unobstructed windows, and chain link fences.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the publication for proposed changes to the zoning ordinances to accommodate the newly passed medical marijuana bill. Upon roll call, all present voted yes. Motion carried.

Discussion was held on County vehicle compensation.

Ty Mitchell, Aviation Director of the Stanley Airport, met with the Board to discuss the levy disbursements. Ty Mitchell stated the Stanley Airport has the most activity, is located in the county seat, is FFA compliant, and is the only airport capable of taking large aircrafts and jets. Ty Mitchell requested the disbursements be based on activity. Stephanie Pappa, Auditor, stated the resolution does not end until December 31, 2018 and a decision could not be made until then. The Board requested to meet with all of the county airports before making a decision.

Chairman Borud opened the bids for oil and gas lease on land described approximately .11 acres of land in Lot 9 of Block 27, Original Townsite of Van Hook in Section 32, Township 152 North, Range 91 West (Van Hook Township).

Moved by Comm. Ruland, seconded by Comm. Jacobson, to accept the bid from Herco Oil & Gas Exploration, LLC. for \$3000.00 an acre which amounts to \$330.00 for the .11 acres. Upon roll call, all present voted yes. Motion carried.

Heath Hetzel and Bonnie Nichols from American Bank Center met with the Board to discuss a loan proposal to refinance the BND jail facility loan.

Mary Trahan, Administrative Assistant and Scott Duerre, Engineering Tech met with the Board to discuss issues with the Road and Bridge Department.

Administrative Assistant Trahan stated Jason Strand from Advanced Engineering and Environmental Services, Inc. and Pem Hall from the Parshall City Council member have requested speed limit and pedestrian crossing changes on Parshall Bay Road, CR 14. The request is to add a 40 mph sign for westbound traffic and eastbound traffic; two 25 mph signs in town between 73rd Ave NW and ND Hwy 37, and a pedestrian crossing between Main St and ND Hwy 37 on CR 14.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the speed limit and pedestrian crossing changes on Parshall Bay Road, CR 14 in Parshall. Upon roll call, all present voted yes. Motion carried.

Administrative Assistant Trahan presented the Board with a Cattle Pass Agreement with Larry and Beverly Thompson and Juli and RayDean Strid. The road construction of 101st Ave NW, CR 9, was realigned to the section line which severs the Thompson's pasture and the only water source is on the east side of the road. Administrative Assistant Trahan stated the entire cost would be the responsibility of the County since the road was moved and the estimated cost is \$75,000.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the Cattle Pass Agreement with Larry and Beverly Thompson and Juli and RayDean Strid during the road construction of 101st Ave NW, CR 9 at an estimated cost of \$75,000. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the advertisement for one semitruck for the Road & Bridge Department and to purchase one belly dump trailer. Upon roll call, all present voted yes. Motion carried.

Engineering Tech Duerre stated the rental program used to rent the tractors may be discontinued and requested to trade in the one Case 125A tractor and purchase 2 new tractors.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the advertisement for two tractors for the Road & Bridge Department. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to accept the quote from West River Striping Company to stripe the County paved roads. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to award and start immediately for the emergency repairs on Old Hwy 2 to Gratech Company, LLC. Upon roll call, all present voted yes. Motion carried.

Engineering Tech Duerre informed the Board that the Volvo road grader had a faulty emergency brake and caused a fire. The Volvo warranty will only cover the faulty emergency brake and not anything damaged by the fire. States Attorney Enget stated the insurance company should handle the matter.

Administrative Assistant Trahan informed the Board a settlement was requested by CSI concerning CR 1 and CR 12, Plaza Road Projects with the following revisions: revise the request for payment by 50% for reclaiming additional asphalt thickness, will remove the foreign material from the asphalt near the main intersection by September 31, 2017, repair 2 approaches by September 31, 2017, recant the request for interest payments if the County will accept the project in the current condition.

Discussion was held on moving forward for additional 2017 County Federal Aid Projects.

Administrative Assistant Trahan gave updates on the Old Hwy 2 and White Earth Valley reclamation road projects.

Melissa Vachal, Recorder, informed that Jan Taylor, deputy would be retiring at the end of July 2017 and requested a replacement. Recorder Vachal also requested a temporary position for Jan Taylor for 2 to 3 days a week in order to finish the village books. The Board agreed that Recorder Vachal could advertise for a fulltime deputy position and to utilize Jan Taylor as a temp employee.

Lori Hanson, Tax Director, and Rory Porth met with the Board to give a 2017 values update.

Tax Director Hanson requested a letter be sent to the township explaining the reversal to the 2016 values as per the June 6, 2017 Equalization Meeting.

Moved by Comm. Uran, seconded by Comm. Jacobson, to use detailed soils data along with using actual use. Upon roll call, all present voted yes except for Comm. Ruland who voted no. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to utilize the identified industry best practice methods to ensure a complete solution. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to not utilize Agridata method for Ag land valuation solution. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve moving forward with the Sidwell methods for Ag land valuation solution. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the purchase of additional software and memory with funding to come from the Commissioner contingency fund. Upon roll call, all present voted yes. Motion carried.

Discussion arose on the implementation of the soils board. The Board agreed to advertise for one person from each of the 5 Commissioner Districts vacancies with a deadline of July 31, 2017.

Shawna McFarland, Social Services Director, met with the Board to discuss Social Service funding. Director McFarland presented the caseload yearly totals and presented the proposed 2018 Social Service budget.

States Attorney Enget gave an update on the arbitration with Ceres Environmental Services, Inc.
