PROCEEDINGS OF THE BOARD OF MOUNTRAIL COUNTY COMMISSIONERS

JULY 15, 2014

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Arlo Borud, Greg Boschee, David J. Hynek, Garry Jacobson and Colleen Reese present. Also present during the meeting was Dave Leftwich, Western Transportation Liaison for the ND Department of Transportation.

Chairman Borud called the meeting to order.

Moved by Comm. Jacobson, seconded by Comm. Hynek, to approve the Minutes of the July 1, 2014 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Hynek, seconded by Comm. Reese, to approve payment of bills totaling \$1,316,008.12. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a regular basis on the Mountrail County Website @ www.co.mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Hynek, seconded by Comm. Reese, to advertise for applicants for two custodial positions at a starting salary of \$42,168 a year depending on experience. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to authorize temporary help for custodial duties at a salary of \$20.00 per hour until custodial positions are filled. Upon roll call, all present voted yes. Motion carried.

Discussion was held on the County Agent position held by Jim Hennessy. Mr. Hennessy resigned his position as office chair for the local Extension Service but will remain as Extension Agent. The Board felt there are serious issues that need to be resolved with the extension service bureaucracy. The Board agreed to contact Chris Boerboom, Director of the NDSU Extension Service, informing him the Board is seriously considering hiring Jim Hennessy as an independent agent as the County does not want to lose such an outstanding-dedicated employee. Mr. Boerboom would be given an invitation to meet with the Board on August 5, 2014.

Moved by Comm. Hynek, seconded by Comm. Boschee, to approve a transfer of \$400,000 to the Social Services Fund and \$400,000 to the Oasis Fund from the General Fund to help with expenses in these funds. Upon roll call, all present voted yes. Motion carried.

Donald Longmuir Jr., Planning & Zoning Administrator, and Lisa Lee, Assistant Planning & Zoning Administrator, were present for the hearings pertaining to zoning amendments.

Chairman Borud opened the 10:00 A.M. public hearing to receive comment on the zoning amendment request filed by Aarmac Transport, with concurrence from landowners, Dallas & Deborah Moore, to rezone a 10.76 acre, more or less, tract of land in McGahan Township from agricultural to industrial for the purpose of building a truck repair shop. No one was present for the hearing.

Administrator Longmuir presented information from the June 23, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by Aarmac Transport/Moores'.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the request of Aarmac Transport, with concurrence from landowners Dallas & Deborah Moore, for an amendment to the Mountrail County Zoning Map to rezone a 10.76 acre, more or less, tract of land described as Outlot 1 of the NESE Section 24, Township 156 North, Range 89 West (McGahan Township) from agricultural to industrial for the purpose of building a truck repair shop in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their June 23, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 10:05 A.M. public hearing to receive comment on the zoning amendment request filed by Michael R. & Dottie L. Hanson to rezone a 9.00 acre, more or less, tract of land in Myrtle Township from agricultural to residential to allow for future development. Michael & Dottie Hanson were present for the hearing.

Assistant Administrator Lee presented information from the June 23, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by Hansons'.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the request of Michael R. & Dottie L. Hanson, for an amendment to the Mountrail County Zoning Map to rezone a 9.00 acre, more or less, tract of land described as Outlot 1 of S½SW less Sublot A of Outlot 1 Section 15, Township 156 North, Range 94 West (Myrtle Township) from agricultural to residential to allow for future development in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their June 23, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Warren Craft & James Enge, Supervisors of the Purcell Township Board, met with the Board to request assistance on a flooded section road on 79th St NW near 59th Ave NW in Purcell Township. Donald Longmuir Jr., Disaster Emergency Coordinator; Lisa Lee, Assistant Disaster Emergency Coordinator, and Jana Heberlie, County Engineer, were also present.

Coordinator Longmuir indicated a flood disaster will be declared and possible funding will be available and suggested submitting a request for funding for the east/west section of this flooded road. A 2,150' X 24' section of 79th Ave NW running north and south would need to be repaired and raised. Purcell Township received an estimate for \$462,600 for this grade raise. The Township was informed this project would need to be bid according to State Law and it was suggested an engineer be hired to draw up plans/specs for the bid letting.

Moved by Comm. Hynek, seconded by Comm. Reese, to approve assisting Purcell Township a maximum of \$450,000 from the County Road & Bridge Fund to repair and raise the grade on 79th Ave NW in Purcell Township. Upon roll call, all present voted yes. Motion carried.

Troy Coons, Chairman of Lowland Township Board, met with the Board to request assistance of seven flood sites on townships roads in Lowland Township. The estimated cost to fix these sites is \$329,692. Mr. Coons indicated all the east/west roads are under water and this estimate is for repairing the road only. Lowland Township does not have the funding to fix these sites.

Moved by Comm. Reese, seconded by Comm. Hynek, to approve assisting Lowland Township a maximum of \$329,692 from the County Road & Bridge Fund to repair seven flood sites on 72nd St NW, 74th St NW & 76th St NW in Lowland Township. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie updated the Board on positions being filled in the Road Department. Also, Engineer Heberlie requested permission to allow one of the temporary employees in the Road Department to assist with custodial services in the Road Department. The Board stated they had no objections.

Moved by Comm. Boschee, seconded by Comm. Reese, to authorize the following County Road & Bridge equipment be placed on the Sheriff's auction in August of 2014 as presented by Engineer Heberlie which included a 1998 Chevy ¾ ton pickup, 1997 Chevy 1500 pickup, 1995 Ford LT9000 truck, and 1983 1½ ton dump truck and a 1960's 220 International tractor/pay loader. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie requested permission to utilize the services of Brosz Engineering to assist the Road Department during the transition of employees and to help train personnel. The Board had no objections to this request.

Engineer Heberlie discussed equipment needs for the Road Department. A quote for Walk'N'Roll packer/rollers was presented to the Board. This purchase would be put on hold as a plow truck is needed for the New Town area.

Moved by Comm. Hynek, seconded by Comm. Boschee, to advertise for the purchase of a plow truck for the County Road & Bridge Department. Upon roll call, all present voted yes. Motion carried.

Discussion was held on alternate routes being used south of New Town due to the construction on State Highway 23 by the ND Department of Transportation. Comm. Hynek asked if the State could have the contractor blade 36th St NW on a weekly basis. Dave Leftwich, Western Transportation Liaison for the ND Department of Transportation, said the State does not use haul routes if the traffic is maintained on the State highway that is under construction. Mr. Leftwich also stated the public is using this road not the State, and the State does not want to set a precedent as there is no designated haul road for this project.

Moved by Comm. Hynek, seconded by Comm. Jacobson, to authorize the Chairman of the Board sign the Contractor Agreement with Central Specialties and Notice to Proceed for Project 02(06)13 to reconstruct and overlay Old Highway 2 from 4th St SW in Stanley City west to US#2. Upon roll call, all present voted yes. Motion carried.

The Board reviewed fund balances and discussed preliminary budgets for the 2015 year.

Moved by Comm. Boschee, seconded by Comm. Reese, to appoint Linda Wienbar to the County Planning Commission for the unexpired term of Michael Hynek's ending December 31, 2014. Upon roll call, all present voted yes except for Comm. Hynek who voted no. Motion carried.

Comm. Hynek, seconded by Comm. Reese, to pass a resolution to declare a Flood Disaster for Mountrail County. Upon roll call, all present voted yes. Motion carried.
