Proceedings of the Mountrail County Commissioners

July 18, 2017

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Arlo Borud, Trudy Ruland, and Daniel Uran. Absent was Garry Jacobson. Also present was States Attorney Wade Enget, Will Kulczyk, Charlie Sorenson, Donald Longmuir, Alan LaBar, Shannon Gilmore, and Brian Kunz.

Chairman Borud called the meeting to order.

Moved by Comm. Ruland, seconded by Comm. Uran, to review and approve the agenda as is. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the Minutes of July 5, 2017 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the bills totaling \$681,752.17. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a regular basis on the Mountrail County Website @ www.co.mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the June 2017 Correctional Center, Sheriff's Department, and Clerk of Court fees. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the appointment of Wayne Olson as the Commissioner for District 1. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the transfer for the 2017 Worker's Compensation Premium totaling \$48,853.37 from the County Road & Bridge Fund, Social Welfare Fund, County Parks Fund, and the Weed Control Fund to the General Fund. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the transfer totaling \$5,803.63 from the 2009 Flood Disaster Fund to the County Road & Bridge Fund. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the transfer totaling \$191,673.86 from the 2011 Flood Disaster Fund to the County Road & Bridge Fund. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the Stop Payment Agreement for Gloria Lagorin in the amount of \$64.97. Upon roll call, all present voted yes. Motion carried.

Donald Longmuir met with the Board to discuss becoming the interim Planning & Zoning/DES Administrator. Don Longmuir requested to be paid \$42.00 an hour for 16 hours per week and to not to receive retirement benefits.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the appointment of Donald Longmuir as the interim Planning & Zoning/DES Administrator. Upon roll call, all present voted yes. Motion carried.

Corey Bristol, Sheriff's Deputy, met with the Board to discuss updates to the Plaza tower. Discussion was held on which budget the cost would come from since there is no room in the 911 budget. Deputy Bristol contacted the Plaza Fire Department and they agreed to cover the cost of the tower and antenna.

Don Longmuir, Interim Planning & Zoning Administrator, was present for the hearings pertaining to the zoning amendments.

Chairman Borud opened the 9:50 A. M. public hearing to receive comments on the zoning amendment request filled by Johnny David Kulczyk, landowner, to rezone a 10 acre more or less tract of land in Unorganized Township from agricultural to industrial for the purpose of a water depot with ponds and a well

Present for the hearing was Will Kulczyk.

Will Kulczyk stated the previous manager has been demoted and Will Kulczyk will be taking over the project. Will Kulczyk stated the requests made by neighbors are simple and plans to do things right. Will Kulczyk asked the Board approve the request despite the recommendation made by the Planning & Zoning Committee at the June 23, 2017 meeting to deny the amendment request.

Charlie Sorenson from the Planning & Zoning Committee stated the amendment does not qualify to be zoned industrial. Charlie Sorenson explained that the project is encroaching the section line and it is not located

near a major corridor. Charlie Sorenson requested the Board deny the amendment and to send the matter back to the Planning & Zoning Board.

Moved by Comm. Ruland, seconded by Comm. Uran, to send the matter which was requested by Johnny David Kulcyzk, landowner, back to Planning & Zoning for an amendment to the Mountrail County Zoning Ordinance to rezone a 10 acre more or less tract of land described as Outlot 1 located in the NE¼SE¼ of Section 17, Township 154 North, Range 94 West (Unorganized Township) and a 10 acres more or less tract of land described as E½ of Section 20, Township 154 North, Range 94 West (Unorganized Township) from agricultural to industrial for the purpose of a water depot with a pond and a well in accordance with regulations set forth in Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their June 20, 2017 meeting. Upon roll call, all present voted yes. Motion carried.

Shena Wold, Treasurer, met with the Board to present the Pledge of Securities.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the Pledge of Securities of Liberty State Bank of Powers Lake, American Bank Center of Stanley, Cornerstone Bank of New Town, Bremer Bank of Minot, and First International Bank & Trust of Minot. Upon roll call, all present voted yes. Motion carried.

Treasurer Wold informed the Board that an account from Liberty State Bank and an account from Cornerstone Bank had become dormant accounts. Treasurer Wold stated the accounts would earn more interest with Bremer Bank.

Moved by Comm. Ruland, seconded by Comm. Uran, to contact Liberty State Bank and Cornerstone Bank to request a rate adjustment or the money will be moved. Upon roll call, all present voted yes. Motion carried.

Rory Porth, Assessor, met with the Board to discuss issues in the Tax Directors Office.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the license of ArcGIS Basic in the amount of \$1,250 and the remote installation and training by Sidwell in the amount of \$1,850 to be taken out of the Contingency Fund. Upon roll call, all present voted yes. Motion carried.

Assessor Porth presented the Mountrail County Soils Committee Policy.

Moved by Comm. Ruland, seconded by Comm. Uran, to adopt the Mountrail County Soils Committee Policy. Upon roll call, all present voted yes. Motion carried.

Assessor Porth reviewed the requirements for assessor certification for a Class II Assessor which needs to be completed by July 31, 2017. Assessor Porth gave an update on the certification process for the local assessors.

Assessor Porth stated the Tax Director's Office will be closed on August 8, 2017 in order for all 3 employees to attend the State Board of Equalization Meeting.

Laurie Johnson, Jail Administrator, met with the Board to discuss the jail facility. Discussions were held on cameras from the old jail and training.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve overtime for 6 employees from the jail facility. Upon roll call, all present voted yes. Motion carried.

The Board, along with interim Administrator Longmuir, reviewed the applications for the Planning & Zoning/DES Administrator position.

Alan LaBar met with the Board to request to continue assessing for the City of White Earth. Also present was Shannon Gilmore, Mayor of White Earth. Alan LaBar stated the classes were not completed in the two year time frame because of procrastination. Alan LaBar stated the State Tax Commissioners Office had advised him to make request to continue assessing from the City of White Earth and from the County. States Attorney Enget stated Alan LaBar could possibly become a data collector for the County and would not be an assessor. The Board agreed to leave the decision to Lori Hanson, Tax Director.

Brian Kunz with Adolfson & Peterson met with the Board to give an update on the jail facility.

Discussion was held on moving the designated smoking area to the County shop.
