Proceedings of the Mountrail County Commissioners

August 1, 2017

The Board met in regular session on Wednesday at 9:00 A.M. with Commissioners Arlo Borud, Trudy Ruland, Garry Jacobson, Wayne Olson, and Daniel Uran present. Also present was States Attorney Wade Enget, Donald Longmuir, Scott Rudolph and Ryan Gjellstad from Border Plains Equipment, Gary Weisenberger from Gooseneck Implement, and Fred Berry, Tom McCoy, and Stan Bisceglia from Fairmount Santrol.

Chairman Borud called the meeting to order.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to review and approve the agenda as is. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the Minutes of July 18, 2017 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the appointment of Wayne Olson to the Job Development Authority Board for an unexpired term ending December 31, 2018. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the appointment of Wayne Olson to the Park Board for an unexpired term ending December 31, 2018. Upon roll call, all present voted yes. Motion carried.

Karen Babbitt, Head Custodian, met with the Board to discuss issues with the newly constructed Justice Center. Head Custodian Babbitt stated the power went out and several panels and outlets needed to be reset. Discussion was held on when the power went out and the generator lag time issues. Head Custodian Babbitt also stated the battery backups for the card readers were not ordered by Garrett Volk, IT Administrator. The Board requested Head Custodian Babbitt contact MDU, Wheeler Contracting Inc., IT Administrator Volk, and

Adolfson and Peterson Construction to be present at the August 15, 2017 Commissioner Meeting to further discuss the issue.

Shawna McFarland, Social Services Director, informed the Board that some job duties will be shifted in order to cover for a recently vacated secretary position. Director McFarland requested that overtime be paid for the rest of the year instead of accumulating flex time.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve overtime for Social Services with the proper documentation due to new state funding. Upon roll call, all present voted yes. Motion carried.

Laurie Johnson, Jail Administrator, met with the Board to give an update on the Correctional Center.

Jana Heberlie, Road & Bridge Engineer, met with the Board to discuss Road & Bridge Department issues along with Scott Duerre, Engineering Tech.

Engineer Heberlie presented the bid results from the July 27, 2017 bid opening for 1 new 2017 semitruck and 2 new 2017 front wheel assist tractors.

Moved by Comm. Jacobson, seconded by Comm. Uran, to accept the lowest bid from Westlie Truck Center for 1 new 2017 Western Star semi-truck with 1 trade in for a purchase price of \$113,002.00. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the lowest bid from Border Plains Equipment for 2 new 2017 front-wheel assist tractors with 1 trade in for a purchase price of \$154,000.00. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie informed the Board that Fairmount Santrol would like to discuss lifting the road restrictions on the Manitou road, CR 7, during frost law. Tom McCoy from Fairmount Santrol requested the road be tested by Braun Intertec to determine if the road can handle more weight. Engineer Heberlie stated the road was built to withstand a restriction of by legal weight/105,500 lbs. max and the frost law restrictions are 7 ton/105,500 lbs. max. Engineer Heberlie recommended to not change the current load restrictions and the Board agreed.

Engineer Heberlie gave updates on the White Earth Valley, Parshall Bay, and Old Hwy 2 road projects.

Engineer Heberlie informed the Board that Governor Bergum signed House Bill 1320 which allows counties to advertise a change in posted road restrictions for conditions of inclement weather.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve, sign and send a letter to all operators about the House Bill 1320 update. Upon roll call, all present voted yes. Motion carried.

Discussion was held on the request made by Hess Corporation to haul overweight on the White Earth Bay road.

Moved by Comm. Ruland, seconded by Comm. Olson, to offer Nathan Sem the DES/P&Z position based on the recommendation of the interview committee with a starting salary of \$48,000 per year. Upon roll call, all present voted yes. Motion carried.
