Proceedings of the Mountrail County Commissioners

August 16, 2016

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Arlo Borud, Greg Boschee, Garry Jacobson, Colleen Reese, and Trudy Ruland. Also present was Garry Johnson; and Derrick Walker with Envirotech Services.

Chairman Borud called the meeting to order.

Moved by Comm. Jacobson, seconded by Comm. Boschee, to approve the Minutes of the August 2, 2016 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the bills totaling \$1,641,551.77. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a regular basis on the Mountrail County Website @ www.co.mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the June and July 2016 fees for the Recorder's Office, July 2016 fees for the Sheriff's Department, and the July 2016 fees for the Clerk of Court's Office. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the transfer for the 2016 Worker's Compensation Premium totaling \$51,710.42 from the County Road & Bridge, Social Welfare, County Parks, and Weed Control Funds to the General Fund. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the Road Crossing Permit 370 from EOG Resources, Inc. on CR 3A, 72nd Ave NW, located in Section 18 in Township 153 North, Range 89 West (Wayzetta Township) to bore for a water pipeline. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the advertisement for preliminary and construction engineering services for a pole or steel structure for the Plaza Shop. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve setting up the Special Meeting for September 8, 2016 at 8:30 A.M. for the Upper Missouri District Health Unit 2017 budget hearing. Upon roll call, all present voted yes. Motion carried.

Wade Enget, States Attorney, reviewed the current maternity leave policy and FMLA. States Attorney Enget stated a new draft of the policy will be presented at the September 6, 2016 Meeting.

Don Longmuir, Planning & Zoning Administrator, and Lisa Lee, Planning & Zoning Assistant Administrator, were present for the hearings pertaining to the zoning amendment.

Chairman Borud opened the 9:30 A.M. public hearing to receive comments on the zoning amendment request filed by Aaron Olson, with concurrence from landowner David Debertin, to rezone a 4.454, more or less, tract of land known as Outlot 2 in the SE¼NE¼ of Section 20, Township 152 North, Range 90 West in Parshall Township from agricultural to industrial for the purpose of storing generators.

Administrator Longmuir presented the information from the July 25, 2016 Planning & Zoning public hearing of the Planning & Zoning Commission recommended approval of the zoning amendment filed by Aaron Olson.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the request of Aaron Olson, with concurrence from landowner David Debertin, for an amendment to the Mountrail County Zoning Ordinance to rezone 4.454 acre, more or less, tract of land described as Outlot 2 in the SE¼NE¼ of Section 20, Township 152 North, Range 90 West (Parshall Township) from agricultural to industrial for the purpose of storing generators in accordance with regulations set forth in the Mountrail County Ordinance and as recommended by the Mountrail County Planning Commission at their July 25, 2016 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 9:35 A.M. public hearing to receive comments on the zoning amendment request filed by Western Area Water Supply Authority, with concurrence from landowners Kevin & Sharon Mell, to rezone a 1 acre, more or less, tract of land known as Outlot 2 in the S½SW¼ of Section 21, Township 156 North, Range 93 West in Manitou Township from agricultural to industrial for the placement of a 1 million gallon water storage water tank and pump station. Present for the hearing were Dave Bauer and Nathan Kleyer from Western Area Water Supply Authority.

Administrator Longmuir presented the information from the July 25, 2016 Planning & Zoning public hearing of the Planning & Zoning Commission recommended approval of the zoning amendment filed by Western Area Water Supply Authority.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the request of Western Area Water Supply Authority, with concurrence from landowners Kevin & Sharon Mell, for an amendment to the Mountrail County Zoning Ordinance to rezone 1 acre, more or less, tract of land described as Outlot 2 in the S½SW¼ of Section 21, Township 156 North, Range 93 West (Manitou Township) from agricultural to industrial for the placement of a 1 million gallon water storage water tank and pump station in accordance with regulations set forth in the Mountrail County Ordinance and as recommended by the Mountrail County Planning Commission at their July 25, 2016 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 9:40 A.M. public hearing to receive comments on the zoning amendment request filed by Pro Pipe Corporation, with concurrence from landowners Betty Neset Restated Family Trust, Arlene Stone and Kathleen Neset, to rezone a 5.5 acre, more or less, tract of land known as Outlot 1 in the NW¼NW¼ of Section 30, Township 157 North, Range 94 West in White Earth Township from agricultural to industrial for the purpose of operating a construction business. Present for the hearing was Ron Marsh from Pro Pipe Corporation.

Assistant Administrator Lee presented the information from the July 25, 2016 Planning & Zoning public hearing of the Planning & Zoning Commission recommended approval of the zoning amendment filed by Western Area Water Supply Authority.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the request of Pro Pipe Corporation, with concurrence from landowners Betty Neset Restated Family Trust, Arlene Stone and Kathleen Neset, for an amendment to the Mountrail County Zoning Ordinance to rezone 5.5 acre, more or less, tract of land described as Outlot 1 in the NW¼NW¼ of Section 30, Township 157 North, Range 94 West (White Earth Township) from agricultural to industrial for the purpose of operating a construction business in accordance with regulations set forth in the Mountrail County Ordinance and as recommended by the Mountrail County Planning Commission at their July 25, 2016 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 9:45 A.M. public hearing to receive comments on the proposed Planning & Zoning ordinance changes.

Todd Mantz from Sundre Sand & Gravel met with the Board to discuss the \$250,000 letter of credit requirement for gravel pits. Todd Mantz stated Sundre Sand & Gravel does a lot of business with townships and this would increase costs and suggested the amount of the letter of credit be lowered. Administrator Longmuir stated that a \$125,000 would be an acceptable amount for a letter of credit.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve the Planning & Zoning amendments and to change the letter of credit requirement to \$125,000 for gravel pits. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the subdivision resolution proposed changes. Upon roll call, all present voted yes. Motion carried.

Administrator Longmuir gave an update on the special legislative session.

Bryan Quigley, Social Services Director, met with the Board to introduce the new Director, Shawna McFarland. Director Quigley will retire on August 19, 2016.

Director Quigley requested a pay increase of \$1,000.00 per year for Shelly Kinney. The Board decided that the budget for 2017 would need to be reviewed before a raise could be given.

Melissa Vachal, Recorder; Traci Hysjulien, Clerk of Court; Lori Hanson, Tax Director; and Shena Wold, Treasurer met with the Board to discuss possible available space when the Sheriff's Department and Clerk of Court moves to the new facility.

Tax Director Hanson informed the Board that a discussion will be needed on the acreage discrepancies in the County before moving to soils in order to get implemented in the 2017 year.

Jana Heberlie, Road Engineer, met with the Board to discuss Road & Bridge issues along with Engineering Tech, Scott Duerre, and Road Supervisors, Monte Dyke and Eddie Patterson.

Craig Smith from Crowley Fleck and Rashan Clark, Ben Scheeler, Michelle Phillips with Hess met with the Board to discuss a valve that was placed on a section line in the SE¼ of Section 12 and the NE¼ of Section 13 in Township 155 North, Range 94 West without a permit. At the March 1, 2016 meeting the Board suggested Hess look for an alternative. Attorney Smith stated that Hess decided to relocate the valve but the landowner has requested the valve be placed 75 feet from the section line instead of the required 150 feet.

Moved by Comm. Jacobson, seconded by Comm. Boschee, to approve the relocation of the valve to 150 feet from the section line in the SE¼ of Section 12 and the NE¼ of Section 13 in Township 155 North, Range 94 West. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the Road Crossing Permit 263 from Hess Corporation on 96th Ave NW, located in Sections 12 and 7 in Township 155 North, Range 94 and 93 West (Unorganized Townships) to bore for water and gas. Upon roll call all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the Road Crossing Permit 264 from Hess Corporation on 58th St NW, located in Sections 12 and 13 in Township 155 North, Range 94 West (Unorganized Township) to bore for water and gas. Upon roll call all present voted yes. Motion carried.

Engineer Heberlie presented the bids for the motor grader bids from the August 2, 2016 meeting. Kent Jaeger was present from RDO Equipment.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the purchase of two John Deere 772 GP Electro Hyd Controls motor grader from RDO Equipment with trade-ins totaling \$358,200. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the final payment to Ackerman Estvold for the design of the Plaza shop totaling \$150,525.90 pending all original documents are received before payment is issued. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie informed the Board that the ditches in Plaza are silted and need to be cleaned out in order for water to drain into the new culverts being installed at an additional cost of \$13,675.38. Jeff Ebsch with Brosz Engineering stated the cleaning of the ditches were never in original design plans.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the upcoming change order in the amount of \$13,675.38 to clean the ditches in the City of Plaza. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the payment to Edwards Gravel in the amount of \$247,431.12 for gravel crushed in the Rice Pit. Upon roll call, all present voted yes. Motion carried.

Discussion was held on the requirements for advertising for fuel bids when the amount exceeds \$4,000. The ND Century Code 11-11-26 states bids can be made by telephone solicitations from at least two suppliers or by advertisement in the official county newspaper. Engineer Heberlie will email the local suppliers.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the speed limit change on CR11 to 35 mph due to the breakage repair for a short distance (as per attached map). Upon roll call, all present voted yes. Motion carried.

Discussion was held on the approach to Lot 39 in the White Earth Bay Park. States Attorney Enget stated the Corp will need to be contacted because the park road is Corp property.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve a letter be sent to Brosz Engineering requesting all original signed plans and documents pertaining to completed road projects be returned to the County. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie stated that Bicker Township has requested mileage be added to the Road Maintenance Contract. The Board agreed that Bicker Township will have to wait until next year to add the mileage when a new contract is signed.

Moved by Comm. Ruland, seconded by Comm. Reese, to approve purchasing rock for rip rap projects from the Wirtz Pit totaling \$48,434.40. Upon roll call, all present voted yes. Motion carried.

Discussion was held on blading. The Board agreed that private subdivisions and roads will continue to not be bladed by the County Road & Bridge Department.

Discussion was held on overweight permits not being used on the Sacagawea Pipeline project. The Board requested Engineer Heberlie send an email to the Public Service Commission on this issue.

Shena Wold, Treasurer, met with the Board to present proposals for Money Market accounts from American Bank Center, Wells Fargo, Bank of the West, Bremer, and First International Bank & Trust. The Board agreed to stay with Bremer due to the excellent customer service the County has received.

Brian Kunz, Konrad Johnson, and Mike Janssen with Adolfson & Peterson met with the Board to give an update on the new jail facility.

Alan Ibach with NRG Technology Services met with the Board to present a proposal to manage the IT system and network.

Laurie Johnson, Jail Administrator, met with the Board to give an update on contracts, job openings, and manuals for the new jail facility.

Garrett Volk, IT Administrator, met with the Board to discuss a proposal from RTC for a phone system for the new jail facility.
