## PROCEEDINGS OF THE MOUNTRAIL COUNTY COMMISSIONERS

## **SEPTEMBER 16, 2014**

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Arlo Borud, Greg Boschee, Garry Jacobson, Colleen Reese and Trudy Ruland present.

Chairman Borud called the meeting to order.

Moved by Comm. Jacobson, seconded by Comm. Reese, to approve the Minutes of the September 2, 2014 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the Minutes of the September 4, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the Minutes of the September 11, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve payment of bills totaling \$2,647,776.77 and August Payroll checks #23197-23209 and direct deposits #7558-7690 totaling \$638,629.04. Upon roll call, all present voted yes. Motion carried. Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the July fee report of the County Recorder and August fee report of the Clerk of Court. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve Permit #178 Enable Bakken Crude Services to cross the county road/section line referred to as 102nd Ave NW between Section 7, Township 154 North, Range 94 West (Unorganized Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the petition made by Ardith D. Lucy, Anita Sandberg, Michael A. Lucy, Andrea R. Lucy n/k/a Andrea R. Ladner, and Alana R. Erickson for vacating lots, streets, avenues & alley ways which is located in the SE¼NW¼ of Section 15, Township 158 North, Range 92 West, (Powers Township), which includes Lots 1- 18 of Block 1; Lots 1-12 of Block 2; all of 2nd Street, 1st Street and Main Street; and all of Valley Avenue and Williams Avenue— all within Lunds Valley Subdivision. Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the salary for Jim Hennessy as the Independent County Agent at a salary of \$5,598.00 per month. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the stipulation of interest and cross conveyance between Edward S. Krieger and Mountrail County which is described as a strip of land along the North line of the NW¼ of Section 11, Township 154 North, Range 94 West (Unorganized Township) and the N½NE¾ of Section 10, Township 154 North, Range 94 West (Unorganized Township) contains 2.06 acres, more or less. Wade Enget, State's Attorney, was present to explain to the Board it was right of way minerals less the 33 feet. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to waive the deposit to lease the South Complex to SRF Consulting Group. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to hold a Public Hearing on Tuesday, October 21, 2014 at 10:00 A.M. in the Community/Commissioner's Room located on the second floor of the Mountrail County Courthouse, 101 North Main Street, Stanley, North Dakota, for the purpose of receiving comments on a zoning amendment request filed by Gene and Patricia Brown, for an amendment to the Mountrail County Zoning Map to rezone a 40.00 acre, more or less, tract of land described as SE¼NW¼ including Outlot 1 E½SE¼NW¼, Section 30, Township 156 North, Range 93 West (Manitou Township) from agricultural (30.92 acres) and commercial (9.08 acres) to industrial to allow for a storage yard for an Enbridge Pipeline Project. Upon roll call, all present voted yes. Motion carried.

Ruland, to hold a Public Hearing on Tuesday, October 21, 2014 at 10:10 A.M. in the Community/Commissioner's Room located on the second floor of the Mountrail County Courthouse, 101 North Main Street, Stanley, North Dakota, for the purpose of receiving comments on a zoning amendment request filed by EOG Resources, with concurrence from Steven M. & Jeanette A. Hoff, to the Mountrail County Zoning Map to rezone a 18.53 acre, more or less, tract of land described as Outlot 3 of the NW¼NW ¼ of Section 10, Township 152 North, Range 90 West (Parshall Township) from agricultural to industrial for purpose of constructing a water reservoir. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Jacobson, to hold a Public Hearing on Tuesday, October 21, 2014 at 10:20 A.M. in the Community/Commissioner's Room located on the second floor of the Mountrail County Courthouse, 101 North Main Street, Stanley, North Dakota, for the purpose of receiving comments on a zoning amendment request filed by EOG Resources, with concurrence from landowners, Bartelson Investments LLLP, to the Mountrail County Zoning Map to rezone a 6.79 acre, more or less, tract of land described as Outlot 2 of the NE¼NE¼ of Section 9, Township 152 North, Range 90 West (Parshall Township) from agriculture to industrial for the purpose of constructing a gas compressor station. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Ruland, to set the poll hours from 8 a.m. to 7 p.m. for the General Election to be held on November 4, 2014. Upon roll call, all present voted yes. Motion carried. Due to the General Election being held on Tuesday, November 4, 2014, the Board was in consensus to reschedule the Tuesday, November 4, 2014 Commissioner's meeting for 9 a.m. on Thursday, November 6, 2014.

The Board tabled setting up another budget meeting.

Tax Director, Lori Hanson, met with the Board to discuss budget requests for the 2015 year for the Tax Director's Office. Tax Director Hanson asked the Board to purchase a vehicle for the Department's use, but she

stated she would not mind taking a used vehicle or a trade from the Sheriff's Department when they trade one in. Tax Director Hanson then asked the Board for \$12,000 of this money budgeted for a new vehicle be used for Vanguard CAMA software.

Al Hanson, from the ND Department of Emergency Services, brought the Board a radio agreement that needs to be signed by the County. Mr. Hanson told the Board that the Department of Emergency Services has a band radio in a bag for use in case of an emergency. Mr. Hanson said there are four regional coordinators who have possession of these radios.

Moved by Comm. Reese, seconded by Comm. Jacobson, to have the Chairman of the Board sign the radio agreement with the ND Department of Emergency Services. Upon roll call, all present voted yes. Motion carried.

Donald Longmuir Jr., Planning & Zoning Administrator, was present for the hearings pertaining to the zoning amendments. King Schmelzer and Tony Hill, both from Glacier Energy, were present for the hearings. Also present were Lorna Elton and Shelly Ventsch, both from Howie Township, and Giles Radtke.

Chairman Borud opened the 10 a.m. public hearing to receive comments on the zoning amendment request filed by Glacier Energy Services with concurrence from landowner David Hilleren, to rezone a 10.0 acre, more or less tract of land in Unorganized Township from agricultural to industrial to construct a water depot.

Administrator Longmuir presented information from the August 25, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by Glacier Energy/Hilleren.

The Board heard concerns regarding this facility from Shelly Ventsch and Lorna Elton both from Howie Township. They were opposed of this going forward due to incomplete paperwork filed with Howie Township in accordance with the townships own planning and zoning laws. It was also brought to the attention of the Board that operation began before it was approved by the county Board. So thus the Board gave direction for Administrator, Don Longmuir, to look into the penalties per day to be assessed for not being compliant with State's Attorney, Wade Enget.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve the request of Glacier Energy Services with concurrence from David Hilleren, for an amendment to the Mountrail County Zoning Map to rezone a 10.0 acre, more or less tract of land described as the NW ¼ of Government Lot 4, Section 2, Township 150 North, Range 92 West (Unorganized Township) from agricultural to industrial to construct a water depot in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their August 25, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 10:10 a.m. public hearing to receive comments on the zoning amendment request filed by Giles Radtke to rezone a 6.46 acre, more or less tract of land in Rat Lake Township from agricultural to residential to allow for placement of a mobile home.

Administrator Longmuir presented information from the August 25, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by Mr. Radtke.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve the request of Giles Radtke, for an amendment to the Mountrail County Zoning Map to rezone a 6.46 acre, more or less tract of land described as Lot 1 Polley Acres Subdivision, Section 5, Township 154 North, Range 93 West (Rat Lake Township) from agricultural to residential to allow for placement of a mobile home in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their August 25, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 11:00 A.M. public hearing on the Mountrail County Preliminary Budget for the 2015 year. No persons appeared to make comment on any expenditure or tax levy.

Moved by Comm. Reese, seconded by Comm. Jacobson, to close the public hearing on the Mountrail County Preliminary Budget for the 2015 year. Upon roll call, all present voted yes. Motion carried.

Wes Black, Brad Borgman, and Kristen Ketter, all from Bremer Bank, met with the Board to discuss the financial services Bremer has to offer. County Treasurer, Shena Wold, was also present.

Clerk of Court, Traci Hysjulien, met with the Board to discuss budget requests for the Clerk of Court's Office for the 2015 year. Clerk of Court Hysjulien requested imaging software to digitize marriage licenses due to not having local back up files for licenses from 1908 to 1968. The Board directed Clerk of Court Hysjulien to do research for software costs.

County Treasurer, Shena Wold, met with the Board to discuss budget requests for Treasurer's Office for the 2015 year. The Board asked Treasurer Wold if she felt she had enough help for her office. The Board authorized Treasurer Wold to fit into her budget, if she needed to hire one, a Clerk II position at a starting salary of \$49,824 and to include adjustments for dental, health and life insurance.

County Recorder, Melissa Vachal, met with the Board to discuss budget requests for the Recorder's Office for the 2015 year. Recorder Vachal made a request to the Board to have the entry counter removed from her office to allow for a purchase of a desk with working counter so that her employees are all sitting together in the office.

Donald Longmuir Jr., Planning & Zoning Administrator, met with the Board to discuss budget requests for the Planning & Zoning Department and Disaster Emergency Services for the 2015 year. Administrator Longmuir made a request to the Board to hire a full-time County Building Inspector due to the increase of building permits received in the Planning & Zoning office each month. Administrator Longmuir said he felt that this position could also help with zoning enforcement and that the costs could be recouped costs with applying fees to conditional use permits. Administrator Longmuir also made a request to the Board for a second disaster emergency vehicle to allow for quicker response time. The Board directed Administrator Longmuir to do more research for this new position by October 1, 2014.

County Engineer, Jana Heberlie, met with the Board to discuss matters dealing with the County Road & Bridge Department. Zach Gaaskjolen, Project Engineer from Brosz Engineering, was also present.

Engineer Heberlie discussed with the Board budget requests for the Road & Bridge Department for the 2015 year. Engineer Heberlie made a request to the Board to allow her to put together a road crew for smaller jobs to help save on contract fees.

Moved by Comm. Boschee, seconded by Comm. Ruland, to remove the Road Worker III Classification from the Road & Bridge Department Budget. Upon roll call, all present voted yes. Motion carried.

Mike Sauber, representing Oakland Township, met with the Board to request assistance for repairs to 71<sup>st</sup> Ave NW (2 miles north of 51<sup>st</sup> St NW) in Oakland Township. The estimated cost to fix this site is \$16,000 to include \$8,000 for fencing and \$8,000 for repairs to the road. Mr. Sauber indicated that water is currently running over the road.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve assisting Oakland Township a maximum of \$16,000 from the Commissioner's Contingency Fund for fencing and repair of the flooded site 71<sup>st</sup> Ave NW (2 miles north of 51<sup>st</sup> St NW) in Oakland Township upon approval of Engineer Heberlie. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie presented a proposal from Hess Corporation on section line improvements on 102nd Ave NW in the Southwest of Section 7, Township 154 North, Range 94 West (Unorganized Township). Craig Smith, from Crowley/Fleck Attorneys representing Hess, and Whitney Montonye and Paul Franklin, both from Hess Bakken Investments, were also present.

Moved by Comm. Boschee, seconded by Comm. Ruland, to approve Hess to make improvements to the county road/section line referred to as 102nd Ave NW between Section 7, Township 154 North, Range 94 West (Unorganized Township) with the stipulation that the road be constructed to meet Mountrail County road design minimum standards. Whitney Montonye from Hess stated to the Board when utilizing the roads they would put down dust control and repair any damage. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Reese, to approve Change order # 1 Project Number CMC 3114 in the amount of \$6,221.93 for the addition of traffic control devices for lane closure on Highway 2 to accommodate construction activity. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Boschee, to approve Supplementary Agreement No. 1 Project Number BRC-3126(055) in the amount of \$12,754.42 for additional engineering services performed by Brosz Engineering for the Shell Creek Bridge due to additional days needed to complete the project. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie informed the Board that construction is completed on the Ross North Project 89<sup>th</sup> Ave NW, (CR5) and requested to change the weight limit restriction as recommend by Brosz Engineering due to the improvements made to the road.

Moved by Comm. Reese, seconded by Comm. Jacobson, to change the weight limit restriction from Six-Ton per Axle to Legal Weight 105,500 lbs. max for Ross North, 89<sup>th</sup> Ave NW, (CR5). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve a call for bids for three six-wheel drive motor graders with snow wing, lift group and v-plow to be opened at 11 a.m. on Tuesday October 21, 2014, in the County Commissioners Room, Mountrail County Courthouse. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie informed the Board that the ND Department of Transportation is holding a meeting at 10 a.m. on October 13 during the North Dakota Association of Counties' Annual Conference October 12-14.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve sending Scott Duerre, Engineering Technician from the Road & Bridge Department, to attend the 29th Annual Regional Local Road Conference to be held in Rapid City, South Dakota from October 22-23. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Ruland, to approve new forms for the Road & Bridge Department to include: Approach Permit, Mountrail County Policy for Township Road Assistance, Township Permit Agreement and Warranty Deed-Right of Way. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve publishing of a notice to mow weeds and grasses by the County. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie presented the Board with a letter from Fertile Townships Board requesting the county to take over and relinquishing jurisdiction of a few of the townships roads.

Moved by Comm. Reese, seconded by Comm. Jacobson, to take over jurisdiction and officially accept approximately 7 miles of the following townships roads under the County Road System effective 09/16/2014:

- 76th Ave NW-South from the Parshall Bay Road (5 miles),
- 31st St NW-East from 76th Ave NW (1 Mile)
- 75th Ave NW-South from 31st St NW (1 mile) to the McLean County Line.

It was stated it would be called County Road 3. Upon roll call, all present voted yes. Comm. Boschee abstained. Motion carried.

Engineer Heberlie presented the Board several more public utility crossing permits. Kim Lewis, representing EOG Resources was also present.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve Permit #179 Oasis Midstream Services LLC to cross the county road/section line referred to as 74th St NW (County Rd 4) between Section 24 & 25, Township 158 North, Range 92 West (Powers Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Boschee, seconded by Comm. Jacobson, to approve Permit #180 EOG Resources to cross the county road/section line referred to as 74th Ave NW between Section 10 & 11, Township 154 North, Range 90 West (Austin Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve Permit #181 EOG Resources to cross the county road/section line referred to as 74th Ave NW, between Section 14 & 15, Township 155 North, Range 90 West (Burke Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve Permit #182 EOG Resources to cross the county road/section line referred to as 74th Ave NW between Section 34 & 36, Township 156 North, Range 90 West (Palermo Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve Permit #183 EOG Resources to cross the county road/section line referred to as 74th Ave NW between Section 10 & 11, Township 155 North, Range 90 West (Burke Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve Permit #184 EOG Resources to cross the county road/section line referred to as 74th Ave NW between Section 26 & 27, Township 155 North, Range 90 West (Burke Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve Permit #185 EOG Resources to cross the county road/section line referred to as 74th Ave NW between Section 26 & 27, Township 154 North, Range 90 West (Austin Township). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve Permit #186 EOG Resources to cross the county road/section line referred to as 74th Ave NW between Section 22 & 23, Township 154 North, Range 90 West (Austin Township).

Engineer Heberlie asked the Board if the County should appoint Brosz as their only engineering firm or use other firms as well. The Board felt that they should stay with a few in case somebody is not available for services on future road construction projects.

Engineer Heberlie presented the Board a letter from Banner Township requesting assistance for repairs to 34<sup>th</sup> Street NW between 66<sup>th</sup> Avenue NW and 67<sup>th</sup> Avenue NW in Banner Township. The letter stated that FEMA approved an award of \$74,000 and that Banner Township is looking for \$90,000 in assistance from the County along with the township contributing funds. Engineer Heberlie also presented a bid proposal for repairs to this road from Strata Corporation for \$247,550.00.

Moved by Comm. Reese, seconded by Comm. Boschee, to approve assisting Banner Township a maximum of \$90,000 from the Commissioner's Contingency Fund, for repairs to 34<sup>th</sup> Street NW between 66<sup>th</sup> Avenue NW and 67<sup>th</sup> Avenue NW in Banner Township. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie informed the Board that there was an error for a check written by the County to Asdco on August 5 and would be sent back as it hadn't been cashed yet.

County Sheriff, Ken Halvorson, met with the Board on budget requests for the 2015 year for the Sheriff's Department, E911/Wireless Fund and Coroners. Sheriff Halvorson believes the reason for lack of workforce is due to lack of housing availability. The Board spoke to Sheriff Halvorson concerning improvements

needed in regards to the morale in his department, and in his working relationship with other entities. Sheriff Halvorson and the Board were in agreement that changes and improvements were needed.

Social Services Director, Bryan Quigley, met with the Board to discuss 2015 budget requests for the Social Services Office.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve Director, Quigley to send a letter to the Governor requesting extra help with the vulnerable adult program. Upon roll call, all present voted yes. Motion carried.
