Proceedings of the Mountrail County Commissioners

September 19, 2017

The Board met in regular session on Tuesday at 9:00 A.M. with Commissioners Trudy Ruland, Wayne Olson, and Daniel Uran present. Commissioner Arlo Borud was absent and Commissioner Garry Jacobson was present at 10 a.m. Also present was States Attorney Wade Enget and Clerk of Court Traci Hysjulien.

Vice-Chairman Ruland called the meeting to order.

Moved by Comm. Olson, seconded by Comm. Uran, to review and approve the agenda as is. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Uran, to approve the Minutes of September 5, 2017 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the bills totaling \$971,808.09. Discussion was also held on the Schulte and Enget bill for the furniture that was approved to pay at the September 5th meeting to be taken out of the County Board Contingency Fund. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a temporary basis on the Mountrail County Website @ www.co.mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Olson, seconded by Comm. Uran, to approve the August 2017 fees for the Clerk of Court and Sheriff's Office. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the Regular Full-time Agreement for Claudia G. Quintero from the Recorder's Office as a Clerk I totaling \$44,500 per year. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the Regular Part-time Agreement for Delia Martinez from the Social Service Department as a DCA II totaling \$17.00 per hour and not to exceed 38 hours per week. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the Regular Full-time Agreement for Melanie Lindley from the Social Service Department as a parent aide and CDA II totaling \$35,360 per year. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Uran, to approve the Road Crossing Permit 518 from Oasis Midstream Services LLC., on the section line of Sections 12 and 13 in Township 154 North, Range 94 West (Unorganized Township) to bore for production water. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to oppose the request to put Outlot 4 of the NE¼ and Outlot 10 of the NE¼NE¼ of Section 18, Township 152 North, Range 92 West (Osborne Township) into a trust with Bureau of Indian Affairs. A letter will be sent opposing all trust requests in the future to the United States Department of the Interior stating the impacts of the trust on the County and various services provided by the County. Upon roll call, all present voted yes. Motion carried.

Discussion was held concerning the County housing and the rental comparisons around the City of Stanley.

Moved by Comm. Olson, seconded by Comm. Uran, to approve the rental to non-employees with a 30 day lease at a going rate of \$1,100 per month not including heat or electricity. The change for employees will be the cap of \$1,100 per month and a new lease will be drawn up by State's Attorney Enget. Upon roll call, all present voted yes except Comm. Jacobson who voted no. Motion carried.

Shena Wold, Treasurer, met with the board concerning the advertisement of the Preliminary Resolution to Combine the Offices of the Mountrail County Auditor and Mountrail County Treasurer. Treasurer Wold was concerned with the advertisement of duties as being misleading. Treasurer Wold's recommendation is to vote no on the resolution plan. Treasurer Wold presented the Board with a typewritten letter regarding her concerns with the Plan and the process undertaken by the Board when drafting the plan.

Lori Hanson, Tax Director, met with the Board to discuss the contract with Sidwell to implement the soils data.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the Sidwell contract in the amount of \$94,924 and annual maintenance of \$3,599. Upon roll call, all present voted yes. Motion carried.

Don Longmuir, Interim P&Z/DES Administrator and Nathan Sem, P&Z/DES Administrator, met with the Board for the public hearing on the Medical Marijuana Zoning Ordinance Hearing.

Vice-Chairman Ruland opened the 10:00 A.M. public hearing to receive comments on the proposed Medical Marijuana Zoning Ordinance.

Interim Administrator Longmuir stated the recommendation from the Planning and Zoning Commission was to approve the Medical Marijuana Zoning Ordinance as is. No one attended the public hearing and no comments were received.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the Medical Marijuana Zoning Ordinance. Upon roll call, all present voted yes. Motion carried.

Mark Schlader, Director of Northstar Technology Group presented an IT Proposal. Also present was Lori Hanson, Tax Director and Traci Hysjulien, Clerk of Court.

Director Schlader presented a proposal to manage the IT system and network.

Moved by Comm. Uran, seconded by Comm. Olson, to open the 11:00 A.M. public hearing on the Mountrail County Preliminary Budget for the 2018 year. No persons appeared to make a comment on any expenditure or tax levy.

Discussion was held concerning the County Road & Bridge budget with the difference in expenses vs. revenues.

Moved by Comm. Jacobson, seconded by Comm. Olson, to approve the 0% tolerance for the 2018 budget and to close the public hearing on the Mountrail County Preliminary Budget for the 2018 year. Upon roll call, all present voted yes. Motion carried.

Jana Heberlie, Road & Bridge Engineer, met with the Board to discuss issues with the Road & Bridge Department along with Mary Trahan, Administrative Assistant.

Engineer Heberlie along with Charles Ramberg informed the Board that on CR 9 a joint cattle pass is being requested by Ramberg/Hanson. It would be a change order to the design. Discussion took place on whether this road would be paved due to budget cuts.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve a cattle pass only if paving occurs. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie presented a contract for a permitting database software. The excel program doesn't have enough space to utilize with all the permits. The permit software is IWorkQ in the amount of \$4,150 and annual maintenance of \$2,500.

Moved by Comm. Jacobson, seconded by Comm. Olson, to approve the purchase and signing of the contract with IWorkQ. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie discussed the heavy oilfield traffic on CR 4, 74th St NW which is leaving the road in poor condition and safety concerns. The Road and Bridge department cannot keep up with the maintenance. Engineer Heberlie stated that a conversation was held with Liberty requesting assistance with the road maintenance. Liberty stated only once a month is all a road grader would be able to assist. Engineer Heberlie requested to reduce the weight limit on the road.

Moved by Comm. Olson, seconded by Comm. Uran, to slow down the truck speed on CR 4 to 35 mph and cars to 45 mph which is approximately 7 miles from CR 5 to CR 9. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve signing an agreement with Joe's Tree Service for the removal of trees in the county right of way on CR 4. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the increase of 2018 Township contract rates for blading from \$125 per mile to \$150 per mile and for snow removal from \$85 per mile to \$100 per mile. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the 2018 Township Maintenance Agreements and Non-Contracted Township Maintenance Agreements for blading and snow removal. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Jacobson, to approve the purchase of 2 Schulte Flex Arms from Border Plains Equipment in the amount of \$40,000. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie gave an update on the 2018-2022 County Federal Aid program and discussed changing the priorities of different bridges located within Mountrail County on the Federal Bridge Program.

Moved by Comm. Olson, seconded by Comm. Uran, to approve the Road Crossing Permit 519 from Savage Water Solutions on 53rd St NW, located in Section 1 and 12 in Township 154 North, Range 94 West (Unorganized Township) to bore for water. Upon roll call, all present voted yes. Motion carried.

Discussion on park roads on how this should be dealt with and the Commission suggested Engineer Heberlie get on the next park board agenda for the 19th of October.

Engineer Heberlie is struggling with several employees who haven't obtained the Class A or CDL license within the recommended period of time allotted.

Moved by Comm. Olson, seconded by Comm. Jacobson, to formulate a letter to be hand delivered by Comm. Uran to the certain employees that are non-compliant. Upon roll call, all present voted yes. Motion carried.

Alan Ibach, Account Executive of Armour Interactive presented an IT Proposal. Also present was Lori Hanson, Tax Director and Traci Hysjulien, Clerk of Court.

Executive Ibach presented a proposal to manage the IT system and network.

Garrett Volk, current IT Technician presented an IT Proposal.

Technician Volk stated that the County needs a full-time technician on staff due to all the computers. Technician Volk presented a proposal to manage the IT system and network independently.

The Board received letters of support to retain Garrett Volk as the full-time IT from Wade Enget, State's Attorney, Ken Halvorson, Sheriff, Lori Hanson, Tax Director and verbal support from Traci Hysjulien, Clerk of Court.

Dustin Miller and Steve Kemp, Pro IT, LLC presented an IT proposal.

Dustin Miller and Steve Kemp presented an IT Proposal.

Further discussion on the IT proposals will be reviewed on the October 3rd meeting.

Discussion on the 2018 County budget before the final budget on October 3rd meeting.

Moved by Comm. Olson, seconded by Comm. Uran, to approve a raise for the 2018 budget year of 2% per employee for the extra duties which include Superintendent of Schools, Workers Compensation, Coroner, and E911 that are paid to elected or appointed officials. Upon roll call, all present voted yes. Motion carried.
