## Proceedings of the Mountrail County Commissioners

## October 3, 2017

The Board met in regular session on Wednesday at 9:00 A.M. with Commissioners Arlo Borud, Trudy Ruland, Garry Jacobson, Wayne Olson, and Daniel Uran present. Also present was States Attorney Wade Enget, Zach Gaaskjolen and Ann Taylor with Brosz Engineering.

Chairman Borud called the meeting to order.

Moved by Comm. Jacobson, seconded by Comm. Uran, to review and approve the agenda as is. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the Minutes of September 19, 2017 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Jacobson, to approve the bills totaling \$380,450.92 and September payroll, checks #10399-10415 and direct deposit #6801-6948 totaling \$818,769.52. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a temporary basis on the Mountrail County Website @ www.co.mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve the August 2017 fees for the Recorder's Office. Upon roll call, all present voted yes. Motion carried.

Discussion was held on the Oil & Gas Energy Impact Fund (Chapter 57-51-15.1 of the North Dakota Century Code).

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the transfer for Oil & Gas allocations totaling \$2,336,736.85 for current allocations from the General Fund to the County Road & Bridge Fund (70% of Oil & Gas Funds). Upon roll call, all present voted yes. Motion carried.

Discussion was held on changing the Oil and Gas formula in the near future.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the transfer for overweight fines from May 1, 2017 to September 30, 2017 totaling \$49,880.00 from the General Fund to the County Road & Bridge Fund. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the transfer for uniform permits from May 1, 2017 to September 30, 2017 totaling \$997,342.14. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Olson, to appoint Jim Hennessy as the North Dakota State Fair Delegate for Mountrail County. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the raffle permit for the Belden Trail Riders Association from September 23, 2017 to September 24, 2017. Upon roll call, all present voted yes. Motion carried.

Discussion was held on the Computer Professionals Unlimited, Inc. contract. State Attorney Enget suggested adding to the contract that if the contract is terminated the data is the property of the County.

Moved by Comm. Ruland, seconded by Comm. Uran, to table the discussion on the Computer Professionals Unlimited, Inc. contract. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve ending the Mountrail County Soils Board term ending dates on December 31. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to deny the settlement request made by Caron Transportation Systems USA for an overweight fine. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Olson, to approve changing the December 5, 2017 Commissioner Meeting to December 4, 2017. Upon roll call, all present voted yes. Motion carried.

States Attorney Enget updated the Board on the South Complex flood. States Attorney Enget explained that a letter was received from the attorney representing Brosz Engineering, which stated Brosz Engineering will not be taking any responsibility for the flooding at the South Complex. The Board request that Dan Brosz be present at the October 17, 2017 Commissioner meeting.

States Attorney Enget also gave an update on the Ceres Environmental Services arbitration.

Moved by Comm. Olson, seconded by Comm. Jacobson, to approve the Agreement regarding Joint Defense of Ceres Arbitration, and Indemnification by Kadrmas, Lee & Jackson, Inc. (KLJ) in the arbitration with Ceres Environmental Services. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Jacobson, to approve Motion to Compel Interstate Engineering in the arbitration case against Ceres Environmental Services. Upon roll call, all present voted yes. Motion carried.

Lori Hanson, Tax Director, met with the Board to give an update on the September 27, 2017 State Board of Equalization Meeting. Tax Director Hanson stated the State Board of Equalization had to table discussions before Mountrail County was discussed. The discussions will reconvene on October 5, 2017. Tax Director Hanson will be present for the meeting. The States Board of Equalization did not make any changes on the appeals in Mountrail County.

Discussion was held on the appeal made by Fred Evans, Chairman from Brookbank Township. Chairman Evans disputed the use of "break-point" method versus "land-use" method and farm residence exemptions. The State Board of Equalization responded by stating that the local assessor shall apply the following considerations, which are listed in descending order of significance to the assessment determination: soil type and soil classification data from detailed or general soil surveys, the schedule of modifiers that must be used to adjust agricultural property assessments within the county as approved by the state supervisor of assessments under subsection 9, and actual use of the property for cropland or non-cropland purposes by the owner of the parcel. The States Board of Equalization provided to Chairman Evans the website to find the Guide to Assessing Agricultural Land in North Dakota. The guide states that the break point method is the commonly used methodology when determining agricultural property assessments.

Chairman Borud opened the 10:30 A.M. Combination of Auditor and Treasurer's Offices Resolution Hearing. Present for the hearing were Joan Hollekim, Mary Kilen with the Promoter, Clerk of Court Traci Hysjulien, Treasurer Shena Wold, Road & Bridge Engineer Jana Heberlie, Administrative Assistant Mary Trahan, Tax Director Lori Hanson, Head Custodian Karen Babbitt, Deputy Corey Bristol, and Social Services Director Shawna McFarland.

Joan Hollekim stated this matter was not handled properly. Joan Hollekim questioned why the possibility of combining 2 offices was not in any of the Commissioner Meeting minutes. Chairman Borud stated the discussion started when the 2018 budgets were being discussed. Joan Hollekim asked if any other offices were considered for consolidation and if the reduction in force policy was discussed. Stephanie Pappa, Auditor, stated the Auditor's Office has had a decrease in the work load and the part-time employee will be going from 4 days down to 3 days. Joan Hollekim is not in favor of the combination.

Treasurer Wold stated that if the offices were kept separate another employee would need to be hired in the Treasurer's Office. Treasurer Wold suggested adding a Motor Vehicle Department to the Treasurer's Office or moving some duties from the Auditor's Office to increase the work load in the Treasurer's Office.

Clerk of Court Hysjulien suggested that marriage licenses and passports could be transferred to the Treasurer's Office. Clerk of Court Hysjulien suggested the position be appointed and not elected. Clerk of Court Hysjulien is not in favor of the combination.

Tax Director Hanson is not in favor of the combination.

Stephanie Pappa, Auditor, explained that when Treasurer Wold was instructed by the Board to add a Deputy position, Treasurer Wold stated there was not enough work to keep Treasurer Wold busy at times. Treasurer Wold does not remember stating this.

Jana Heberlie, Road & Bridge Engineer, met with the Board to discuss issues with the Road & Bridge Department along with Mary Trahan, Administrative Assistant.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the final pay application to Gratech Company, Ltd. in the amount of \$6,206.17 for rip rap on Old Hwy 2. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the final pay application to Central Specialties, Inc. in the amount of \$75,783.91 for the Tagus reconstruction and paving project. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve and sign the Addendum to Contract for Central Specialties Inc. for the Plaza construction final repairs. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the Construction and Maintenance Agreement with the NDDOT for the 3.830 mile missile road in-slope repair. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Ruland, seconded by Comm. Olson, to approve the request made by Troy Jacobson for unpaid time off. Upon roll call, all present voted yes except Comm. Jacobson did not take part in the discussion or vote. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the Amendment to the Agreement to Crush/Purchase Stockpile Aggregate. Upon roll call, all present voted yes. Motion carried.

Discussion was held on the NDACo Delegate Council meeting materials.

Discussion was held on the CDL requirements at the Road & Bridge department.

States Attorney Enget stated a call was received about skateboarding at the Memorial Building. States Attorney informed the Board that Head Custodian Babbitt was instructed to order signs for the Memorial Building, Courthouse, and the South Complex.

Moved by Comm. Jacobson, seconded by Comm. Uran, to accept the Final Budget for Mountrail County for the 2018 year in the amount of \$85,874,994. Said budget is on file in the County Auditor's Office and spread upon the Minutes of this meeting. Upon roll call, all present voted yes. Motion carried. (Budget at end of Minutes)

Discussion was held on the IT department and the need for a ticket system. Garrett Volk, IT Administrator was also present.

Shawna McFarland, Social Services Director, met with the Board to request the General Fund be reimbursed by the Social Service Fund in the amount of \$400,000 for a transfer from October 2016 reverting back due to not needing the funds for the 2017 year.

Moved by Comm. Ruland, seconded by Comm. Uran, to approve the transfer from the Social Service Fund to the General Fund in the amount of \$400,000. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Jacobson, to approve the letter to the Burleigh County Clerk of Court to request that an order be amended for attorney fees. Upon roll call, all present voted yes. Motion carried.

Comm. Ruland gave an update on the Western Dakota Energy Association city vs. county study.

Karen Babbitt, Head Custodian was present for discussions on the one year walk through for the new jail facility will be on October 17, 2017 at 1:00 P.M. Head Custodian Babbitt also gave an update on the South Complex leaking issue.
