Lynn Flaten met with the Board to discuss an overweight fine on College Drive in New Town. States Attorney Enget presented pictures of signs that are posted on College Drive that read "No Unauthorized Truck Traffic" and "No Trucks over 20,000 lbs. gross weight". Lynn Flaten stated the driver is having financial troubles and was probably distracted and did not see the signs. Comm. Ruland asked if this was the first time loading in the area. Lynne Flaten stated it was not the drivers first time. Comm. Borud stated that if the truck driver was so distracted the driver should not be driving. Comm. Ruland stated drivers have an opportunity to turn around and this road was not built for the heavy weight. Comm. Ruland stated this is a residential area and there are signs at both ends of the street. Comm. Uran stated this has been an ongoing problem in New Town and the citizens have requested more policing of these roads at city council meetings.

Moved by Comm. Ruland, seconded by Comm. Uran to keep the overweight fine as is for Flaten Trucking on College Drive in New Town. Upon roll call, all present voted yes. Motion carried.

Chairman Borud opened the 9:30 A.M. hearing to receive comments on Tax Deed Appraisal of land taken by the County, October 2, 2017 under Tax Deed Action. No one from the public appeared.

Moved by Comm. Ruland, seconded by Comm. Olson, to approve the appraisal values and set the tax deed sale for November 21, 2017 at 10:00 A.M. Upon roll call, all present voted yes. Motion carried.

Geoff Simon with Western Dakota Energy Association met with the Board to discuss the Gross Production Tax Change Study and Interim Legislative Committee Support. The study is focusing on the hub cities. The tasks specific to the County are road investments, public safety/law enforcement, property taxes and gross production taxes, and future energy impacts. Geoff Simon stated the county's cost to be a part of the study would not exceed \$7,500. Geoff Simon stated 2019 might be a tough year and the study will allow for a more cohesive approach.

Moved by Comm. Ruland, seconded by Comm. Uran, to support Western Dakota Energy Association and to be a part of the Gross Production Tax Formula Change Study. Upon roll call, all present voted yes. Motion carried.

Garrett Volk, IT Administrator, presented an IT proposal to the Board. Present for the discussion was Lori Hanson, Tax Director; Traci Hysjulien, Clerk of Court; Corey Bristol, Deputy; and Shawna McFarland, Social Services Director.

The Board had requested that the website maintenance be removed and an extra day be added to the original proposal that IT Administrator Volk had presented at the September 19, 2017 meeting. IT Administrator Volk stated the cost for 2 day would be \$6,000 per month and an extra day would be \$500 per day. IT Administrator Volk stated mileage would not be an extra charge. Social Services Director McFarland stated all of the programs at Social Services are internet based and it would be nice to have someone 5 days a week. Clerk of Court Hysjulien asked the Board how this issue came about. Comm. Ruland stated the County is getting less money from the state and the Board is looking at all options and all budgets. IT Administrator Volk stated GIS requests will still be handled. The Board felt it was necessary to include all employees input before moving forward.

Comm. Ruland requested Administrator Volk create email accounts for all of the commissioners.

IT Administrator Volk presented a quote for IPads for the commissioners.

Laurie Johnson, Jail Administrator, met with the Board to give an update on the jail facility.

Mental health issues were discussed and how utilizing the current staff has helped also present for the discussion was Social Services Director McFarland and States Attorney Enget.

Jail Administrator Johnson gave an update on training.

Discussion was held on contract with the City of New Town for boarding inmates.

Jail Administrator informed the Board that there is an amendment to the Food Service Contract due to inmate meal counts falling below the contracted scale pricing.

Moved by Comm. Ruland, seconded by Comm. Olson, to approve Amendment 1for CBM Managed Services for the Food Service Contract. Upon roll call, all present voted yes. Motion carried.

Discussion was held on jail staffing.

Mary Trahan, Administrative Assistant, met with the Board to discuss Road & Bridge issues.

Moved by Comm. Olson, seconded by Comm. Ruland, to approve Change Order 2 in the amount of \$19,657.70 to Rachel Contracting Inc. on Old Hwy 2 for seeding. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve the Annual Maintenance Certification for County Federal Aid Projects. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve awarding the preliminary and construction engineering to Sauber Engineering for the Full Depth Reclamation of Old Hwy 2 from Palermo to Blaisdell. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve awarding the preliminary and construction engineering to Sauber Engineering for the replacement of the Lostwood Bridge with a precast reinforced concrete box culvert. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Olson, seconded by Comm. Uran, to approve the request made by White Earth Township for 3,000 yards of gravel. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve changing the speed limit on Old Hwy 2 from Ward County to Blaisdell to 45 mph with a weight restriction of by legal weight 105,500 lbs. max. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve changing the speed limit on CR 9 from Hwy 2 to the City of White Earth to 55 mph with a weight restriction of by legal weight 105,500 lbs. max. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the salary increase for Troy Jacobson from the Road & Bridge Department totaling \$4,570 per month effective November 1, 2017 for successful completion of probationary period. Upon roll call, all present voted yes except Comm. Jacobson did not take part in discussion or vote. Motion carried.

Discussion was held on the Township Assistance Budget.

Don Longmuir from Planning & Zoning met with the Board to inform the Board that the Dakota Access Pipeline donated \$20,000 to the Disaster Emergency Department.

Dan Brosz and Zach Gaaskjolen from Brosz Engineering met with the Board to discuss issues with road projects and the flood at the South Complex.

States Attorney Enget stated that on the 53rd St NW project, Terry Lukan changed the agreement with the landowner after specifically being told by the Board not to change anything. States Attorney Enget stated this will always be an issue now.

Administrative Assistant Trahan presented a list of issues below to the Board.

- 1) CR 10, 53rd St NW, project the wetland mitigation was not finalized, the landowner agreement was changed, utility relocation was not coordinated effectively resulting in an extra \$15,000 cost to the county, erosion control issues, and there were safety issues during the construction.
- 2) CR 2 project from Old Hwy 2 to Palermo the rip rap failed in less than a year and not enough rock was used causing the fabric to not stay in place.
- 3) CR 2 project from Ward County to Blaisdell the estimates for preliminary and construction engineering totaled \$19,000 but the cost to date is \$163,197.50. Administrative Trahan stated the County did double the scope of work and added 1 culvert. Zach Gaaskjolen stated this issue was due to the Air Force changes and a good estimate was not given to the county.
- 4) CR 1 and CR12 Plaza project Brosz Engineering advised the County that the project was ready for final acceptance but foreign material was found under the asphalt an there were holes in the intersection where foreign material was found, 2 approaches were not built to spec resulting in the project still being open.
- 5) Administrative Trahan stated multiple requests have been made to Brosz Engineering for the road records and the Road & Bridge Department is still missing some records.

Dan Brosz stated Brosz Engineering could absorb some of the costs and landowners are always a concern on every road project.

Discussion was held on the 2 floods at the South Complex.

Dan Brosz stated that Brosz Engineering is in a tough spot by being engineers for both the County and the City of Stanley. Dan Brosz stated the flood will be looked into.

Chairman Borud stated the County is not getting quality work for what is being paid for. Dan Brosz stated Brosz Engineering has completed quality work in the past on other projects with the County and will work harder in the future.
