Vets Officer Wing stated Lisa Lapica has worked for 15 years alongside. The accreditation would take place as the Veterans Service Officer once Lisa Lapica is hired as the Veterans Service Officer position. The Commissioner of Veterans Affair gave three different options of hiring for the Veterans Service Officer. States Attorney Wade Enget spoke concerning N.D.C.C 37-14-18 all three requirements would need to be fulfilled before moving forward with the hiring process.

11:00 A.M.

Jana Hennessy, Engineer met with the board to discuss road and bridge. Also present was Joel Wilt and Bill Gathman with NDDOT; Joel Myers, Dan Vander Voste and Craig Mizera with HDR; Zach Gaaskjolen with Brosz Engineering; Jeff Wright with Sauber Engineering; Eli Black with Triple Aggregate.

Engineer Hennessy met with the board to discuss a turning lane on Highway 23 to turn off on 83rd Ave NW and Joe Wilt with NDDOT and no representation from Slawson Exploration Company. Joe Wilt with NDDOT spoke stating no reimbursement from NDDOT if the turning lane is put in by Slawson Exploration ahead of time. Joe Wilt stated the site distance is not good even with the turning lane. Joe Wilt stated would be better to rebuild the Van Hook Road CR 15 and utilize that. Comm. Ruland and Comm. Uran stated that it's not a good thing to mix recreation with oil field on the Van Hook Road CR 15. Joe Wilt stated the turning lane would put it on the priority list which could take up to 5 years to build. Joe Wilt stated the State could put signage at the location also.

Discussion on the proposals and different options from Sauber, Brosz and HDR Engineering Companies on the road improvements on 96th Ave NW. Charlie Sorenson with Debing Township stated the top priority is the drainage and stability of the road. Comm. Ruland stated if this goes forward all entities would need to participate with the cost of rebuilding. The next step would need to be a conjoined meeting with the townships, county and oil companies to go forward with the rebuild of 96th Ave NW the proposal from Brosz Engineering will be discussed at the meeting.

Max Schriock with Aggregate Construction, Inc. met with the board to discuss a haul route proposal with the rebuild of Highway 1804 with the NDDOT. The closest pit is located at Old Scenic Highway and 54th St NW and is wanting to increase the load limit by legal weight and also to lift the 30 ton bridge along the route. Comm. Ruland requested if it would be able to be moved out in the winter and stage the material somewhere else. Max Schriock stated that the material could change if stockpiled so doesn't recommend doing that. The Commission decided this would be treated the same way as prior agreements with the cash bond etc. Aggregate Construction will come back to the board if received the bid from NDDOT.

Discussion on Carstensen Contracting and the refund for the permit application fee of non-refundable fee of \$6,000 that was not refunded with the original \$120,000 from the Commissioner meeting on October 16, 2018. Brad Carstensen spoke concerning only utilizing 30 permits rather than the 60 permits that previously was submitted. Brad Carstensen stated would like the 30 permits that weren't utilized to be refunded. Engineer Hennessy stated the 30 locations were entered in the data base but no physical activity for pre and post inspection was done for these 30 permits.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the non-refundable amount of \$4,000 back for the permits not utilized. Upon roll call, all present voted yes except for Comm. Ruland who voted no. Motion carried.

Discussion on CR 9, 101st Ave NW and the final review and approval of the proposed design with HDR. Craig Mizera, Dan Vander Vorste, and Joey Myers with HDR gave an update and status on CR 9, 101st Ave NW. Discussion was whether to go with option 1 to complete in 2019 or option 2 to complete in 2020.

Moved by Comm. Uran, seconded by Comm. Ruland, to approve going forward with option 2 to complete in the 2020 on CR 9, 101st Ave NW. Upon roll call, all present voted yes. Motion carried.

Discussion on when the bid letting would be best if around the early March or end of February.

Joe Myers with HDR gave an update on the Construction Engineering. Craig Mizera also discussed Phase II with CR 9.

Discussion on the resolution for Project BRO-0031(057) to construct a bridge in Cottonwood Township and award the project to Central Specialties Inc.

Moved by Comm. Ruland, seconded by Comm. Olson, to approve the Resolution from Project BRO-0031(057) to award the project to Central Specialties, Inc. Upon roll call, all present voted yes except Comm. Jacobson who voted no. Motion carried.
