#### PROCEEDINGS OF THE MOUNTRAIL COUNTY COMMISSIONERS

#### November 18, 2014

The Board met in regular session on Thursday at 9:00 A.M. with Commissioners Greg Boschee, Garry Jacobson, Colleen Reese and Trudy Ruland present. Commissioner Arlo Borud was absent. Also present were Dave Leftwich with NDDOT and Rory Nelson with the Governor's Office.

Vice-Chairman Boschee called the meeting to order.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to approve the Minutes of the November 6, 2014 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Jacobson, to approve the payment of bills totaling \$944,231.12. Upon roll call, all present voted yes. Motion carried. (A complete list of bills is posted on a regular basis on the Mountrail County Website @ www.co.mountrail.nd.us under the County Commissioner's heading.)

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the October Sheriff fees. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Reese, to approve Permit #205 authorizing EOG Resources, Inc. to cross county road/ section line referred to as 74<sup>th</sup> Ave NW, between Sections 34 and 35, Township 156 North, Range 90 West (Palermo Twp). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Reese, to approve Permit #206 authorizing EOG Resources, Inc. to cross county road/ section line referred to as 51<sup>st</sup> ST NW, between Sections 15 and 22, Township 154 North, Range 90 West (Austin Twp). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve a Full-time Employee Agreement for Heather Greenlee at a starting salary of \$3,334 per month for the position of Clerk in the Auditor's Department. Upon roll call, all present voted yes. Motion carried.

Reese, to approve 2 transfers for prior oil and gas allocations totaling \$2,022.42 from Infrastructure Fund to General Fund as presented by Treasurer Shena Wold and in accordance to Section N.D.C.C. 57-51-15(5a). Moved by Comm. Jacobson, seconded by Comm. Reese, to approve 3 transfers totaling \$3,146,499.43 from General Fund to County Road & Bridge Fund (80% of Oil & Gas Funds). Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve a Part-time Employee Agreement for Heather Grihorash at a starting wage of \$19.23 per hour for the position of Administrative Assistant in the Social Services Department. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Jacobson, to hold a Public Hearing on Tuesday, December 16, 2014 at 10:00 A.M. in the Community/Commissioner's Room located on the second floor of the Mountrail County Courthouse, 101 North Main Street, Stanley, North Dakota, for the purpose of receiving comments on a zoning amendment request filed by Dakota Access, with concurrence from landowner Jean M. Nelson, to the Mountrail County Zoning Map to rezone a 20 acre, more or less, tract of land described as the E½NW ¼NW¾ of Section 35, Township 156 North, Range 91 West (Idaho Township) from agricultural to industrial for purpose of accommodating a crude oil facility and substation. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Jacobson to accept the letter from Idaho township relinquishing rights to 61<sup>st</sup> St NW from highway 8 to 83<sup>rd</sup>/South Bypass and for the county to take over jurisdiction and accept 3 miles of the following township roads under the County Road System effective 11-18-2014.

- 61<sup>st</sup> St NW from Highway 8 (2 miles)
- 83<sup>rd</sup> Ave NW to Highway 2 (1 mile)

Moved by Comm. Reese, seconded by Comm. Ruland, to change next commissioners meeting to Monday, December 1, 2014. Upon roll call, all present voted yes. Motion carried.

Robert Harms with Plains Marketing, Steve Blenker with Amerigas, Perry Byers with Byers Enterprises LLC., Beau Hill and Jennifer Yu with EOG Resources and Edith McNamara were all present for the hearings.

Chairman Boschee opened the 9:10 A.M. public hearing to receive comments on the zoning amendment request filed by Plains Pipeline, with concurrence from landowner Lucinda Biladeau, to rezone a 10 acre, more or less tract of land in Crane Creek Township from agricultural to industrial to allow for 150,000 barrel crude oil storage tank.

Administrator Longmuir presented information from the October 27, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by Plains Pipeline.

Moved by Comm. Jacobson, seconded by Comm. Reese, to approve the request of Plains Pipeline, with concurrence from landowners Lucinda Biladeau, for an amendment to the Mountrail County Zoning Ordinance to rezone a 10.00 acre, more or less, tract of land described as an Outlot 3 of the E½NW¼ of Section 23, Township 153 North, Range 91 West (Crane Creek Township)from agricultural to industrial to allow for 150,000 barrel crude oil storage tank in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their October 27, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Boschee opened the 9:20 A.M. public hearing to receive comment on the zoning amendment request filed by Amerigas, with concurrence from landowner BNSF, to rezone a 0.95 acre, more or less tract of land in Palermo Township from agricultural to industrial to allow for installation of a propane tank and fencing.

Administrator Longmuir presented information from the October 27, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by Amerigas.

Moved by Comm. Ruland, seconded by Comm. Reese, to approve the request of Amerigas, with concurrence from landowners BNSF, for an amendment to the Mountrail County Zoning Ordinance to rezone a 0.95 acre, more or less, tract of land described as NE¼SW¼NE¼ of Section 15, Township 156 North, Range 90 West (Palermo Township)from agricultural to industrial to allow for a propane tank and fencing in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their October 27, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Boschee opened the 9:30 A.M. public hearing to receive comment on the zoning amendment request filed by Perry Byers, with concurrence from landowners Conrad and Sherry Varnum, to rezone a 4.95

acre, more or less tract of land in Osborn Township from agricultural to industrial to include four 1800 gallon storage tanks for the purpose of accommodating a commercial waste disposal site.

Administrator Longmuir presented information from the October 27, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by Perry Byers.

Ruland, to approve the request of Perry Byers, with concurrence from landowners Conrad and Sherry Varnum, for an amendment to the Mountrail County Zoning Ordinance to rezone a 4.95 acre, more or less, tract of land described as Sublot B of Outlot 1 of the NE½NE½ of Section 29, Township 152 North, Range 92 West (Osborn Township)from agricultural to industrial to allow for 1800 gallon storage tank for the purpose of accommodating a commercial waste disposal site in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their October 27, 2014 meeting. Stipulation of including a berm containment in case of a spill was put forth from the Board. Upon roll call, all present voted yes. Motion carried.

Chairman Boschee opened the 9:40 A.M. public hearing to receive comment on the zoning amendment request filed by EOG Resources, with concurrence from landowner Ehlert Enterprises, to rezone a 36.469 acre, more or less tract of land in Wayzetta Township from agricultural to industrial to allow for purpose of expanding an existing storage facility.

Administrator Longmuir presented information from the October 27, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended approval of the zoning amendment filed by EOG Resources.

Moved by Comm. Reese, seconded by Comm. Ruland, to approve the request of EOG Resources, with concurrence from landowners Ehlert Enterprises , for an amendment to the Mountrail County Zoning Ordinance to rezone a 36.469 acre, more or less, tract of land described as Outlot 2 and Outlot 3 of the NE½SW¼ of Section 26, Township 153 North, Range 90 West (Wayzetta Township)from agricultural to industrial to allow for expansion of an existing storage facility in accordance with regulations set forth in the Mountrail County Zoning Ordinance and as recommended by the Mountrail County Planning Commission at their October 27, 2014 meeting. Upon roll call, all present voted yes. Motion carried.

Chairman Boschee opened the 9:50 A.M. public hearing to receive comment on the zoning amendment request filed by Iron Horse, with concurrence from landowner Jack Fladeland, to rezone a 9.50 acre, more or less tract of land in Crane Creek Township from agricultural to industrial to allow for a water depot and a shop. Edith McNamara was present to oppose.

Administrator Longmuir presented information from the October 27, 2014 public hearing of the Planning & Zoning Commission. The Planning and Zoning Commission recommended tabling the zoning amendment filed by Iron Horse.

Edith McNamara stated that there was no legal access to the property and she was opposed to taking water from the aquifers.

Moved by Comm. Ruland, seconded by Comm. Jacobson to table the request and send back to the Planning & Zoning Commission with improvements. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to accept high bids for the purchase of county-owned property as follows: \$1,931 received from Wayne Johnson for the purchase of Lot 2, Section 34, Township 157, Range 91; \$2,204 from Connie Clouse for the purchase of Lot 7, Block 2, Olson's Addition, New

Town City; \$5,200 from Connie Clouse for the purchase of Lot 2, Block 2, Subdivision of portion of Block 2, Original Townsite, New Town City; and \$100 from Darin Powell for the purchase of Block 12, Original Townsite East 10 feet of the West 40 feet of Lot 17, Plaza City. Upon roll call, all present voted yes. Motion carried.

Jana Heberlie, County Engineer, met with the Board to discuss matters dealing with the County Road & Bridge Department.

Engineer Heberlie and Marshall Craft from Purcell Township were present to update the Board on a grade raise and rip rap project on 79<sup>th</sup> Ave NW which was done by Knife River. Engineer Heberlie stated that the requirements were not met on the project. It was recommended by Dave Leftwich from the North Dakota Department of Transportation to contact the ND Insurance Reserve fund for suggestions.

Moved by Comm. Reese, seconded by Comm. Ruland, to not pay Knife River until the road is fixed. Upon roll call, all present voted yes. Motion carried. Evan Powers from Knife River was present, stated he will be in contact with Engineer Heberlie to resolve the specification requirements. Upon roll call, all present voted yes. Motion carried.

Engineer Heberlie updated the Board concerning, Manitou North/93<sup>rd</sup> and 91<sup>st</sup> Ave NW (CR7), Apex Engineering with the removal of the rocks on the right of way. Complaints have been made concerning the rocks being placed on private property without permission, Engineer Heberlie is looking into the situation.

Engineer Heberlie updated the Board on the findings of the Uniform Truck Permit Meeting that was attended on November 12<sup>th</sup>. A pilot project will be complete by the end of December 2014.

Engineer Heberlie presented to the Board to sign all 2015 Road Maintenance agreements with Townships along with Van Hook Township for the 2015 year for the uniform county truck permitting program.

Moved by Comm. Reese, seconded by Comm. Ruland, to bid on a new blade since warranty has expired on the 09 Cat 140M. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Jacobson, seconded by Comm. Ruland, to offer Pete and Joella Westgard, \$10,000 an acre for land for a future Plaza shop. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Reese, seconded by Comm. Ruland, to give permission for Engineer Heberlie to draw up an agreement for future assistance with installation of culverts. A letter from Idaho Township was presented to the Board requesting assistance with installation so will be tabled until next meeting. Upon roll call, all present voted yes. Motion carried.

Wade Enget, State's Attorney, met with the Board to discuss the case filings and give an update on the comparisons from 2004 to 2014.

Moved by Comm. Reese, seconded by Comm. Ruland, to offer a single policy employees vision insurance. Upon roll call, all present voted yes. Motion carried.
