The **Township** of _____ hereby requests assistance on township road(s) with the purchase and installation of traffic posts and signs. At this time Mountrail County will assist with the purchase and installation of STOP and/or YIELD traffic signs only. Mountrail County will purchase and install MUTCD compliant signs and the **Township** agrees to reimburse Mountrail County for **50% of the cost of the sign materials (signs, posts, and anchors)**. On behalf of the **Township, Mountrail County** agrees to provide the labor and install of traffic signs at: **no cost to the township**, all charges to be paid within 30 days after receiving an invoice from Mountrail County. The **Township** understands that Mountrail County Road and Bridge Department reserves the right to accept or reject any and all requests.

Township shall follow MUTCD (Manual on Uniform Traffic Control Devices) standards and guidance: <https://mutcd.fhwa.dot.gov>, specifically 2009 Edition Chapter 2B for Regulatory Signs: <https://mutcd.fhwa.dot.gov/htm/2009/part2/part2b.htm>

After the installation is complete, the **Township** will hold **Mountrail County harmless** from any liability for this road signs assistance project.

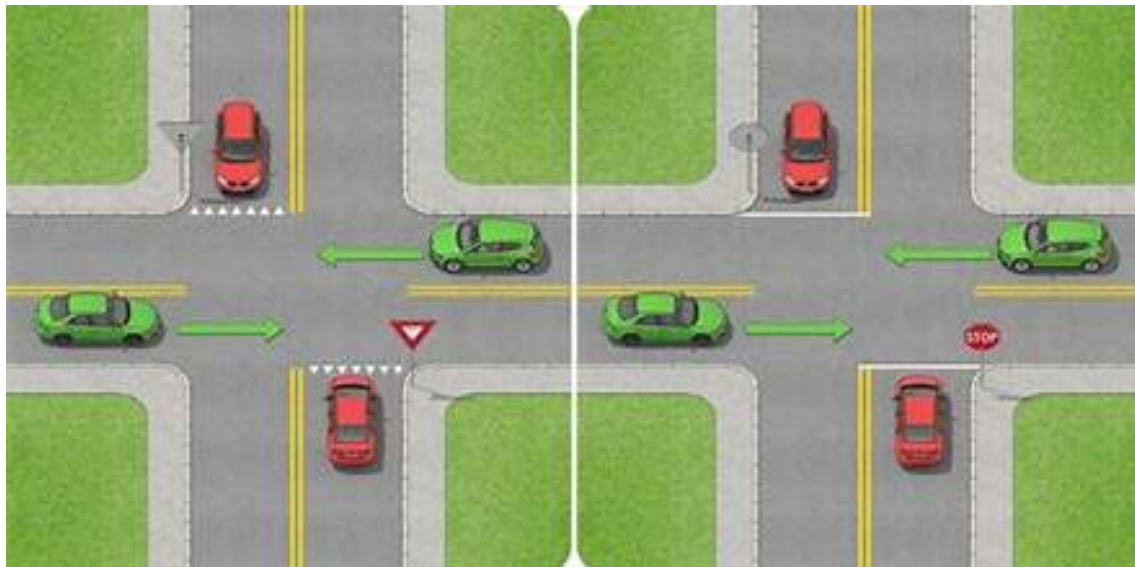
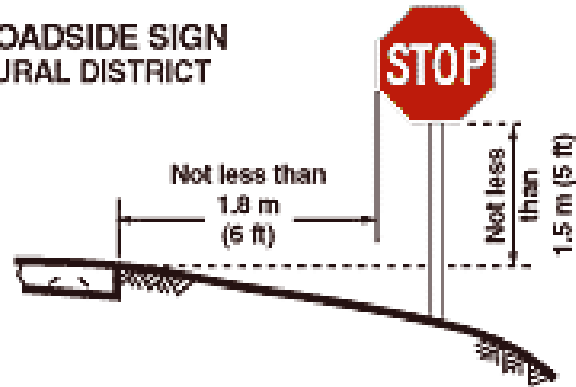
