No officer or employee of such person retained by the **Township** shall have any financial or other personal interest in any real property acquired for the project unless such interest is openly disclosed upon public records of the **Township**, and such officer, employee, or person has not participated in such acquisition for and in behalf of the **Township**.
- 5. Township fully understands the **County** is only providing assistance for said township project and **Township** agrees to assume all responsibility of this project on the township road described above or any impacts related to this project and hold the **County** harmless during the construction of said project and for any future improvements or obligations on said township road described in this agreement.
