1. OPENING & ROLL CALL

The Board met in regular session on Tuesday, August 2, 2022 at 9:00 A.M. in the Emergency/Community Room, Mountrail County Courthouse, Stanley ND with Commissioners Joan Hollekim, Jason Rice, Wayne Olson, Trudy Ruland, and Daniel Uran present. Absent was State's Attorney, Wade Enget.

Chairman Ruland called the meeting to order.
