I understand that JAH Królik Farm, the breeder of the pet or market rabbit, will transfer ownership of the pet or market rabbit directly to me and/or my child and that the Fort Berthold 4-H and/or Mountrail County 4-H Youth Development Program, including its directors, employees, volunteers and representatives, make no representations or warranties with regard to the pet or market rabbit and will have no responsibility whatsoever for the health or condition of the pet or market rabbit.

I knowingly and freely assume all risks, both known and unknown, inherent to owning a pet or market rabbit and I, on behalf of myself, my child, my heirs and next of kin, do hereby expressly forever release, indemnify and hold harmless the North Dakota State University Extension Service, the Mountrail County 4-H Youth Development Program, its directors, employees, volunteers, leaders and sponsors (“Releasees”) with respect to any and all injury, disability, death, or loss or damage to person or property arising out of or related to my child’s participation or the selection of my child as the winner in the “**BUNNIES FOR BUDDIES**” competition, including my child’s use and care for the pet or market rabbit. **This promise applies even to claims based on Releasees’ negligence and or gross negligence, to the extent authorized by law.**

I grant Releasees full permission to use images, recordings, or any other record of the event in any medium. I will comply with stated and customary rules for participation. Event staff may terminate any participation due to conduct s/he deems inappropriate. The entry fee is non-refundable and non-transferable.
