D. TRANSFER

Moved by Comm. Hollekim, seconded by Comm. Jacobson, to approve the transfer from Oil and Gas allocation totaling \$903,743.52 for current allocations from the General Fund to the County Road & Bridge Fund (70% of Oil & Gas Funds). Upon roll call, Olson, Hollekim, Jacobson, Ruland and Uran voted yes. Motion carried.

E. PAYROLL

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve the elected official employee agreement for Jason Rice with the Commissioners in the amount of \$2,480 per month/\$29,760 per year. Upon roll call, Hollekim, Ruland, Olson, Jacobson and Uran voted yes. Motion carried.

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve the temporary employee agreement for Richard (Derick) McCloskey with the County Buildings Department as a facilities technician in the amount of \$19.038 per hour not to exceed 40 hours per week/280 hours per year. Upon roll call, Uran, Jacobson, Olson, Hollekim and Ruland voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve the temporary employee agreement for Rigoberto Vergara with the Corrections as a Correctional Officer in the amount of \$21.418 per hour with the dates beginning 11-19-2020 and ending 1-31-2021, not exceeding 40 hours per week. Upon roll call, Ruland, Jacobson, Olson, Uran and Hollekim voted yes. Motion carried.

F. UNORGANIZED TOWNSHIP BALANCES & LEVIES

The Commissioners reviewed the 2020 balances for the Unorganized Townships and the 2020 mill levy numbers. Jana Hennessy, Engineer discussed that the revenues for Unorganized Townships Load Pass comes back as a grand total amount. Comm. Ruland discussed decreasing the levies for some of the unorganized townships for the 2020 tax year/2021 budget year. Wade Enget, State's Attorney stated the levies would be able to be lowered.

Moved by Comm. Hollekim, seconded by Comm. Uran, to approve lowering to 0 mills for Unorganized Township 150-92 effective for 2020 tax year/2021 budget year. Upon roll call, Jacobson, Ruland, Uran, Olson and Hollekim voted yes. Motion carried.

Moved by Comm. Hollekim, seconded by Comm. Uran, to approve lowering to 0 mills for Unorganized Township 150-93 effective for 2020 tax year/2021 budget year. Upon roll call, Hollekim, Jacobson, Ruland, Uran, and Olson voted yes. Motion carried.

Moved by Comm. Hollekim, seconded by Comm. Uran, to approve lowering to 0 mills for Unorganized Township 152-93 effective for 2020 tax year/2021 budget year. Upon roll call, Olson, Hollekim, Jacobson, Ruland, and Uran voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Olson, to approve lowering to 0 mills for Unorganized Township 153-93-effective for 2020 tax year/2021 budget year. Upon roll call, Uran, Olson, Hollekim, Jacobson, and Ruland voted yes. Motion carried.

Discussion was held on the road projects specifically 96th Ave NW with all expenses, excluding Rat Lake and Debing Township's share, being paid out of the Unorganized Township 154-94 and 155-94 Funds . Comm. Ruland stated not all the townships were totally expected to take on the full payment for the 96th Ave NW road project. Comm. Ruland states that the County should assume some of the cost on 96th Ave NW road project. More discussion will be held on the negative balances and if Unorganized Townships 154-94 and 155-94 will need further assistance with the balances. The levies for Unorganized Township 154-94 and 155-94 will remain at 18 mills for the 2020 tax year/2021 budget year.

3. APPOINTMENT SCHEDULED

9:30 A.M.

Lori Hanson, Tax Director met with the board for abatement hearing on parcel #16-0020101 for a reduction in value for tax year 2019. Tax Director Hanson recommended doing a part reduction with the land going from \$17,300 to \$7,300 and the building value from \$51,600 to \$57,200 for a total true and full value being \$64,500 instead of \$68,900. Chris Miller was also present and stated the structure is a mobile home and he paid \$40,000 for the property. Tax Director Hanson stated some of the properties in Blaisdell do need to be re-evaluated. Discussion was held on the values for Mr. Miller's property. McGahan Township's recommendation is to deny the abatement. Tax Director Hanson will go out to the property and measure the structures before the next Commissioner meeting.

Moved by Comm. Hollekim, seconded by Comm. Olson, to table the abatement on parcel #16-0020101 for the 2019 year until the December 15, 2020 meeting. Upon roll call, all present voted yes. Motion carried.

9:32 A.M.

Lori Hanson, Tax Director met with the board for abatement hearing on parcel #16-0020101 for a reduction in value for tax year 2020.

Moved by Comm. Hollekim, seconded by Comm. Olson, to table the abatement on parcel #16-0020101 for the 2020 year until the December 15, 2020 meeting. Upon roll call, all present voted yes. Motion carried.

9:35 A.M.

Lori Hanson, Tax Director met with the board for abatement hearing on parcel #61-0081300 for an exemption as a parsonage for four months out of the year. Tax Director stated the last few years this property has not been used as a parsonage. Matt Evans, President of Bethlehem Lutheran Church discussed the house being empty for several months until the Pastor was on board.

Moved by Comm. Uran, seconded by Comm. Hollekim, to approve the abatement on parcel #60-0081300 for the 2020 year for four months of the year being exempted as recommended by Tax Director Hanson. Upon roll call, Hollekim, Olson, Jacobson, Ruland and Uran voted yes. Motion carried.

9:40 A.M.

Stephanie A. Pappa, Auditor met with the board to discuss the purchase of a new copy/scanner/printer machine. Auditor Pappa supplied the two quotes from Advanced Business Methods and Clute Office Equipment. Auditor Pappa recommended going with Advanced Business Methods due to the maintenance agreement being a monthly charge instead of the per copy charge with Clute Office Equipment.

Moved by Comm. Olson, seconded by Comm. Uran, to approve purchasing a new copy/scanner/printer machine from Advanced Business Methods in the amount of \$10,933.60 due to maintenance contract. Upon roll call, Jacobson, Uran, Olson, Hollekim and Ruland voted yes. Motion carried.

9:45 A.M.

Corey Bristol, Sheriff met with the board to discuss the radios. Comm. Hollekim is wondering if any money is left for the funding for the cities for the emergency radios. The Commissioners discussed the monies left over could be possibly utilized for the cities. Sheriff Bristol stated he doesn't want this to be a wish list for the cities. Sheriff Bristol would evaluate the budgets in regards to the radios and meet with the Board at their next meeting to further discuss the County assisting with radio upgrades. Sheriff Bristol discussed purchasing an SUV due to getting a dog next year. The Commission had no objections to obtaining quotes for an SUV and presenting them at their next meeting since the monies are in the 2020 budget for the Sheriff's office.

10:00 A.M.

Jana Hennessy, Engineer met to discuss Road & Bridge. Also present were Ryan Farden, Zach Gaaskjolen and Craig Mizera.

1. CR18-UTILITIES IN COUNTY ROW

Engineer Hennessy discussed the installation of a sewer force main system to tie into the City of Stanley's sewer system that is north of parcel 61-0053661 which is located in ROW by 61st St NW/CR 18. Duane Haugen with Kemper Construction discussed the direction and the manhole being utilized to install the sewer.

Moved by Comm. Olson, seconded by Comm. Hollekim, to approve signing the Memorandum of Agreement with DSI and Kemper Construction along with the City of Stanley to install a sewer line in the ROW on 61st St NW/ CR 18 subject to defining a specific location in the MOA and the County not being responsible for any reclamation costs. Upon roll call, all present voted yes. Motion carried.

2. 96th AVE NW-FENCING ISSUE

Engineer Hennessy discussed the issues with fencing in the ROW on 96th Ave NW. Several landowners have the wrong fencing materials and/or also located in the Right of Way. Jeff Ruud, Chairman of Rat Lake Township and Charlie Sorenson, Chairman of Debing Township were present and discussed the un-necessary fencing and gates installed inappropriately. Also present were Zach Gaaskjolen, Jeff Ebsch and Ann Taylor with Brosz Engineering. Zach Gaaskjolen, Brosz Engineering, discussed the budget allocated for the project and to try and keep the lower cost without buying additional right of way. Discussion was held on the lack of communication with the landowners and engineers. Ann Taylor with Brosz Engineering stated the 4 wire red brand barb wire is not being installed due to the same manufacture being utilized and meeting the DOT standards. Ryan Farden with Farden Construction stated would be a change order of \$85,780 to relocate the fence already installed or partially installed. Ann Taylor with Brosz Engineering stated Farden Construction was asked to stop and move north to finish the fencing there. The subcontractors stated they would not use the fence materials currently in place and would purchase all new materials for the fence. Comm. Uran discussed the old material be left with the County since it has been paid for already. The change order will be looked at on the December 15th meeting but the fence that hasn't been installed will be able to keep going forward.

3. CR 19

Engineer Hennessy discussed the bids for CR 19 and stated that the Baranko Brothers was the lowest bidder at \$4,173,538. Craig Mizera with HDR Engineering gave an update on the 404 permit with the Corp of Engineers.

4. ROM – 0300(139) AGREEMENT

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve signing the Cost Participation, Construction and Maintenance Agreement with the NDDOT for ROM-0300(139) Minuteman Missile Project consisting of gravel surfacing, inslope repair and culvert repair for various locations at no cost to Mountrail County. Upon roll call, all present voted yes. Motion carried.

5. MWEC

Engineer Hennessy discussed an invoice received from Mountrail Williams Electric for moving poles on 101st Ave NW road project. Chris Meiers with MWEC wrote an email with the explanation on why the extra cost compared to the estimate. The one landowner did not want an overhead line so an underground line was installed which is more expensive and then realigning an approach so the poles needed to be relocated. Comm. Hollekim stated the County has not allowed underground wiring in the past and wondered if a precedent is being set with allowing it for one person. Comm Ruland stated this was not brought in front of the commissioners for the change order. This will be brought forward at the next Commissioner meeting.

6. TRANSPORTATION ALTERNATIVE PROGRAM GRANT APPLICATION

Engineer Hennessy discussed the Tranportation Alternative Program Grant Application and is applying for vegetation management (seeding, mulching and topsoil) on CR 4, Lostwood road project.

Moved by Comm. Jacobson, seconded by Comm. Uran, to approve and sign the 2021 Township Maintenance Contracts. Upon roll call, Olson, Ruland, Hollekim, Uran and Jacobson voted yes. Motion carried.

9. ROAD STUDY

Engineer Hennessy went through the responses being sent back to the NDLTAP road study.
