2. Contractor agrees bid is valid for a period of one year from bid acceptance unless a thirty (30) day written notice is sent to the County Engineer, PO Box 275, Stanley, ND 58784 to withdraw such bid. Contractor will be obligated to bid price for any job award(s) prior to withdrawal.

3. If contract is awarded, contractor will be required to:

- Sign agreement with Mountrail County and obtain access agreement with landowner. Agreement form will be furnished by the Mountrail County Road & Bridge Department.
- Provide Road and Bridge department with a copy of approved conditional use permit for proper zoning of gravel pit.
- Provide Road and Bridge department with a copy of approved Haul Route agreement from gravel pit site to nearest county or state roadway.
- Provide Road and Bridge department with a copy of pit / pile noxious weed-free certification.

4. In submitting this bid it is understood that the right is reserved by the owner to reject any and all such bids and to waive irregularities, and it is agreed that this bid may not be withdrawn for a period of thirty (30) days from this opening thereof.

5. No bid security will be required with the Bid.

6. For all new gravel crushing bids, a Certificate of current Liability Insurance is due at time of bid, updated Certificate of Insurance with Mountrail County listed as Certificate Holder will be required PRIOR to any work being awarded. (***Copy of most recent Liability Insurance must be included.***)

7. The undersigned is duly and regularly licensed as required by Chapter 49-07 and 43-07 (subsections 1-26) of North Dakota Century Code and holds a Class _____ Contractor's License No. _____. (***Copy of most recent Contractors License must be included.***)

SPECIAL PROVISIONS FOR CRUSHING AND STOCKPILING AGGREGATE

1. **Incidental Items**

The price bid for crushing and stockpiling aggregate shall include the following:

- A. Stripping, stockpiling and replacement of topsoil and overburden.
- B. Crushing and stockpiling of aggregate material.
- C. Provide adequate and proper drainage.
- D. Bed preparation and seeding.
- E. Provide certification of noxious weed-free pit location.

2. **Aggregate Requirements – Mountrail County Surface Gravel Specifications**

1. NDDOT Aggregate Base – Class 13

- A. The required gradation for the stockpile of Mountrail County Surface Gravel as shown below (these specifications must be met on new and existing stockpiles):

2. Modified Class 13 Aggregate Base – Class 13

- A. The required gradation for the stockpile of Mountrail County Surface Gravel as shown below (these specifications must be met on new and existing stockpiles):

<u>Sieve Size</u>	<u>Total % Passing by Weight</u>
3/4"	100%
No. 4	50 - 78%
No. 8	37 - 67%
No. 40	13 – 35%
No. 200	4 -- 15%

- B. The plasticity index shall be from 4-12. Tests will be run in accordance of AASHTO-T90.
- C. LA Abrasion of less than 40%.
- D. A maximum allowable percentage of Shale is 12%.
- E. There will be a minimum of 50% fractured faces, at least 1 fractured face, NDDOT method.
- F. Clay additive material to be provided by Mountrail County Road and Bridge Department.

3. Testing

- A. The Contractor will be required to provide one test per 5,000 cubic yards of material produced for sieve analysis, plasticity index, and fractured faces. Tests for each 5,000 cubic yards produced must be run by an approved testing agency and submitted to the County Engineer for review and approval. Final acceptance of the produced pile will be contingent upon test results received by the Board of Mountrail County Commissioners.
- B. All tests must be taken from the belt or stockpile.
- C. Sampling and testing of the gravel materials must be in compliance with NDDOT specifications.

4. Measurement and Payment

- A. The final quantity shall be determined by actual field measurements of the stockpile accept and in place. County will perform required measurements.
- B. Payment shall be made according to the price bid per cubic yard for the material accepted and in place.
