Laurie Johnson, Correctional Administrator discussed the amount charged is \$75 per day for housing Federal inmates and \$80 for all the rest of the inmates. Wade Enget, States Attorney also discussed the DOCR requesting to hold prisoners and the response from Correctional Administrator Johnson.

Comm. Ruland discussed having a feasibility/needs study for a potential nursing home/assisted living facility in the southern part of Mountrail County. It was suggested a grant application be done directly by the Mountrail County Job Development Authority for this study.

Kim Savage, Tax Director met with the board to discuss two abatements.

Moved by Comm. Olson, seconded by Comm. DeGroot, to approve an abatement on parcel #61-0018200 for tax year 2024 for qualifying for 90% Disabled Veterans Property Tax Credit as per the recommendation of the Tax Director Savage. Upon roll call, Olson, Ruland, Rice, DeGroot and Hollekim voted yes. Motion carried.

Moved by Comm. Rice, seconded by Comm. Hollekim, to approve an abatement on parcel #20-0014100 for tax year 2024 for qualifying for 90% Disabled Veterans Property Tax Credit for 6 months as per the recommendation of the Tax Director Savage. Upon roll call, Olson, Ruland, Rice, DeGroot and Hollekim voted yes. Motion carried.

Tax Director Savage discussed the Sidwell GIS mapping contract.

Moved by Comm. Rice, seconded by Comm. DeGroot, to approve the two year contract with Sidwell Contract for the GIS Mapping Services with an annual Technology Access Fee totaling \$500 & GIS Parcel Mapping Services totaling \$130 per hour. Upon roll call, Rice, Ruland, Olson, DeGroot and Hollekim voted yes. Motion carried.

Tax Director Savage along with Rory Porth, Property Tax Assessor met with the board for discuss the 2025 agriculture land valuations. Property Tax Assessor Porth stated the average agricultural value per acre for Mountrail County decreased from \$501.61 in 2024 to \$497.69 for the 2025 year. Property Tax Assessor Porth recommended to stay the same for the agricultural land values at a 94.74% threshold which is between the 90% to 100% tolerance level allowed by the State.

Moved by Comm. Rice, seconded by Comm. Hollekim, to approve staying the same for the 2025 agricultural land valuation at 94.74% threshold which is between the 90% to 100% tolerance level allowed by the State. Upon roll call, DeGroot, Ruland, Rice, Olson and Hollekim voted yes. Motion carried.

9:30 A.M.

Stephanie A. Pappa, Human Resource Director discussed the Human Resource Advisory Committee (HRAC) recommendation for the request from Jim Hennessy for a dual banding change. Discussion was held on the budget changes for the salary due to job duties increased on the Weed Control Fund. The Weed board approved the following changes for the salary adjustment from 25% to 40% to Weed Control and 75% to 60% for County Agent salary for the 2025 budget. The salary would decrease from \$86,521 to \$73,450.80 for County Agent salary and for Weed Control it would be \$28,840 to \$48,967.20.

Moved by Comm. DeGroot, seconded by Comm. Olson, to approve the dual position for the County Agent/Weed Control from a banding/grading of a D65 for the County Agent/Weed Control to a D72.5 as per the recommendation of the Human Resource Advisory Committee effective January 20th pending the Dual agreement. Upon roll call, Rice, Olson, DeGroot, Ruland and Hollekim voted yes. Motion carried.

Jana Hennessy, Road & Bridge (R&B) Engineer met to discuss Road & Bridge. Also present were Brian Lund, Ross Kovach and Brad Skager with Rossco Crane & Rigging Inc.

1. ROSSCO CRANE & RIGGING INC.

Engineer Hennessy discussed the request from Rossco Crane & Rigging Inc concerning the overweight/oversized loads exceeding 290,000 lbs. Brian Lund with Rossco Crane & Rigging Inc. presented to the board on how the trailer mechanism works with equalizing the weight. Ross Kovach stated the timeline is taking too long and would like to shorten the time frame.

Moved by Comm. DeGroot, seconded by Comm. Olson, to authorize the County Engineer to issue excess move agreements on behalf of Mountrail County to Rossco Crane & Rigging Inc to move with oversized/overweight super loads exceeding 290,000 lbs. Upon roll call, Ruland, Rice, Olson, Hollekim and DeGroot voted yes. Motion carried.

5. LEGISLATIVE BILL

Discussion was held on proposed House Bill 1407 to change the weight limitations for vehicles on highways other than the interstate system from a gross weight not to exceed 80,000 to a gross weight not to exceed 113,000 lbs. unless otherwise posted.
