Lori Hanson, Tax Director and Rory Porth, Property Tax Assessor met with the board to discuss the 2023 agriculture land valuations. Tax Director Hanson stated the average agricultural value per acre for Mountrail County increased from \$487.34 in the 2022 year to \$512.36 for the 2023 year. Tax Director recommended to increase the agricultural land values by 4.9% to remain at a 92% threshold which is between the 90% to 100% tolerance level allowed by the State.

Moved by Comm. Hollekim, seconded by Comm. Rice, to approve increasing the 2023 agricultural land valuation by an approximate 4.9% to remain at a 92% threshold which is between the 90% to 100% tolerance level allowed by the State. Upon roll call, DeGroot, Hollekim, Rice, Ruland and Olson voted yes. Motion carried.

10:00 A.M.

Lori Hanson, Tax Director discussed the letter from the City of Stanley requesting the assistance of Hannah Collins until a new City Assessor is hired.

The Board was in consensus to allow Hannah Collins to work under a contract with the City of Stanley until they hire a new City Assessor upon signing a temporary agreement in the amount of \$1,500.

Chad Hysjulien and Lauren Frost, City of Stanley Council members and Allyn Sveen, City of Stanley Auditor discussed with the Commissioners the next steps with the following properties located in Stanley on tax deed; Lot 27, Replat of John Rian Addition Phase 1, Stanley City appraisal value of \$12,825; Lot 28, Replat of John Rian Addition Phase 1, Stanley City appraisal value of \$29,927; Lot 29, Replat of John Rian Addition Phase 1, Stanley City appraisal value of \$5,750; Lot 30, Replat of John Rian Addition Phase 1, Stanley City appraisal value of \$5,750; Lot 41, Replat of John Rian Addition Phase 1, Stanley City appraisal value of \$5,755 and Lot 42, Replat of John Rian Addition Phase 1, Stanley City appraisal value of \$5,755 and Lot 42, Replat of John Rian Addition Phase 1, Stanley City appraisal value of \$6,689 . Wade Enget explained laws under NDCC 57-28. The two options if the County retains possession of these properties would be to demolish or reappraise the properties. Councilman Hysjulien would bring this matter before the full City Council at their next meeting for further discussion. More discussion will be ongoing with the City of Stanley and the possibility of reappraising the properties.

1. CR 6 BNSF SURFACING PERMIT

Matthew Huettl, HDR Engineering discussed obtaining a surface permit and the requirement of purchasing the General Liability Railroad Protective Insurance for the railroad crossing at White Earth. The Contractor will apply

for this permit. Engineer Hennessy along with Craig Mizera and Matthew Huettl, HDR Engineers will meet with the Council members of White Earth to discuss the project.
