The Board acknowledged Mountrail County is in compliance and will be receiving reimbursement in the amount of \$814,259.29 for funds withheld while non-compliant.

I. STIPEND

J. TRANSFER

Hollekim, to approve the transfer for Oil & Gas allocations totaling \$1,587,456.61 for current allocations from the General Fund to the County Road & Bridge Fund (70% of Oil & Gas Funds). Upon roll call, Uran, Ruland, Olson, Jacobson and Hollekim voted yes. Motion carried.

K. CENSUS

Discussion was held on the Complete Count Committee for the census.

Jacobson, to approve contributing \$10,000 from the Commissioner Contingency Fund to the Complete Count Committee for advertising, mailings, and miscellaneous costs for the upcoming 2020 Census. Pappa, Auditor discussed leaving the clerk position open until discussion is held with Bremer on providing service for integrated payables and if help is needed after implementation of integrated payables then a part-time position would be looked at in the future.

N. HB SOUND & LIGHT

O. BOARD CONCERNS

The Board reviewed the letter received from Christopher Jones, Executive Director of the ND Department of Human Services, approving the creation and formation of the Mountrail McKenzie Human Service Zone effective January 1, 2020.

Discussion was held on the calls received due to missing tax statements from the Treasurer Office. State's Attorney Enget stated the majority of the mail has the correct address on it but was returned by the US Post Office to the Treasurer's Office with the reason code, "Unable to Forward".

P. NORTH DAKOTA FIRE AND TORNADO AGENT
