# 5. CR 9 100<sup>th</sup> AVE NW-WHITE EARTH COTTAGE SITE

Discussion was held with Craig Mizera with HDR Engineering concerning the White Earth Bay Cottage Site proposal designs. The following options: Option 1: 12 foot lanes with 2 foot shoulders; 6 foot wide ditch bottom; 3 foot deep ditch; Conceptual cost = \$960,000 Option 2: 12 foot lanes with curb and gutter; Conceptual cost = \$1,400,000\* Option 3: Resurfacing existing roadway; Conceptual cost = \$27,000.

Discussion was held on if there was enough room for option 1 and Engineer Mizera stated it would be a tight fit. The design option 3 would just be graveling with no replacement of culverts etc. Chairman Ruland stated this is a design option for a shovel ready project in the future.

Moved by Comm. Jacobson, with no second, to approve moving forward with design option 3 for CR 9, 100<sup>th</sup> Ave NW White Earth Cottage Site. Without a second, the motion will not be considered.

Moved by Comm. Olson, seconded by Comm. Uran, to approve moving forward with design option 1 for CR 9, 100th Ave NW White Earth Cottage Site. Upon roll call, Hollekim, Uran, Ruland, and Olson voted yes and Jacobson voted no. Motion carried.

Discussion was held on a special assessment district on this portion of the road for the White Earth Cottage Site. State's Attorney Enget stated this would be considered if White Earth Bay established a District.

# 6. WETLAND MITIGATION DISCUSSION/WETLAND BANKING

Craig Mizera with HDR Engineering along with Jill Rust and Tina Fricke discussed the Wetland Mitigation and Wetland Banking process. Jill Rust discussed the benefits and disadvantages of each mitigation process. The options are as follows: the on-site, wetland banking and/or in-lieu fee. Chairman Ruland stated that the Department of Agricultural is under discussion with the energy sector to be able to develop a mitigation bank. Comm. Hollekim asked whether we can have the Corps of Engineers and Ducks Unlimited banks together and use at the same time. Jill Rust stated that would be an option.

# 7. 40<sup>th</sup> ST NW-DUST CONTROL

Discussion was held that 40th St NW has always had dust control applied but Jerry Aftem requested not to put on due to health issues. Jerome Jarski is in favor of the dust control being applied.

Moved by Comm. Olson, seconded by Comm. Hollekim, to approve applying dust control on 40<sup>th</sup> St NW for those in favor of having it. Upon roll call, all present voted yes. Motion carried.

### 8. PLAZA SHOP

Discussion was held on the Ottertail Power Company Service Agreement for the Plaza Shop. State's Attorney Enget stated the agreement would need to be signed in order to get power to the new Plaza Shop.

Moved by Comm. Olson, seconded by Comm. Hollekim, to approve signing the Electric Service Agreement and Revenue Guarantee with Ottertail Power Company for the site at Plaza Shop. Upon roll call, Uran, Ruland, Olson, Jacobson and Hollekim voted yes. Motion carried.

#### 9. PLAZA PAVEMENT DAMAGES/REPAIRS

Engineer Hennessy gave an update on the damages that occurred due to the City of Plaza's water main break. Discussion was held on who is in charge of getting the pavement fixed and who is paying for the repair on the pavement. No communication was taken by the City of Plaza for the repairs. Engineer Hennessy will bring this back at the next meeting.

Moved by Comm. Olson, seconded by Comm. Uran, to approve moving forward with getting the Plaza pavement fixed. Upon roll call, Olson, Uran, Jacobson, Hollekim and Ruland voted yes. Motion carried.

#### 11:00 A.M.

Stephanie A. Pappa Auditor discussed the 2020 financials. Discussion was held by the Commissioners to cut the 2020 budgets. Comm. Hollekim stated the budgets and the oil revenue need to be adjusted for the current revenue.

### 11:20 A.M.

Wade Enget, State's Attorney discussed the Mountrail County Employee Handbook Procurement Policy for Goods and Services. Also present were Traci Hysjulien, Nichole Degenstein, Lori Hanson, Melissa Vachal, Corey Bristol, Jana Hennessy, Desiree Sorenson, Lynnette Vachal, Karen Babbitt and Mary Trahan. Comm. Uran stated with the difficulty of any procurement policy is that the local bidders typically end up on the high end and we need to consider the cost of transportation of equipment to be repaired if it is a non-local procurement. More discussion will be held at the next Commissioner meeting.

Discussion was held with Departments Heads concerning the COVID-19 and the plan and policy moving forward. Present for the discussion were Corey Bristol, Jana Hennessy, Mary Trahan, Traci Hysjulien, Nichole Degenstein, Karen Babbitt, Melissa Vachal, Lori Hanson, Desiree Sorenson, Laurie Johnson, Lisa Lapica, and Lynnette Vachal. Comm. Hollekim expressed her concerns on the employees working remotely from home. Auditor Pappa was asked to send an email to all Department Heads requesting who is still working remotely. This issue will be discussed at the next commissioner meeting.
