H. BOARD CONCERNS

Comm. Hollekim mentioned that at the ND Association of Counties Strategic Planning session communication was a topic of concern. Comm. Hollekim suggested sending minutes from the other different boards and getting updates to all the rest of the Commissioners on what is occurring on those boards. Also, Comm. Hollekim suggested updates from department officials on a periodical basis.

Chairman Ruland discussed the salary for the 2023 year and further discussion will be held at the next commissioner meeting.

3. APPOINTMENT SCHEDULED

9:10 A.M.

Laurie Johnson, Correctional Administrator discussed out of state travel for training in Alexandria , MN in October, Waite Park, MN on July 14-15 and River Falls, WI on September 28-29th.

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve the out of state travel for training being held in Waite Park, MN on July 14th-15th and River Falls, WI on September 28th-29th and in Alexandria MN in October. Upon roll call, Olson, Uran, Hollekim, Ruland and Rice voted yes. Motion carried.

Correctional Administrator Johnson discussed the Lake Region Correctional facility needing to house 49 inmates and willing to pay the daily rate from July 1st to October 1st due to a reduction from Grade One to Grade Three Facility. Correctional Administrator Johnson also stated LRLEC is reaching out to provide technical assistance for Basic Training classes and is willing to pay wages, travel and lodging. Employees will do the training on their own personal time off and not as an employee of Mountrail County.

9:15 A.M.

Chairman Ruland opened the 9:15 A.M. public hearing for the purpose of receiving comments on an amendment to zoning request, to rezone a tract of land from Agricultural to Commercial filed by Wallsauger Properties LLC, applicant, with concurrence from Brent & Kayla Wollschlager, landowners, for the purpose of constructing rental storage units on property described as Outlot 1 in the SE¼SE¼ of Section 36, Township 152 North, Range 91 West (Van Hook Township).

Malinda Gunderson, Planning & Zoning Assistant, presented the information from the May 24, 2022 Planning & Zoning Commission recommending to the Mountrail County Commissioners to approve the zoning request filed by Wallsauger Properties LLC applicant with concurrence from Brent & Kayla Wollschlager, landowners.

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve the zoning request filed by Wallsauger Properties LLC, applicant, with concurrence from Brent & Kayla Wollschlager, landowners, for the purpose of constructing rental storage units on property described as Outlot 1 of SE¼SE¼ of Section 36, Township 152 North, Range 91 West (**Van Hook Township**) as Wallsauger Properties LLC, applicant, with concurrence from Brent & Kayla Wollschlager, landowners, have met all criteria as set forth in Article IV, Section III of the Mountrail County Zoning Ordinance and is further contingent upon Wallsauger Properties LLC with concurrence from Brent & Kayla Wollschlager complying with all other terms and conditions of the Mountrail County Zoning Ordinance. Upon roll call, all present voted yes. Motion carried.

9:30 A.M.

Chairman Ruland opened the 9:30 A.M. public hearing for the second reading of the Mountrail County Planning & Zoning Land Development Code.

Also present were Scott Harmstead, SRF Consulting Group; Malinda Gunderson, Planning & Zoning (P&Z) Assistant; Melissa Vachal, P&Z Administrator; Charlie Sorenson; Deanna Blikre Peterson; Brian Skaar; Myron Lee; Howard Rice; Dallas Lalim; Jay Regnier, Austin Collins, Brad Peterson and Mollie Smith with Enel Green Power North America Inc., and Dennis Lindahl, with Tioga Economic Development Corporation.

Discussion was held on the letters of opposition received from Steve Blikre, Brian Skaar, David Norstedt, Nels & Starla Norstedt, Dwight & Kay Blikre, Myron Lee, Roger Blestrud & Enel Green Power North America Inc. regarding the new wind ordinance that would prevent the development of the wind projects. Jay Regnier, Senior Director with Enel Green Power North America Inc made comments on the ordinance provisions for turbine setbacks, occupied structure variance, visual impact assessment, noise standards, permit term and financial assurance. Dennis Lindahl, with Tioga Economic Development Corporation supported Enel Green Power North America Inc. Dallas Lalim, Landowner is in support of the Oil & Gas industries and the wind turbines. Dallas Lalim stated the wind turbines is surface which helps the current landowners' yearly income. Wade Enget, State's Attorney stated the Mountrail County Planning & Zoning Land Development Code is still able to be changed or modified. Chairman Ruland stated if the Land Development Code is passed and someone doesn't meet the setback numbers then a person would be able to apply for a variance permit.

Moved by Comm. Hollekim, seconded by Comm. Uran, to refer the Mountrail County P&Z Land Development Code back to the P&Z Board for further consideration specifically with Article 5 with subsections 5.6 Wind Energy Facility, Utility Scale and 5.9 Temporary Freshwater Industrial Use Point of Diversion. Upon roll call, all present voted yes. Motion carried.

10:00 A.M.

The Board reviewed the bids for the rental office space quotes at the Memorial Building. Two bids were received from Gjellstad LLC and Kimber Company. Also present were Clay Sorenson, CRS Construction, Roger Gjellstad, Mary Dennis and Candice Grilley. Roger Gjellstad with Gjellstad LLC discussed the construction of permanent office spaces in the building with the cost being charged in the monthly rental fees. Comm. Uran suggested the County pay an upfront lease fee for the construction costs. Clay Sorenson stated it could be completed to the county's satisfaction. The quote for Kimber Company didn't meet the bid specifications for the 16 office spaces requested.

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve moving forward with the proposal from Gjellstad LLC totaling \$10,000 per month plus utilities for rental of office space on property described as Sublot A of Outlot 5 of the NESE of Section 28, Range 91 in Stanley City (8131 Highway 2). Upon roll call, Ruland, Uran, Hollekim, Rice and Olson voted yes. Motion carried.

Discussion was held on the moving companies' proposals to relocate offices in the Memorial Building to the Courthouse and/or the new office space at 8131 Highway 2.

Moved by Comm. Uran, seconded by Comm. Rice, to approve going with Williston Area Movers for moving offices at the Memorial Building at an estimate totaling \$8,000. Upon roll call, Ruland, Rice, Uran, Olson and Hollekim voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Hollekim, to approve purchasing 100 storage totes from Ace Hardware totaling \$2,300. Upon roll call, Olson, Rice, Uran, Hollekim and Ruland voted yes. Motion carried.

Discussion was held on the used furniture housed in the Memorial Building and the consensus of the Board is if there is no room in the temporary building then get rid of the furniture.

10:30 A.M.

Jana Hennessy, Road & Bridge (R&B) Engineer met to discuss Road & Bridge. Also present were Gregory Gunderson, Joel (Rocky) Dubose & Justin Labar representing the City of White Earth, Craig Mizera and Matthew Huettl with HDR Engineering.

1. CR 6

Engineer Hennessy presented the City of White Earth concerns and questions with the main city streets that connect CR9 (99th Ave NW) to CR6 (67th St NW) with the White Earth West CR6 project

that is currently under design. Gregory Gunderson and Justin Labar discussed the following concerns and questions for the City of White Earth.

Questions -

1) Regarding the engineering survey and the city paying for the survey or cost sharing the concern is that there is a clear path forward. The council would like to have some assurance that this would be fiscally responsible. Knowing the funds are not available to pay for this project themselves going forward this is a concern.

2) Lack of policing for what is perceived as impending issue if the road is paved, and weight limit increased in a very residential area where many young children reside. Would county law enforcement be willing to patrol the area more frequently? What would it take for this to happen?3) How would the county funding the project and taking control of the care of this road work long term?

4) Would the expectation be that we would increase weight limit on this road or all streets in White Earth?

Concerns –

1) Avoiding drainage issues in the area to the NW of this road. There would need to be assurance that the water will move when this is done. This has been a battle in that area that we have only recently seem to get a handle on and we do not want to go backward.

2) There would need to be an understanding with road and bridge that our blade operator will not leave this road full of snow if the county does not get out before him to clean it. We will not wait to clean out the main road that 80 percent of our residents have to use to leave their homes to go to work, get emergency services or just to go to the grocery store. In addition, the city workers may use the city sweeper to clean up the road if it becomes full of gravel.

3) Stop sign placement, while we understand we may not be able to keep all the current signs, it is important that we keep the one by the church. We tried one coming down the hill and it was disaster in the winter, someone must stop there.

4) Making sure there are adequate Children at Play notices coming into the residential area so there is a clear understanding of this factor along the route. Half our resident children live on the other side of that road from our city park so there is a significant amount of biking and walking across and along this stretch of road. This road being paved is likely to increase this activity.

Joel (Rocky) Dubose stated the City of White Earth doesn't have the means financially to support the cost of the road.

Matthew Huettl with HDR Engineering stated with the Preliminary Engineering Contract would give two different design options to consider.

Moved by Comm. Rice, seconded by Comm. Olson, to approve signing the Preliminary Engineering Contract Amendment from 2nd St and Hill St, from JCT CR 9 to JCT CR 6 approximately .317 miles with HDR Engineering at a cost not exceeding of \$9,940.60. Upon roll call, Uran, Ruland, Olson, Hollekim and Rice voted yes. Motion carried.

Moved by Comm. Rice, seconded by Comm. Uran, to approve signing the Preliminary Engineering Contract Amendment from Williams County line (102nd Ave NW) to the City of White Earth elevator, (67th St NW) approximately 5.84 miles with HDR Engineering at an estimated increase of \$224,580 with total contract cost not to exceed \$433,031.10. Upon roll call, Rice, Hollekim, Ruland, Olson and Uran voted yes. Motion carried.

Engineering Huettl reviewed the different design options for CR 6 White Earth West Project as follows: Decision #1: Structure 31-106-11.0 Barrier End: Alternative 1) Barrier End Modification for Existing Bridge; Alternative 2) Barrier End Repair for Existing Bridge and Decision #2: Proposed Pavement Section: Alternative 1) Cement Stabilization 2) Geogrid Stabilization.

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve the design option for bridge barrier ends as Alternative 1) barrier end modification for existing bridge totaling \$76,000 for CR 6 Project. Upon roll call, Uran, Ruland, Rice, Olson and Hollekim voted yes. Motion carried.

Moved by Comm. Uran, seconded by Comm. Rice, to approve the design option for the paving as Alternative 2) Geogrid stabilization pavement for CR 6 Project. Upon roll call, Olson, Ruland, Rice, Hollekim and Uran voted yes. Motion carried.

2. CR 15/VAN HOOK

Engineer Hennessy discussed the letter received from Gratech Company LLC for the dissatisfaction with the substantial completion dates put into place by ND Game & Fish for seed planting and the

substantial completion construction end date which is in October of 2022. Gratech requested the final completion/seeding deadline date be extended to spring of 2023. The consensus of the board was to grant no extension on the date of completion.

3. RAIL ROAD CROSSING/PROJECT #RSO-C731(022)

Moved by Comm. Olson, seconded by Comm. Rice, to approve signing the Final Certification of Local Match for Van Hook Railroad Crossing Project #RSO-C731(022). Upon roll call, Hollekim, Rice, Uran, Olson and Ruland voted yes. Motion carried.

4. NEW TOWN CONCRETE PAD QUOTES

Moved by Comm. Olson, seconded by Comm. Rice, to accept the quote from Creative Concrete for materials and labor to construct a 40' X 40' X 7" concrete pad for salt storage at the New Town Shop totaling \$35,710.00 being contingent on the approval of the building permit with the City of New Town. Upon roll call, Rice, Uran, Hollekim, Olson and Ruland voted yes. Motion carried. Engineer Hennessy commented she reached out to three different contractors but only one submitted a quote.

5. ONEOK

Engineer Hennessy discussed the overweight permit requested from ONEOK to use the Stanley Truck Bypass today as a route to haul a 305,500# compressor. Discussion was held on the residential area, the road weight limit capability, the lack of planning by ONEOK, and the coordination with the City of Stanley.

Moved by Comm. Uran, seconded by Comm. Rice, to approve an excess agreement for the Stanley Truck Bypass with ONEOK concurrent with the coordination of the City of Stanley. Upon roll call, Ruland, Olson, Uran voted yes Hollekim and Rice voted no. Motion carried.

6. UPDATED ROAD CHARTS & MAPS

Engineer Hennessy shared the R&B charts for the upcoming 2023 budget year.

7. CR 9 UPDATE

Craig Mizera with HDR Engineering gave an update on CR 9. The Corps of Engineers are still holding the permits.

8. CDL

Engineer Hennessy stated the R&B is in the works of getting an in-house trainer for the CDL requirements.

9. SEMI BIDS

Moved by Comm. Hollekim, seconded by Comm. Olson, to give authorization to Engineer Hennessy to make an emergency purchase of a used semi not exceeding \$75,000 due to the lack of availability. Upon roll call, Uran, Ruland, Olson, Hollekim and Rice voted yes. Motion carried.

4. ADJOURN

The Board adjourned at 2:00 P.M. to meet in regular session on Tuesday, July 5, 2022 at 9:00 A.M. Accepted and approved this 5th day of July, 2022.
