1. NORTH DAKOTA TRUST LAND/CR10 ROAD EASEMENT

Engineer Hennessy discussed the road easement needed for the CR 10 Project with the North Dakota Trust Lands.

Moved by Comm. DeGroot, seconded by Comm. Rice, to approve the signing of the road easement for the CR 10 Project for parcels of land in the SE¼ & SW¼ of Section 16, Township 154, Range 89 with the North Dakota Trust Lands. Upon roll call, Ruland, Rice, Olson, Hollekim and DeGroot voted yes. Motion carried.

2. MWEC-CR 1-TAGUS SOUTH ROAD PROJECT

Kim Savage, Tax Director along with Rory Porth, Karen Brown, & Lisa Wolla Assessors met with the board to discuss County Equalization.

Chairman Ruland opened the 11:00 A.M. County Equalization Meeting.

Moved by Comm. DeGroot, seconded by Comm. Olson, to approve going into County Equalization meeting. Upon roll call, all present voted yes. Motion carried.

Tax Director Savage presented the County Property Assessments for the 2025 assessment year.

Tax Director Savage discussed adjustments needed on parcels in the City of Stanley as the properties qualify for exempt status.

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve removing values on exempt parcels per the recommendation of Tax Director Savage as follows: vacant land value of \$17,600 on parcel #61-0006100 as property is owned by Mountrail County through tax deed action proceedings; land value of \$273,600 and structure value of \$1,027,700 on parcel #61-0048520 as the property is owned by the Stanley School District and used for a bus barn; and land value of \$44,200 and structure value of \$189,500 on parcel #61-0081300 as the property is owned by Bethlehem Lutheran Church and used for a parsonage. Upon roll call, Hollekim, Ruland, Rice, Olson and DeGroot voted yes. Motion carried.

Tax Director Savage discussed parcel #31-0007800 in Austin Township which is no longer farm residence exempt. Tax Director Savage recommended removing the ag land value of \$300 and adding a residential land value of \$6,000 and a total residential structure value of \$281,400 for the house (\$140,300) and two shops (\$141,100).

Moved by Comm. Rice, seconded by Comm. DeGroot, to remove the ag value and accept the residential values placed on Parcel #31-0007800 as per the recommendation of Tax Director Savage and approve sending a Notice of Adjustment for parcel #31-0007800 with hearing to be held at the Tax Equalization meeting at 9:45 a.m. on the 17th of June. Upon roll call, Rice, Olson, Hollekim, DeGroot, and Ruland voted yes. Motion carried.

Tax Director Savage discussed the McAlmond Township equalization meeting. The residential values were low and the Township Board of Equalization approved the increase in values on the nine parcels reassessed by the County.

Tax Director Savage discussed parcels #16-0013200, #16-0017600 & #16-0017700 in McGahan Township that need adjustments as all gravel pits have been reclaimed. Tax Director Savage recommended to remove the commercial value of \$32,100 and add ag land value of \$6,100 on Parcel #16-0013299; remove the commercial value of \$16,700 and add ag land value of \$1,300 on Parcel #16-0017600 & remove the commercial value of \$22,600 and add ag land value of \$1,500 on Parcel #16-0017700.

Moved by Comm. Hollekim, seconded by Comm. DeGroot, to remove the commercial values and accept the agricultural values placed on Parcels #16-0013200, #16-0017600 and #16-0017700 as per the recommendation of Tax Director Savage and approve sending a Notice of Adjustment for Parcel #16-0013200, #16-0017600 & #16-0017700 with hearing to be held at the Tax Equalization meeting at 9:45 a.m. on the 17th of June. Upon roll call, Hollekim, Ruland, Rice, Olson and DeGroot voted yes. Motion carried.

Tax Director Savage stated the County is not in compliance with State tolerance levels with the residential values. The State of North Dakota allows a tolerance level of 90% to 100%, the County is at 85% according to the sales ratio study. Tax Director Savage discussed the three options to get the County into compliance: Option 1; 15% increase in residential structure value only county-wide (excluding the cities of Stanley & Parshall) which will bring the values to 92.3% threshold: Option 2; 12% increase in structure value and 12% land value county-wide (excluding the cities of Stanley & Parshall) which will bring values to 91.8% threshold: and Option 3; 20% increase in structure and land value for Lake properties and 10% on structures and land for rest of the county (excluding Stanley & Parshall) which will bring values to 91.8%. Lake properties include White Earth Cottage Site, Little Knife Cottage Site, Riverview Estates Subdivision, Arrowhead Point Subdivision, Bridgeview Subdivision, Varloe's Subdivision, Traynor Park Subdivision, Brendle's Subdivision, Brendle's 2nd Subdivision, and Brendle's 3rd Subdivision.

Moved by Comm. DeGroot, seconded by Comm. Rice, to approve increasing residential values to bring into tolerance with the State of North Dakota using Option 3 with a 20% increase in structure and land values for Lake properties and 10% on structures and land for rest of the county (excluding the cities of Stanley & Parshall) which will bring residential values to approximately 91.8% tolerance level as per the recommendation of Director Savage. Stanley and Parshall were not included in the increase as these cities are currently at a tolerance level of 92%. Upon roll call, Olson, Rice, Ruland, DeGroot and Hollekim voted yes. Motion carried.

Moved by Comm. DeGroot, seconded by Comm. Rice, to recess the County Board of Equalization meeting at 12:08 P.M. until June 17, 2025 at 9:45 A.M. Upon roll call, all present voted yes. Motion carried.
