Old Business:

4-H Horse Show

- Went very well, but only had one Cloverbud as a lot of our members moved up an age group.
- Numbers were almost the same for our county from last year.
- Would like to hear feedback on having a second judge/split arena, if the horse committee would like to go back to one judge or keep two judges their opinions would be appreciated.
- The judge commented on how well our show ran and how much help we had.
- If we get short on help, it has been suggested to have a sign-up available for each parent/committee member to sign up to help with an event.

Achievement Days:

- Numbers were average for the most part, sheep and swine were likely the largest drop.
- Lynnette reported that we have received a lot of compliments on our Achievement Days and felt it went smoothly and great.

Suggestions Box Notes/Post-Event Discussion:

- Was suggested to have judging from 2-5 pm (Shorten up the time available) so that judges aren't waiting and potentially do not split up members by species. Just have an open judging time.
 - Was asked to put in the newsletter and have club leaders tell their members that if you have several projects to come early.
- Suggested that we need to set up the panels for the arena before we set up any of the livestock areas.
- If you have suggestions on facility updates/panels/cages, etc. John has invited anyone interested to come to a fair board meeting. Contact Lynnette or Heather to let them know you would like to attend, and they can let you know when the meeting is.
- Discuss at our January meeting how we would like to move forward with static judging times lining up with set-up times and how to complete the check-in process.

- Suggested to have static judges turn in their book to a static committee member to make sure that their books/papers have been completed correctly.
- Suggested to have poultry moved a little further away from the show ring so they do not scare the animals.
- To add in the intermediate showmanship division.
- Potential to add small animals and horses into the round-robin.
- If horses or other species would like to make premium sale changes, please bring them to the January meeting.

- Suggested that if you would like vendor space, to come to the 4-H council for permission.
- Have a "due date" for vendors/sponsors to apply for a spot and then the board can approve the vendors or sponsors.
- Asked how we know who is watching the exhibits and was suggested to only have one club at a time.
