	<p>The Mountrail County Correctional Center (MCCC) has a very thorough policy. The PREA Policies are 8.01 through 8.09. Policy 8.01 PREA - Prevention and Planning in its opening policy statement states that the MCCC has zero tolerance towards all forms of sexual abuse and sexual harassment. The policy follows the guidelines of the PREA standards, includes definitions, and the duties of the appointed PREA Coordinator who works to ensure every standard is met. The PREA Coordinator position within the jail is the Director of Security and reports directly to the Jail Administrator. She has the authority to develop and oversee the efforts of the facility to prevent, detect, and respond to sexual abuse and sexual harassment. The PREA Coordinator has been committed to implementing PREA standards into the jail.</p>

	<p>The auditor reviewed the MCCC Policy 8.02 PREA - Supervision and Monitoring, the annual staffing plan signed January 31, 2024, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. The MCCC has strong, consistent leadership and a positive culture. The auditor witnessed ample staff on shifts. It is a 42-bed facility with three (3) managers, one (1) registered nurse, 13 full time correctional officers, and two (2) part time correctional officers. There are always a minimum of three staff on duty. All three managers are certified correctional officers and also fill-in for correctional officer shifts when necessary. There have been no deviations from the staffing plan. If there were deviations, it would be documented in the Zuercher Jail Management System (JMS).</p> <p>The management staff conduct unannounced rounds to observe operations, and this was verified by line staff and a review of the reports from the JMS. The unannounced rounds are conducted by intermediate and higher-level supervisors. The facility is a small facility with multiple cameras throughout the parking lots, and entrances and the master control staff allow all access and exit from the facility. There is no way for administrators to enter without alerting the master control. Their policy prohibits staff from alerting other staff members that these supervisory rounds are occurring, but typically the staff are aware simply because it is a small facility, and it is unavoidable. There are multiple cameras throughout the facility that are monitored in the main control room.</p>

	<p>The auditor reviewed MCCC Policy 8.03 PREA – Cross-Gender Viewing and Searches, interviewed administrators, staff and inmates, and toured the facility to verify compliance with this standard. MCCC prohibits cross gender searches of inmates. There are female staff on duty to conduct searches of new female admissions in booking. All interviews with both inmates and staff confirmed the practice. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex inmates. If the offender’s genital status is unknown, it is determined during conversations with the offender, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. The facility does not conduct cross gender strip or pat down searches, but policy requires that if this is to occur, it is to be documented with justification in the JMS. There have been no recorded cross-gender searches. Staff have been trained and were able to demonstrate the correct search procedure for a cross gender pat search to the auditor.</p> <p>The facility has policies and procedures in addition the physical construction of housing areas enables offenders to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks. All cells have showers with shower curtains for privacy and toilets. This affords greater privacy than allotted in many correctional facilities. Policies and procedures require staff of the opposite gender to announce their presence when entering an offender housing unit. These announcements allow inmates to cover up if changing or using the toilet within their cell. Based on agency staff interviews, inmate interviews and direct observation by the auditor, the announcements are consistent.</p>

	<p>Education includes a statement that appropriate provisions will be made as necessary for inmates not fluent in English, those with disabilities, and those with low literacy levels. The MCCC has a contract with the Language Link to use when communicating with inmates who are not proficient in English or when communicating through the use of a sign language interpreter. Posters and the training video are in both English and Spanish which is the predominant language encountered at this facility. All staff are instructed in the procedures for assisting inmates who may need additional assistance. Staff work with inmates who have either visual impairments or reading and comprehension issues by verbally reviewing the material. The agency prohibits the use of inmate interpreters, readers, or other types of inmate assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the inmate's safety. The auditor determined that inmates with disabilities have an equal opportunity to participate in or benefit from all aspects of their efforts to prevent, detect, and respond to sexual abuse and sexual harassment.</p>

Staff hired over the reporting period have the required background checks. All staff are trained as CJIS operators to run criminal background checks through NCIC. A requirement of that program is that a background check is completed for all CJIS operators automatically every five years. The MCCC asks prospective applicants during the interview process regarding any previous sexual misconduct. The auditor reviewed the interview questions of recent new hires to confirm that these questions are asked and answered. However, they were not asking these questions during the annual evaluation interview if existing staff. The facility contacts previous institutional employers to determine if they had any substantiated allegations of sexual abuse. This is documented on a form.</p> <p>CORRECTIVE ACTION: The auditor required that a process be put in place for the annual evaluation process that requires all employees answer the sexual misconduct questions and acknowledge that they have a continuing duty to report this throughout the terms of their employment. Because the auditor is not able to monitor for the year, the auditor requested that they complete these forms for all current employees now, continue the process as employee reviews come up, and add specific information in their policy or a Standard Operating Procedure about specifically how they will complete this process such as which forms will be used and when this will be completed. On June 7, 2024, the PREA Coordinator provided the auditor forms with these questions and acknowledging a continuing duty to report that is signed by each staff for the current year and has added these questions to the annual employee evaluation documents.</p>

The facility has two trained facility investigators to conduct administrative investigations. All criminal allegations are turned over to the North Dakota Bureau of Criminal Investigation. In some instances they may be turned over to the Mountrail County Sheriff's Office. The Administrative Investigators have completed the North Dakota Department of Corrections and Rehabilitation (ND DOCR) investigator training. All have been trained in either how to preserve or process evidence and they work together for a successful prosecution of sexual assault.</p> <p>Victims of sexual abuse have access to forensic medical exams through Trinity Hospital in Minot. The inmate is assessed again within 30 days for risk and appropriate housing and any time if referred, requested, there is an incident of sexual abuse or there is receipt of additional information that warrants a reassessment. The auditor interviewed the Registered Nurse (RN) employed by the facility who stated she reviews the intake screening assessment done upon intake as well to ensure that if the inmate has previously been sexually victimized, she can discuss this with them during their private health screening she conducts with them within 14 days of intake.</p> <p>The auditor recommended that question number 4 on the victim potential screening be restated from "Have you ever been incarcerated before" to "Is this your first time being incarcerated" which is a more appropriate screening question for victim potential.</p>

	<p>The auditor interviewed the Jail Administrator, the PREA Coordinator, staff, and inmates. The auditor observed an intake process. The MCCC uses the PREA screening process to determine appropriate housing. They review all information and make the best suited placement for an inmate on an individualized, case-by-case basis. The MCCC implements appropriate controls on the dissemination of responses to screening questions asked pursuant to this standard in order to ensure that sensitive information is not exploited to the offender's harm by staff or other offenders. A transgender or intersex inmate's own view with respect to his or her own safety is given serious consideration. The MCCC has shower stalls with curtains in each individual cell. All inmates shower separately from other inmates. During the interviews staff were knowledgeable of this PREA standard.</p>

	<p>Auditor Overall Determination: Meets Standard</p> <p>Auditor Discussion</p> <p>The auditor reviewed MCCC Policy 8.12 Housing - PREA and interviewed the Jail Administrator and the PREA Coordinator. The MCCC staff typically finds alternative housing units that provide protection for the inmate without segregating or isolating them. The population has been at low enough numbers that inmates typically have a single cell. If they use protective custody, it is for very limited duration and only until they can find appropriate housing. Even then for MCCC protective custody is not isolation or "lock down". They still go to rec and have out of cell time like everyone else. Offenders at high risk for sexual victimization would not be placed in involuntary segregated housing unless an assessment of all available alternatives has been made, and a determination has been made that there is no available alternative means of separation from likely abusers.</p>

The auditor interviewed administrators, staff and inmates, reviewed the inmate handbook, information on the inmate phone, and on the texter, and reviewed postings while on the tour of the facility. The MCCC provides multiple internal ways for inmates to privately report sexual abuse and sexual harassment, retaliation by staff or offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, through the TurnKey kiosk, through an inmate grievance form, by calling the internal cell phone line on the inmate phone, anonymously, and from third parties and promptly document any verbal reports.</p>

reports. Inmates are aware that they can place anonymous reports of sexual abuse or sexual harassment on a piece of paper, or anonymously report to the North Dakota Department of Corrections and Rehabilitation (DOCR) or to the Bureau of Criminal Investigations, or request to speak with services staff at any time.

The MCCC provides at least one way for offenders to report abuse or harassment to a public or private entity or office that is not part of the MCCC, and that is able to receive and immediately forward offender reports of sexual abuse and sexual harassment to agency officials, allowing the offenders to remain anonymous upon request. Offenders can write to the North Dakota DOCR. The auditor conducted a test by placing a letter addressed to the North Dakota DOCR into the inmate mailbox in an inmate housing unit. The auditor received an email from the DOCR PREA Coordinator that the test was received and verified that they would report anything back to the MCCC administration but allow the inmate to remain anonymous if requested.

The facility also provided information to inmates that they could report to the Domestic Violence Center. The auditor explained to them that a FAQ dated February 2020 states that a rape crisis center cannot be used as an external reporting entity.

The facility very seldom holds for immigration purposes only. The detainee may be placed in a cell awaiting the border patrol agent to pick them up. They do have posters on how to contact the Department of Homeland Security.

CORRECTIVE ACTION: The auditor required that all references in the handbook, on training materials, on the End the Silence brochure, including the brochure that is listed under the link "PREA Information" on the MCCC website, and on posters that lists rape crisis centers as a reporting entity be removed. Rape crisis centers should only be listed on materials under the heading "Victim Support Services." While the auditor was still on site the facility removed reference to rape crisis centers on their management system so that the education information that they verbally state to the inmate during intake does not include them as an external reporting entity. The auditor required copies of the corrected handbook, posters, pictures of the kiosk information, and to notify the auditor when the website information has been corrected.

On July 2, 2024, the PREA Coordinator provided an updated inmate handbook with the information updated to state, "**Victim Support Services:** Mountrail County Correctional Center has partnered with the Domestic Violence Program NWND to provide survivors of sexual abuse with emotional support services. To access these services, contact 701-628-3233 or send a letter to PO Box 538 Stanley ND 58784."

On August 21, 2024, the Jail Administrator provided updated posters both in English and Spanish. The posters have been posted throughout the jail housing units that have been updated with the rape crisis center information removed from under the reporting heading on all the posters and only listed under Victim Support Services. The Jail Administrator also provided updated kiosk information, and an updated brochure. The brochure is used both for inmate information as well as posted on the website for third-party reporting information. 	<p data-bbox="256 264 544 297">Auditor Discussion</p> <p data-bbox="256 338 1476 707">The auditor reviewed the PREA policy and conducted staff and inmate interviews. The MCCC does not impose a time limit on when an offender may submit a grievance regarding an allegation of sexual abuse. They do not require an offender to use any informal grievance process, or to otherwise attempt to resolve with staff an alleged incident of sexual abuse. They ensure that an offender who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint, and such grievance is not referred to a staff member who is the subject of the complaint. They issue a final decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance.</p> <p data-bbox="256 745 1453 987">Third parties, including fellow offenders, staff members, family members, attorneys, and outside advocates, are permitted to assist offenders in filing requests for grievances relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of offenders. They have established procedures for the filing of an emergency grievance when the offender is subject to a substantial risk of imminent sexual abuse.</p> <p data-bbox="256 1025 1481 1352">After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, the MCCC immediately forwards the grievance (or any portion thereof that alleges the substantial risk of imminent sexual abuse) to the Jail Administrator so that immediate corrective action is taken, and provides an initial response within 48 hours, and issues a final agency decision within 5 calendar days. 	<p>Auditor Discussion</p> <p>The facility has a Memorandum of Understanding (MOU) with the Domestic Violence Program-NWND for advocacy and support services. The auditor attempted to dial the Domestic Violence Program-NWND from an inmate phone. The phone call required a PIN number to place the call and stated that there were no funds to place a call. When the auditor attempted to make a collect call, the recording stated that the destination numbers was out of collect calling funds. Staff can refer an inmate at any time for mental health support services if they feel that is warranted. The nurse will refer inmates for follow-up services outside of the facility and the facility has telepsychiatry services available. In addition, the MCCC provides the number to the Domestic Violence Criss Center in Minot. Again, this is not a free call.</p> <p>CORRECTIVE ACTION: The auditor required that the call to the Domestic Violence Program-NWND be a free call for inmates within the facility. The MCCC has their PREA brochure on their website. It has all the information that is provided to inmates as well as a paragraph that states they can “Tell a family member, friend, legal counsel, or anyone else outside the facility. Staff are required to make such reports to the staff supervisor and a report is submitted to the investigator. Administrators and staff understand that “immediate” means when the response is needed – that could mean within minutes if the abuse was recent or it could mean before the end of the shift for incidents in which an abuse was reported that occurred in the distant past. They identified during interviews that this is done by conducting and documenting a monthly status check with inmates and by monitoring inmate disciplinary reports; changes in inmate housing; and being alert to unfair or inconsistent practices regarding inmates' rights and needs. Contractors or volunteers who engage in sexual abuse are reported to law enforcement agencies (unless the activity was clearly not criminal). Emergency medical and mental health services are provided without charge to inmates.

The evaluation and treatment of such victims include, as appropriate, follow-up services, treatment plans, and, when necessary, referrals for continued care following their transfer to, or placement in, other facilities, or their release from custody.</p> <p>MCCC provides such victims with medical and mental health services consistent with the community level of care. However, with the audit completed on April 23, 2018, the audit completed on May 14, 2021, and this third audit completed on May 16, 2024, they have shown compliance with the frequency and scope of audits by ensuring an audit was completed every three years since they began. The auditor had complete access and observed operations in every area of the MCCC. The auditor requested many documents throughout the audit process and will continue to request documents through the corrective action period. The staff at the MCCC were more than accommodating, they were extremely helpful and above-board in every interaction.
