Camping Waiver of Liability:

The undersigned hereby waive, release and forever discharge Mountrail County Fair Association/Building, its affiliates, managers, members, agents, attorneys, employees, staff, volunteers, heirs, executors, administrators, representatives, predecessors, successors and assigns from any claims resulting from physical or personal injury, pain, suffering, illness, disfigurement, temporary or permanent disability, loss or death, and any property damage that may occur caused by fire, theft, vandalism, water or land-related accidents, natural events or any other occurrences or mishaps. We are here of our free will, and entirely at our own risk. We understand that these injuries or outcomes may arise by our own or others' negligence or conditions on the premises or the conditions or our use of amenities offered at the premises or related to travel to and from the premises. Nonetheless, we the undersigned assume all related risks, known and unknown. Mountrail County Fair Association/Building is not responsible for errors, omissions, acts or failures to act of any party or entity conducting a specific event or activity. I fully understand that this is a release of liability and I agree to voluntarily give up or waive any right that I otherwise have to bring legal action against Mountrail County Fair Association/Building or its associates, for any personal injury or property damage whatsoever for negligence on the part of Mountrail County Fair Association/Building, its agents and employees. This waiver and release of liability shall remain in effect for the duration of my presence at the premises.

We further agree to indemnify, defend and hold harmless Mountrail County Fair Association/Building, against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs.

Lost and Found: Mountrail County Fair Association/Building will not be responsible for any personal belongings that are lost, stolen, or left behind by guest or any member of the guest's party.

Garbage Removal: All garbage will be bagged and removed from the premises. Dumpsters are available on the Southwest side of building.

Fires: No fires are allowed on the premises. Only contained propane fire pits are allowed upon discretion and approval of the Mountrail County Fair Association and in accordance to any county Fire Ban Issuance.

Payment: Full payment is due before parking or plugging in of any camper/tent/etc. Payment is for site and electricity only.

Deposit: A **separate deposit check of \$50** will be made before rental date or camping. This will not be deposited unless damage occurs, garbage or other clean-up is necessary, including pet droppings. **Dumping of black or gray water on premises is NOT allowed.** Deposit check will be shredded if no damage or clean-up is needed.
