Rice, to approve the Notice of Award to Knife River Materials totaling \$4,922,811.89 for CR 3 Project No 03(71)23 Palermo North consisting of approximately 5.5 miles of HMA Surfacing. Upon roll call, Ruland, Rice, Olson, Hollekim and DeGroot voted yes. Motion carried.

2. 36th ST NW RECONSTRUCTION

Moved by Comm. Rice, seconded by Comm. Olson, to approve the Change Order #2 for the addition of 36th St NW Reconstruction for applying water soluble paint for the lines resulting in a decrease of \$20,944.90 to the contract with Jensen Brothers Construction with total contract adjusted to \$6,184,105.47. Upon roll call, Ruland, Rice, Olson, DeGroot and Hollekim voted yes. Motion carried.

3. RTC-WHITE EARTH BAY

Superintendent Duerre discussed who the responsible party would be to give approval for allowing Reservation Telephone Company (RTC) to install the fiber optic within the right of way.
