## 1. OPENING & ROLL CALL

The Board met in regular session on Tuesday, November 21, 2023 at 9:00 A.M. in the Emergency/Community Room, Mountrail County Courthouse, Stanley ND with Commissioners Joan Hollekim, Trudy Ruland, Wayne Olson and John DeGroot present and Jason Rice absent. State's Attorney, Wade Enget was present.

Chairman Ruland called the meeting to order. The Pledge of Allegiance was recited.

## 2. BUSINESS

## A. AGENDA

Moved by Comm. DeGroot, seconded by Comm. Olson, to review and approve the agenda as corrected. Upon roll call, all present voted yes. Motion carried.

## **B** MINUTES

Moved by Comm. Olson, seconded by Comm. DeGroot, to approve the minutes of the November 7, 2023 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

## C. FEES

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve the October fees for the Correctional Facility, Sheriff and Clerk of Court. Upon roll call, Hollekim, DeGroot, Ruland and Olson voted yes. Motion carried.

# D. PAYROLL

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve the resignation of Nichole Degenstein, Human Resource Director effective November 30, 2023. The Board thanked Director Degenstein for her ten years of dedicated service with Mountrail County. Upon roll call, Olson, DeGroot, Ruland and Hollekim voted yes. Motion carried.

Discussion was held on the Human Resource Director position. Stephanie A. Pappa, Auditor along with Randi Schumaier, Human Resource Specialist discussed the option of bringing the Human Resource department back into the Auditor's office. Auditor Pappa discussed hiring a full-time position under Human Resource department & Auditors office to handle the payroll and election duties.

Moved by Comm. DeGroot, seconded by Comm. Olson, to promote Randi Schumaier to the position of interim Human Resource Director under the supervision of Auditor Pappa effective December 1<sup>st</sup> at a banding/grading of C41 with an increase in salary to the amount of \$35.119 per hour/\$73,048 per year. Upon roll call, Ruland, Olson, Hollekim and DeGroot voted yes. Motion carried.

More discussion will be held at the Human Resource Advisory Committee for recommendations on the new payroll/election position as far as banding/grading and a special meeting be held for the Commissioners.

Moved by Comm. DeGroot, seconded by Comm. Olson, to approve the regular full-time employee classification for Justice McKenna with the Sheriff as a Dispatcher in the amount of \$23.365 per hour/\$48,600 per year. Upon roll call, DeGroot, Ruland, Olson and Hollekim voted yes. Motion carried.

Hollekim, to approve the salary increase form for successful completion of satisfactory probationary period for Jack Babbitt with the Road & Bridge as a Roadworker I to the amount of \$30.158 per hour/\$62,730 per year effective December 1<sup>st</sup>. ## 3. APPOINTMENT SCHEDULED

## 9:15 A.M.

Laurie Johnson, Correctional Administrator, Corey Bristol Sheriff along with Nichole Degenstein, Human Resource Director met with the board to discuss the HB 1307/Back the Blue Grant monies received. The Corrections received \$25,548 and the Sheriff received \$18,452 for the options of the funds to be utilized on law enforcement recruitment bonuses; law enforcement retention bonuses; and tuition payment for law enforcement trainees.

Moved by Comm. Hollekim, seconded by Comm. DeGroot, to approve and accept the funds of allocated under House Bill 1307/Back the Blue Grant to be utilized for law enforcement retention bonuses equally distributed amongst the 10 current licensed law enforcement officers excluding the Deputy Sheriff and Sheriff totaling \$18,452 and 18 current correctional officers excluding the Correctional Administrator totaling \$25,548 as recommended by Correctional Administrator Johnson and Sheriff Bristol. Upon roll call, Ruland, Olson, DeGroot and Hollekim voted yes. Motion carried.

## 9:25 A.M.

Corey Bristol, Sheriff discussed bringing a company into crush or demolish the impound vehicles rather than having an auction.

Moved by Comm. DeGroot, seconded by Comm. Olson, to allow Sheriff Bristol to contact a crushing/scrap company for the disposal of the impounded vehicles. Upon roll call, Olson, Hollekim, DeGroot and Ruland voted yes. Motion carried.

#### 9:30 A.M.

Jessica Niemitalo, Treasurer met with the board to discuss the bank proposals from Bravera and Cornerstone. The recommendation of Treasurer Niemitalo was to move \$70 million into money market accounts and \$20 million in certificate of deposits with Bravera Bank and \$30 million into money market at Cornerstone Bank and leaving the checking accounts at Bremer until the software conversion is complete with leaving an estimate of \$14 million in the money market at Bremer.

Moved by Comm. DeGroot, seconded by Comm. Hollekim, to approve investing \$70 million into money market accounts and \$20 million into a certificate of deposit (CD) at 12 months at Bravera Bank and \$30 million into a money market account at Cornerstone Bank as per the recommendation of Treasurer Niemitalo. Upon roll call, Ruland, Olson, Hollekim and DeGroot voted yes. Motion carried.

#### 9:45 A.M.

Ken Rensch along with Ken Ruud with the Parshall Rural Ambulance District met with the board to request a new ambulance.

Moved by Comm. Olson, seconded by Comm. DeGroot, to approve the purchase of the new ambulance for the Parshall Rural Ambulance District totaling \$495,779 paying half the amount in 2023 from the Rural Fire & Ambulance Account under the General Fund. Upon roll call, Ruland, Olson, Hollekim and DeGroot voted yes. Motion carried. A joint powers agreement pertaining to this action would be drawn up.

# 10:00 A.M.

Chairman Ruland opened the 10 a.m. Sale of Lands forfeited to the County for non-payment of taxes. Present for the hearing were Randy Nichols and Elizabeth Leingang.

Moved by Comm. Hollekim, seconded by Comm. Olson, to open the bidding of the Sale of Lands forfeited to the County. Upon roll call, all present voted yes. Motion carried.

Moved by Comm. Hollekim, seconded by Comm. Olson, to accept the high bids for the purchase of county owned property as follows: \$268 received from Elizabeth Leingang for the purchase of E½ of Lot 6 & all of Lot 7, Block 6, Coulee Village, Township 158 North, Range 88 West and \$2,040 from Randy Nichols, representing Samuel W. & Mary E. Hunter Trustees of Kathleen E Devecchi & Jennifer E. Hunter for Outlot 3 of SE¼NE¼, Section 34, Township 154 North, Range 90 West. Upon roll call, Olson, DeGroot, Hollekim and Ruland voted yes. Motion carried.

Moved by Comm. DeGroot, seconded by Comm. Olson, to close the tax sale. Upon roll call, all present voted yes. Motion carried.
