1. 90th AVE NW-MWEC

Chris Brostuen stated MWEC was not aware of the 75 feet right away requirement on the Unorganized Township roads due to them being considered the same as a County road. Several of the pole locations are within the 36 feet of center of the road in the clear zone between the road and fence line. Chris Brostuen stated these would be moved to the fence line.
