Proceedings of the Mountrail County Commissioners

1. OPENING & ROLL CALL

The Board met in regular session on Tuesday, October 21, 2025 at 9:00 A.M. in the Emergency/Community Room, Mountrail County Courthouse, Stanley ND with Commissioners Trudy Ruland, Jason Rice, John DeGroot, Wayne Olson and Joan Hollekim present. State's Attorney, Wade Enget was present.

Chairman Ruland called the meeting to order. The Pledge of Allegiance was recited.

2. BUSINESS

A. AGENDA

Moved by Comm. Olson, seconded by Comm. Hollekim, to review and approve the agenda as corrected. Upon roll call, all present voted yes. Motion carried.

B MINUTES

Moved by Comm. DeGroot, seconded by Comm. Rice, to approve the minutes of the October 7, 2025 meeting as corrected. Upon roll call, all present voted yes. Motion carried.

C. FEES

Moved by Comm. Hollekim, seconded by Comm. DeGroot, to approve the September Fees for Corrections and Sheriff. Upon roll call, Hollekim, Olson, Ruland, DeGroot, and Rice voted yes. Motion carried.

D. PAYROLL

Moved by Comm. Olson, seconded by Comm. Rice, to approve the regular full time employee classification for Veronica Viteri with the R&B as an Administrative Assistant in the amount of \$26.68 per hour/\$55,500 per year. Upon roll call, Ruland, Hollekim, Rice, DeGroot and Olson voted yes. Motion carried.

G. NDACO SURVEY ON IMPACTS OF HB 1176

Discussion was held on the NDACO survey on the impacts of HB 1176.

One of the concerns identified with HB 1176 is the absence of an option for a gradual increase in a new levy. Taxpayers may be faced with a significant burden because a taxing district must either adopt the maximum levy or remain constrained by a 3% increase if a lower dollar amount is levied. Further, the lack of enforcement is an issue. If a levy is calculated incorrectly at the local level, there is currently no mechanism in place to address this error as it is not the County Auditor's duty to make sure levies are figured correctly. In addition, there is no way to recoup losses in federal funding should they occur and often inflation rates exceed the 3% increase. There are many taxing districts that have limited reserves, and they will be forced to use them to cover budgetary costs.

Auditor Stephanie A. Pappa will submit the comments of the survey.

Motion carried.
