Moved by Comm. Hollekim, seconded by Comm. Olson, to authorize the department heads to make adjustments in salary in the 2020 year based on the salary chart approved October 1, 2019. Upon roll call, Olson, Jacobson, Ruland, Uran and Hollekim voted yes. Motion carried.

Jana Hennessy, Engineer met to discuss Road & Bridge. Also present were Gerald Koble, Jason Olson with HDR Engineering and Ann Taylor with Brosz Engineering.

# 1. CR 9/101ST AVE NW

Moved by Comm. Olson, seconded by Comm. Uran, to approve sending the letter to Charles

Ramberg addressing his concerns on CR 9/101<sup>st</sup> Ave NW. Upon roll call, all present voted yes. Motion carried.

Discussion was held with Corey Bristol, Sheriff who stated that CR 9, 101st Ave NW is closed due to wet conditions.

2. ROM-0300(142)

Moved by Comm. Hollekim, seconded by Comm. Olson, to approve signing the Construction and Maintenance Agreement with ND Department of Transportation for Project #ROM-0300(142) for gravel surfacing and calcium chloride stabilization on various missile routes in the County. Upon roll call, Olson, Ruland, Uran, Jacobson and Hollekim voted yes. Motion carried.

3. ND COUNTIES WITH RAILROAD CROSSING

Discussion was held on sending a letter to the ND Department of Transportation identifying CR 19 as a location where rail/highway crossing safety needs improvement.

4. OVERWEIGHT ASSESSMENT/36<sup>TH</sup> ST NW

Gerald Koble appeared to discuss an overweight assessment he received hauling crude oil on 36<sup>th</sup> St NW, Big Bend Township. Mr. Koble would like the overweight assessment lowered due to not being aware of the weight limit capacity and the timing of the road closure restrictions.

Moved by Comm. Jacobson, seconded by Comm. Olson, to settle for 20% of the fine being \$4,160 due to the timing of the road closure restrictions with settlement subject to Big Bend Township's approval of the reduction for the overweight assessment on 36<sup>th</sup> St NW. Upon roll call, Olson, Ruland, Hollekim, Uran and Jacobson voted yes. Motion carried.

5. OLD HIGHWAY 2

Discussion was held on the continuation of the liquidated damages for Old Highway 2. Engineer Hennessy will get a formal request from the contractor for the Board to take action upon.

6. CR 10/53RD ST NW

Discussion was held on CR 10/53rd St. NW with Franklin & Rosemary Martens on the issue of water standing in the ditches. State's Attorney Enget discussed the agreement between Mountrail County and Franklin & Rosemary Martens during construction which all terms have been satisfied.
